7. Narrative Description

The Sunnyside Hotel was constructed as a residence in 1897 and converted for use as a small hotel in 1913. The building is located in Magnolia Springs, Alabama at the northwest corner of the intersection of Oak Avenue and Jessamine Street. Magnolia Springs is an unincorporated community along the banks of the Magnolia River in southwest Baldwin County. Though some of the homes in Magnolia Springs enjoy waterfront footage along the river, the Sunnyside Hotel sits several blocks off of the water. Oak Avenue borders the property on the south, and is a spectacular residential street with an overarching canopy of live oaks. Jessamine Street borders the property to the east and is an unpaved lane. The Sunnyside Hotel sits on an informally landscaped lot graced by water oaks, magnolias and azalea bushes.

Constructed in 1897, the Sunnyside Hotel retains its integrity of location, style, materials, feeling, associations, workmanship and setting. The building is a one and a half story, clapboard building resting on a stuccoed brick foundation, with a hip roof one story porch covering the facade and east elevations.

The three bay facade features a gable roof to the sides with a steep pitch. The main entrance consists of a wood door with a glass window and transom with a 2/2 window to either side. A second entrance is in the east bay and was converted from a window in ca. 1920. It consists of a wood door with a glass window and a screen. The porch roof is supported on turned posts with a balustrade. There are a pair of gable roofed wall dormers above, each with a 2/2

window. There is one interior brick chimney with a corbel cap.

The east elevation consists of three bays of the main block of the house with an attached gable ell of two bays extending to the north. The porch wraps around the east elevation, abutting the slightly offset ell. There is an entrance in the middle bay under the porch. A pair of 2/2 windows are in the gable above and there are exposed rafters around the eaves with a fascia board attached. The gable roof ell dates from ca. 1920 and is a two story, frame addition with aluminum windows (ca. 1960).

The north elevation, or rear of the Sunnyside Hotel, is distinguished by the ell off the east elevation, a shed roof rear entrance and another, smaller ell off the west rear elevation. The east ell features a pair of aluminum windows at the first and second stories. To the west is the rear entrance, featuring clapboards, triple glass doors and curved stained glass side lights and transom. Above this rear entrance in the main block of the house is a gable wall dormer with a 2/2 window. Adjacent west of this is a one story frame gable ell with an eight foot shed roof extension off its western elevation (1980) which includes a stained glass window.

The west elevation features three windows at the first story and two in the gable above the main block of the house. This elevation is not accessible due to bushes and trees right against the house.

The exterior integrity of the Sunnyside Hotel is remarkably good. Alterations have been limited to the replacement of one window at the facade with an aluminum window and the

windows in the 1920s ell with aluminum windows. The rear entrance dates from ca. 1980 as does the addition to the west elevation of the west rear ell, and both additions were executed in materials sympathetic with the original house.

The interior of the Sunnyside Hotel features many Late Victorian elements typically found in Gulf Coast residences of the period. The entrance hall is extremely wide, and features all beaded board walls with baseboards and picture rail. Interior doors are horizontal wood panel with transoms (to allow for breezes), all of which retain their original hardware. To the west of the hall are a bedroom, bath and rear bedroom, all clad in beaded board. To the east, the double parlors have been sheetrocked (ca. 1960), carpeted and the dividing wall removed. An original mantel piece remains. To the rear of the main block are the rear entrance and two ells.

The interior of the first floor of the east ell serves as a kitchen, having been converted ca. 1960. The upstairs serves as bedrooms, all sheetrocked and carpeted (ca. 1960).

The interior of the west ell serves as a family room and features beaded board painted white, carpet and the stained glass window (ca. 1980).

The upstairs consists of four bedrooms and three baths. All walls are beaded board, doors are four panel with original hardware and somewhat unusually, there is an interior window behind the central bedroom to provide light in the stairwell below.

Interior alterations to the Sunnyside Hotel are limited to the remodeling of the east parlors on the first floor (ca.

1960), the remodeling of the rear east ell (ca. 1960), the eight foot addition to the west ell (ca. 1980) and the addition of two bathrooms upstairs (1997).

At the rear of the lot sits a one story, clapboard, gable roof outbuilding, two by one bay. There is a 9/9 window in each gable end and a pair of wood doors with glass windows at the facade. The interior features a modern concrete floor with exposed stud walls. This structure was built ca. 1920 as a storage building.

At present, the Sunnyside Hotel is being converted into a bed and breakfast inn. The degree of interior and exterior integrity is good.

Although no formal archaeological survey has been made of this property, the potential for subsurface remains is high. Buried portions may contain significant information that may be useful in interpreting the entire property.

8. Statement of Significance

The Sunnyside Hotel is significant under Criterion A -Entertainment/Recreation-as an intact and rare Baldwin County example of a small resort hotel. Though south Baldwin County has been a popular resort area since the turn of the century, there are few surviving historic hotels. During the 1920s, a peak decade for the resort and vacation industry in the area, there were only five hotels in all of Baldwin County. (Hager, p. 300) Of these five hotels, two survive in the neighboring town of Fairhope in addition to the Sunnyside in Magnolia Springs. With its spacious wrap-around porch enhanced by turned posts and balusters, wall dormers, steeply pitched roof, exterior and interior door transoms, and magnificent curly pine beaded board interior, the Sunnyside hotel stands as an important survivor of Baldwin County's early 20th-century resort years.

Historical Summary

Magnolia Springs is located at the headwaters of the Magnolia River in the southwest quadrant of Baldwin County, Alabama. The Magnolia River flows into Weeks Bay, which itself empties into Mobile Bay. From earliest times, the community has been accessible by small sailing craft and steam packets. Because of its natural springs and abundant fish and wildlife, the area attracted settlers early on.

In 1800 the Spanish granted the tract of land including what would become Magnolia Springs to Joseph Collins. Collins operated several turpentine stills in the area and a small

settlement surrounded them. In 1855 Collins transferred his lands to Kennedy, Moore and Company which continued the turpentine operation on a larger scale. Much of the work was conducted by slave labor. During the Civil War Union troops destroyed the turpentine stills and the local economy was ruined. (Bemis, "Brunell House")

Prospects began to improve during the 1890s, when Magnolia Springs began to attract the attention of winter-weary northerners. The warm climate, good fishing and peaceful setting became important assets. Brochures extolled the good life, "always cool in the shade, no matter how hot the sun shines. The influence of the saline breezes from the Gulf will bring you a good sharp appetite." (Rasumssen, "Rambling Notes") By 1892 there was a post office, and in 1894 a large parcel of land along and back from the River was subdivided into the Lyman's Addition to Magnolia Springs creating 52 lots and several streets. (Bemis, "Brunell House")

On July 31, 1897 Christopher McLennan purchased lot 5 in the Lyman's Addition and began construction of a frame house. Concurrent with McLennan's construction, other lots in the vicinity were sold, and several large hotels built to help attract people to the community. These hotels included the "Woodbound" which could accommodate 300 people and the "Babcock" which could accommodate 30. Regular packet boats ferried guests up the river. (Rasumssen, "Rambling Notes")

McLennan sold his house in 1900 and it changed hands several times until 1913 when it was purchased by Mrs. William Harding. Mrs. Harding operated the house as a small hotel, which by the 1920s was known as the "Sunnyside." It was Mrs. Harding who added the rear ell at the east rear of the

building. Her additions responded to increased tourism during the 1920s as more and more northerners sought out the mild climate and excellent fishing to be found at Magnolia Springs. Because of improved methods of transportation and roads, more people were able to travel as the decade progressed. As with the other hotels, the "Sunnyside" sheltered prospective purchasers of Baldwin County land. After Mrs. Harding's death in the 1940s, the "Sunnyside" was inherited by her sister and brother in law and they ceased to operate it as a hotel. During the 1980s the building was sensitively restored by new owners, and it sold in 1996 to the present owner, David Worthington, who is converting it into a bed and breakfast. (Interview, David Worthington)

Magnolia Springs remains a quiet community tucked away off the main road. The mail is delivered by boat to those lucky enough to live along the River, and northerners continue to be attracted to the area. During the mid-1980s Magnolia Springs was declared a historic preservation area by the Baldwin County Commission, a largely ceremonial designation. The loss and alteration of the turn of the century architecture of Magnolia Springs has made National Register designation of the settlement. Therefore, the Sunnyside Hotel is an important survival of Magnolia Spring's heyday.
