Describe the present and original (if known) physical appearance

This residential area consists of approximately 340 residences, most of which were constructed between 1910 and 1930. Out of the total number of structures, approximately 290 either contribute or conditionally contribute to the district. The area has good examples of most early 20th century residential styles including Neo-Greek Revival, Tudor, Spanish Mission, Bungalow, Arts and Crafts and Classical Revival. The houses range from small, middle income, closely-spaced cottages to large, high-style houses situated on spacious wooded lots. Some of the larger homes were designed by prominent local turn-of-the-century architects. The district also includes two very fine Gothic Revival churches and two small early twentieth century commercial areas. One of the commercial areas is located on the northwest boundary of the district, and the other is located on the southern boundary.

The entire district is laid out in a picturesque landscape setting typical of similar turn-of-the-century residential areas located around the country which were popularized by the landscape architect, Frederick Law Olmsted. Typical Olmstedian features that can be seen in Old Cloverdale are curved streets that follow the natural contours of the land, large irregularly-shaped lots, open landscaped park areas, and carefully preserved original trees and shrubs.

The majority of the larger homes tend to be located on the more spacious wooded lots closest to the open central park areas. The middle income housing tends to be primarily concentrated on the winding streets just outside the center of the area, and the smaller homes are situated close together on or near the outlying streets which form the periphery of the district.

The current condition of the buildings can best be described as ranging from good to excellent. The district, as a whole, is remarkably well preserved with relatively few modern encroachments.

The district also includes four significant, early, open parks. Three of these parks have 1970's fountains. The Milo Howard Park was the only space which had an earlier fountain (1927), which was removed and replaced by one of the 1970's models. Two of the parks (Milo Howard and Fitzgerald) are relatively small, triangular-shaped areas located at street intersections. The other two parks (Cloverdale and LeGrand) are much larger with numerous shade trees. These more spacious parks are actively used by residents for jogging, strolling, organized athletic events, picnics, etc.

In addition to the parks, there are 177 early outbuildings which served originally as stables, garages, servants quarters, etc. These outbuildings along with the four parks bring the total number of contributing buildings and sites to 467.

Statement of Significance (in one paragraph)

Criterion C - Landscape Architecture:

Cloverdale (1892) is primarily significant as the earliest of Alabama's two fully realized examples of garden landscaped residential suburbs popularized in this country by Frederick Law Olmsted in such developments as Riverside (1869) in Chicago and Druid Hills (1893) in Atlanta. Redmont in Birmingham, designed in the second and third decades of the 20th century, is the state's only other such neighborhood that exhibits on the same scale as Cloverdale the picturesque plan with winding streets and spacious lots overlooking open, informal park areas.

The quality of the design suggests that a landscape architect was involved in the plan. Both Joseph F. Johnson and Frederick Law Olmsted have been suggested as possible sources for the design, as both were doing work in Montgomery shortly before the plan was drawn. Because of the strong similarities with his design for Atlanta's Inman Park (1887), Johnson seems the likely candidate.

Criterion A - Landscape Architecture:

Cloverdale is a well preserved example of the late 19th and early 20th century suburban neighborhood made possible by the advent of electric streetcars and automobiles. Located two miles from downtown Montgomery, it was planned by its developers as an exclusive residential area connected to the center of town by an electric trolly line.

Criterion C - Architecture:

Cloverdale is significant for its fine collection of late 19th and early 20th century domestic structures. Good and excellent examples of the works of local architects Frank Lockwood, Sr., Frank Lockwood, Jr., B. B. Smith, and Weatherly Carter are scattered throughout the district, which also illustrates most of the common upper and middle-class 20th-century domestic styles. Tudor, Neo-Greek Revival, Arts and Crafts, Spanish Mission, English Cottage, Colonial Revival, and Neo-Classical Revival are well represented, as are vernacular houses of the period.

The district also contains two locally important Gothic Revival churches, two representative early 20th century commercial areas, and four early 20th-century apartment houses.

HISTORICAL SUMMARY

Cloverdale was originally a portion of a 160-acre tract purchased by William Graham from the U.S. Government in 1817. Graham was one of Montgomery's early leading citizens and its first mayor. The owner of a store on Market (now Dexter Avenue), he served as the Clerk of the Circuit Court in the 1830s and was Treasurer for the State of Alabama from 1846 to 1859.

The tract, called "Graham's Woods", was located to the south of the city and was considered to be way out in the country. In 1834 Graham sold the land to Duncan Graham, whose heirs, in turn, sold it to Malcolm Graham in 1886. Apparently, the land was put to little practical use by the Graham family, probably because the soil was primarily. Alabama prairie mud unsuitable for agriculture. The land was covered with virgin pines, a few of which still exist on the lawns of some Cloverdale homes, and the area was sometimes called "The Pines."

In 1886, Malcolm Graham sold the property to J. C. O'Connell, a wealthy Montgomery engineer and cotton merchant. On June 9, 1887, O'Connell along with M. B. Houghton, M. P. LeGrand, Jr. and A. W. LeBron incorporated the property as The South Montgomery Land Company. By 1888, sizable portions of the development had been sold to Robert H. McClellan and Charles Scheerer, who were real estate speculators from Galena, Illinois.³ Mr. LeBron was also from Galena.

In 1892, the company was dissolved, and the Cloverdale Land and Development Company incorporated under the direction of M. A. Williams, A. W. LeBron, R. P. Dexter and Phares Coleman. In that same year, a plat of the property was drawn showing a series of winding streets with large irregularly-shaped lots overlooking several open parks and a proposed lake site. This layout, with only minor alterations, exists today.

Included in the original scheme was an extension of the new Montgomery electric trolly into the Cloverdale suburb, connecting the neighborhood directly with the center of the city. As compensation for extending the line, the car company was given a few of the lots. The <u>Montgomery Advertiser</u> reported on September 30, 1892 that seven streetcars were serving the Cloverdale system. The trolly continued to provide cheap transportation for Cloverdale residents until the 1950s.

Local historians have speculated that Frederick Law Olmsted may have authored the plan for Cloverdale because he was in Montgomery in 1889 to design a landscape plan for the Alabama State Capitol and one of the local draftsmen he employed, J. M. Garrett, also drew the Cloverdale plat. A more likely candidate, however, is Joseph Forsyth Johnson, who like Olmsted came to Montgomery in 1889 to submit plans for the Capitol grounds. The remarkable similarity between his design for Inman Park in Atlanta (1887) and Cloverdale (1892) strongly suggests that he also designed the latter. See attachments A and B.

The earliest documentation discovered for the construction of a house in Cloverdale is from a letter dated 1892. The letter was written from Nettie Fuller to her Sister, Willie, in which she states, ". . . went out to our new home yesterday evening, the road was just as muddy as it could be. I don't know what we will do when we get out there it will be so lonesome and muddy."⁰ This house, which was located on the corner of what is now Felder Ave. and Norman Bridge Rd., was demolished for an apartment complex in the late 1940's. Miss Willie Fuller ran a private school directly behind the house facing Felder Ave.

In 1893, the Cloverdale Land and Development Company went bankrupt, due to the nation-wide economic panic of that period. During the next fifteen years the Cloverdale site lay dormant with the exception of some activity along the north side of Felder Ave., where a small golf course and tennis courts were built. This was the beginning of the Montgomery Country Club.

In 1908, the site was again reincorporated and called simply, Cloverdale Homes. Mr. A. W. LeBron served as secretary-treasurer of the corporation, but the financial backing and administrative management was headed by Mr. O. O. Nelson, one of Montgomery's leading real estate brokers. Cloverdale owes a great deal of its ultimate success to Mr. Nelson, because under his direction the sale of lots and the construction of houses skyrocketed between 1908 and 1916. In 1908, there were only ten houses in Cloverdale, but by 1916 there were one hundred twenty-five. Many of these houses were designed by Montgomery's leading architects, B. B. Smith, Weatherly Carter, Frank Lockwood, Sr. and Frank Lockwood, Jr. One house was designed by Mobile architect, Nicholas Holmes, Sr.

In 1910, the residents of Cloverdale voted for the first time to incorporate their suburb into a self-governing village. They elected Charles Tullis as the first Mayor and Col. A. B. Garland, C. H. Roquemore, Charles Johnson, A. W. LeBron and W. P. DeJarnette as aldermen. Shortly after the incorporation of the village an effort was made to lay sidewalks and sewer lines and to gravel the streets. Much of this early civic engineering was carried out by B. B. Smith and Weatherby Carter, architects and engineers. This period also saw the development of a small commercial strip on the corner of Norman Bridge Road and the north side of Cloverdale Road. This was Montgomery's first suburban commerical area. In the late 1920's, another similar business area began to develop on the corner of Fairview Ave. and Woodley Rd.
