Intermediate boundary marker Northeast #6 is located in the front yard of the residence at 3601 Eastern Avenue, northeast of the intersection of 34th Street and Eastern Avenue. The sandstone marker is in good condition. A 3' x 3' x 5' iron fence, also in good condition, surrounds the marker.

Northeast boundary stone #6 was the thirteenth marker to be located in Maryland. It was laid in 1792. Its fence was dedicated by the Livingston Manor Chapter of the Daughters of the American Revolution on June 2, 1916.

Verbal Boundary Description:

The stone is located in the front yard of 3601 Eastern Avenue approximately 25 feet northwest of the centerline of 34th Street and 45 feet northeast from the centerline of Eastern Avenue. The fence surrounds the stone.

Boundary Justification:

The boundary stone and fence have historically been situated at this location and maintain historic integrity.
