

Describe the present and original (if known) physical appearance

Dating from 1900, One Stanley Avenue is a distinctive and well-preserved example of the Queen Anne style in a remote residential context.

The 2½-story house is of frame construction, with cross-gabled roof, shingle siding (on the half-story), clapboard siding (on the first and second stories), corner tower, one-story facade porch, and granite foundation.

The facade, which faces west, contains a central entrance flanked by paired 2/1 windows. Above the entrance the central bay in the second story is a three-sided bay window; above this, in the half-story, is a dormer with hipped roof. A corner tower rises three stories from the right side of the facade. This tower, square in plan, contains single or paired 2/1 windows on each of its sides in each story. A parapet with ornate wooden railing caps this tower.

The south side of the house faces a driveway and features a gabled projection of 2½ stories to the right of the facade tower. To the right of this projection is the rear ell of the house, with a door facing south, covered by a one-story porch.

In the 1920's a railing forming a second story porch over the front door was removed along with a door in the bay above.

Statement of Significance (in one paragraph)

With its distinctive square corner tower, unique in Maine, this impressive Queen Anne residence is a local landmark in a remote rural community principally known as the birthplace of the famous Stanley Brothers ("Stanley Steamer") after whom this street was named. So distinctive is this house that local residents long ago began referring to it simply as "One Stanley Avenue", a name now applied to the restaurant it houses.

Lavella Norton was the principal builder in Kingfield at the turn of the century. His father, Tristram, was also a builder, having constructed the "Brick Castle" on North Street, a handsome four square late Federal house. Lavella built, besides One Stanley Avenue, the Amos G. Winter House (N.R. 5-3-76), the Stanley School and Webster Hall among other structures in the community.

The distinctive interior finish work was executed by Lavella's brother, William, and consists in part of a molded oak arch, a dining room carried out entirely in oak with a floor of cherry, oak and maple parquet, and a kitchen with molding, cabinets and wainscotting entirely of birdseye maple, cull wood from his own mill.
