

Shortly after 7 September 1840 the Jury decided it did not like the Judge's Bench, so another was built. It is at the south side of the Courtroom near the big folding doors, is railed with the same type turned banisters as the bailiff's bench. It is mortised, tenoned and p pegged together and is semicircular. Photo is from left side.

It is on the east wall of the Courtroom near the rail that divides this section from the rest of the Courtroom. When Court is about to begin, the Sheriff cries from this bench. "Hear ye, hear ye, the Honorable Court is now in session. All rise."



Folding doors. One pair of the ten identical pairs of folding doors of which there are three at the north and south (this is north), one east and west and one north and south from the Courtroom. Plain pilasters and square headlights were required for all folding doors. Panels are carved.

Here may be seen the slate roof, chimney stacks, the square surround of th cupola with its shutters.

Detail of the cornice from the southeast corner. The cornice is very elegant and perfectly suited to the building. It was ordered to be either of heart of pine or cypress entirely free of sap or other defects, though it is not known which of these woods was used.

West side of Courthouse. From the southwest corner. Note the four blind windows at the lower floor made so because of the stairs within. This is the only side with five windows above, the middle one lighting the stait landing. The fanlight over the folding doors was placed there during restoration, the original being square like all the others.
