Union -- settled in 1791, usurping the prestige of Old Pinckneyville after 1800, prospering first as a crossroads town and then as a wealthy and aristocratic/planter town -- retains a number of impressive antebellum mansions in both county and town. Herndon Terrace is one of the best remaining examples of this type architecture.

The house was built and has always been occupied by the Herndon-Thomson family, prominent in Union County.

Still standing on the grounds is the large cork oak tree mentioned in Shaffer's <u>Carolina Gardens</u>.
