Clotfelter Rowhouse

The stucco and frame rowhouse at 6112 Paseo Delicias, in Rancho Santa Fe, California, is rectangular in shape and is attached to a common wall with three other rowhouses, built in 1928. Each rowhouse is separated from the other by 12' walls. The Clotfelter rowhouse is set back from the street a different distance to provide interest; the facade configuration of the windows and grillwork is different for each home. Each of the rowhouses has a different room plan.

This southernmost rowhouse owned by the Clotfelters is entered through a arched doorway into a landscaped patio area. The dining room and one bedroom have windows which look out into the front patio. The home has a living room, dining room, two bedrooms, a kitchen, bathroom, and linen room. The County Assessor indicates on the Residential Building Record that the interior had some alterations made to the interior in 1932. The Clotfelter building has a 30' x 5-' frontage and is 100 feet deep. The garage, built at the same time as the rowhouse, is at the northwest corner of the rear yard, separated from the rowhouse. The back area contains large trees and shrubs around the edges near the walls; grass is the ground cover. The rowhouse has 1,536 square feet of living space, is extremely secure and private. There are no visible alterations of the exterior of this structure since the day of construction.

The other three rowhouses have a different configuration of room layout; the square footage is about the same. The northernmost rowhouse also has a front patio inside the common wall; the two houses in the center do not. Three of the rowhouses have garages at the alley. The third of the rowhouses in the alignment, from south to north has instead, a two bedroom guest house aligned against the common wall which backs up against the alley. All four rowhouses are in pristine condition. At this time, however, it has not been possible to contact three of the property owners for permission to submit their homes for nomination.

The Clotfelter Row House is significant under Criterion C in the architectural history of Rancho Santa Fe as an excellent example of town house architecture designed by Lilian Rice in the Spanish Colonial Revival style and in the community planning and development history of California as a component of a carefully laid out group of buildings over a large planned area. The Clotfelter Row House is one of four such row houses designed by Rice within the Civic Center area. Each is built around a series of enclosed courtyards and atriums. They share similar materials, details, and volumes, however, each is a unique design. The Clotfelter Row House is a masterpiece of Rice's Spanish Colonial Revival residential design within a semi-urban setting. Walled and gated entry, tile roof, window grilles, decorative iron sconces, and canales are seen in this beautifully designed and crafted building. The Clotfelter Row House exhibits the major characteristics of its property type, making it eligible for the National Register in the context of "The Work of Lilian Jenette Rice in Rancho Santa Fe During the Years 1923-1938."


