

NARRATIVE DESCRIPTION

The proposed Okolona Historic District includes 292 buildings and one object that comprise the historic downtown and historic middle and upper class residential area of the city of Okolona in Chickasaw County, Mississippi. The district's character is that of a small Southern town in the decades between Early Settlement and the end of the Second World War. Many of Okolona's industrial and railroad resources have been demolished, and much of the housing in the community has suffered significant deterioration in material integrity. Therefore, the district focuses on those commercial, institutional, and residential elements of Okolona that retain significant integrity.

The commercial core is positioned in the central portion of the district and is surrounded by residential development to the north, south and west. To the east there is the railroad related to its historic industrial buildings. The earliest portion of the commercial core lie on an east-west axis along Main Street between Silver and Olive Streets. The area developed from circa 1888 to circa 1900 and is reflective of vernacular expressions of national commercial trends at the time, characterized by attached commercial row buildings which are one or two stories in height and one or two commercial lots in width. Buildings illustrative of this development are commercial vernacular building such as Inventory #108. Several businesses were labeled "colored" on a 1904 map sketch and were owned by families who remained in business and prominent in Okolona for many years. These businesses were located primarily on the north side of Main Street, west of what is today Olive Street. (Inventory # 131, #132 and #133).

Later, in the first twenty years of the 20th century, commercial development progressed further east down Main Street, between Silver and Gatlin Streets. The Merchants and Farmers Bank (Inventory # 120), built in 1903, and the Bank of Okolona (Inventory #106), built about 1910, best characterize the buildings of this era. Other development was characterized by one and two-story vernacular commercial row buildings. The other buildings within these blocks, in the eastern portion of Main Street have undergone extensive renovations in the latter half of the twentieth century. In this area, only 25% of the buildings of the existing commercial building stock has sufficient collective integrity. Many buildings have had storefronts covered with metal panels and canopies that diminish their integrity. However, many of these downtown buildings could have their late additions removed to restore their integrity and qualify them as "contributing."

In the surrounding residential neighborhoods, along Monroe Street and School Street, many large residences were constructed between 1910 and 1925, in such styles as Colonial Revival (Inventory #39, #66, #169, #207, and #211), Queen Anne (Inventory #71, #187, #201, and #209), Neo-Classical (Inventory #59) and Tudor or English Cottage (Inventory # 72, #73, and #159). Many fine Craftsman Bungalows were constructed among these larger homes (Inventory #8, #29, #39, #84, #220, and #222).

Okolona is notable for its well-preserved early twentieth century churches and institutional buildings. The churches include the First Methodist Church (##136), built in 1907-08; Grace Episcopal Church (#151), built in 1908; Okolona Presbyterian Church (#143), built in 1919; St. Theresa's Catholic Church (#177), built about 1922; and the First Baptist Church (#87), built in 1924. The Carnegie Library (#139) was built in 1915, and the Okolona High School (#158a) was built in 1924.

During the period from 1940 to 1950 a fair number of smaller middle-class residences were built (such as Inventory #76, #77, #148, #216). Many of these are scattered among older buildings, built on lots subdivided from larger lots or replacing older houses.

Two properties within the proposed district have been previously listed individually in the National Register of Historic Places – the Elliott-Donaldson House (Inventory #9), listed on 24 March 1980, and the Merchants and Farmers Bank (Inventory # 120), listed on 7 April 1987.

The right and left sides each have a 9-light door. One glazed, metal door is located to the left of the center. Two 6/6, paired windows sit between the doors. One 6/6 window sits between the end doors and the corners of the building.

The entry door is flanked to the right by 4/1 paired windows, and to the left by a 4/1 window and a 12-light door. This bay's gabled porch covers 2 gas pumps. The 2nd bay is an open garage. The 3rd and 4th bays are 2 large garages with garage doors. All gables are stucco with half-timbering. Main St. facade shows a gable end and cross-gable porch. A wooden panel door and 4-light window sit symmetrically under the gable end. A shed roof addition is attached to the left side. The addition is covered by asbestos shingles, and has a wooden louvered door.

The wings are set in front of the central block and form an entry courtyard. One 8/8 window with attached shutters sits in each wing. The courtyard is enclosed by a brick and iron fence. The centered entry door is a wood-paneled double door. An addition is attached to the back of the left wing.

The entry door sets under the porch and has been boarded up. Above the entry door, on the 2nd floor are double doors that open up to the balcony. The porch is flanked, on the 1st and 2nd floors, by two 1/1 windows with pediment and shutters.

Under the cross gable, to the left is an arched, brick entry porch covered by a gable roof. Under the cross gable to the right is a tripartite window with a center 6/1 window flanked by 4/1 windows. To the right of the front-gable roof is a brick arch in-filled with wood-frame windows and door. To the left of the slope chimney is a 12-light entry door under a front-gable roof. STATEMENT OF SIGNIFICANCE

The Okolona Historic District is locally significant in the areas of commerce and architecture under Criteria A and C. The period of significance spans a century, from circa 1850, when the earliest surviving buildings were constructed, to 1950, which marked the beginnings of economic changes in the area in the aftermath of the Second World War. The buildings in the district illustrate the commercial and residential development of Okolona as a center for the transportation of cotton to market, as a commercial center serving the local rural area, and as a center of government as the seat of the Eastern District of Chickasaw County. (The other county seat is located in Houston.)

Settlement and Early Development

Okolona is said to have had its beginning six miles northwest of its present location when Littlebury Gilliam settled on the old stage route in 1836 and opened his house as a public inn. Gilliam became the founder of a settlement, which he named Prairie Mount. Over the next few years the locus of settlement in the area gradually shifted to the site of Okolona, where a community had begun to develop that was initially called Rose Hill. When a post office was established there, the name was changed to Okolona, reputedly based on a Chickasaw Indian name.

The town was formally incorporated in 1850. Because of the depredations of the Civil War, only a few structures survive from the 1850s. Most notable among them is the Elliott Donaldson House (Inventory #9), built in 1850. (It was individually listed on the National Register on 15 September 1980). Several other residences are believed to date from about 1850 (Inventory #10, #209, #211, #213, and #226). Okolona quickly became a trade center for Chickasaw County. Goods, especially cotton, were shipped from Okolona to far-away markets. The rich prairie soil surrounding the city was perfect for large-scale cotton production.

Baptist, Methodist, Episcopal, Presbyterian and Christian church congregations had all been established in town by the end of the 1850s. The locations were later changed. When first built, three of them – Baptist, Methodist and Episcopal Churches – were located on the corners at the intersection of Main Street and Church Street, thus the naming of Church Street.²

The Mobile and Ohio Railroad

In the year 1848, John J. McRae, later to be Governor, came to the county as agent for the Mobile and Ohio Railroad. The company wanted to build a railroad line somewhere west of the Tombigbee River. The citizens of Chickasaw County subscribed and paid by taxation for assistance in building the railroad. The tracks were completed to Okolona and beyond in 1859. The railroad quickly became the driving factor

in commerce. The economy of the community rested largely on ginning cotton and moving the ginned cotton off to market.

Early commercial development occurred on the Main Street axis perpendicular to the railroad; however, all commercial buildings from this period, and the original depot, were burned during the Civil War.

Civil War

Okolona was just coming into its own when the Civil War began. Because of the railroad, the town was strategically important. As a result, skirmishes between Union and Confederate forces occurred at or near Okolona at least five times, beginning in November, 1862.³ In February, 1864, Federal forces under Brigadier General William Sooy Smith entered Okolona during his move from Memphis in cooperation with Major General William T. Sherman's Meridian Expedition. On February 22, Smith's forces, retreating from West Point, were defeated by Confederate cavalry under Major General Nathan Bedford Forrest north and west of town. In a running battle which culminated in the action at Ivey's Hill, believed to be approximately ten miles north of Okolona on the Pontotoc Road, the Federals were pushed back to Memphis. During the afternoon of the 22nd, General Forrest's younger brother Jeffrey, in command of a cavalry brigade, was killed.⁴ A number of houses and public buildings in Okolona were subsequently used as hospital sites. Hospitals were established at Okolona at other times during the war, most notably as a result of the battles of Shiloh and Corinth. ⁵

Industrial Development and Economic Prosperity

By 1866, the population and commercial interests of the part of the country in which Okolona is located, east of Chuquatonchee Creek, had increased so that in response to the requests of its people the Legislature enacted a law dividing the county into two judicial districts.⁶ The eastern part of the county was designated as the Second Judicial District and the western part as the First. It was further provided that equal terms of Circuit and Chancery Courts would be held in each district, one in Okolona, and one in Houston.

Okolona quickly grew and became the major center of trade for Chickasaw County. In the cotton market Okolona was a fierce competitor, virtually controlling the cotton trade of the county. Leading merchants, such as C.C. Dibrell, Buchanan and Son, and Myers and Houseman transferred their business from

Houston, Mississippi to Okolona. The railroad increased the processing capacity of Okolona to develop its industry of producing cotton, which allowed for efficient processing of the raw material prior to shipment to market. From 1870 to 1890, the U.S. Census figures indicate that Okolona grew from a population of 1,410 people to 2,099 people, a 49% increase. A map from 1898, from the *Atlas of the World* indicates Okolona as one of the "Chief Cities" of the state of Mississippi.

From the diary of G.H. Babbitt (born in Okolona in 1877), an entry on August 11, 1897 tells of electricity coming to Okolona. The U.S. Census figures indicate a population growth of 69% between 1900 and 1920. By 1900, Main Street was much as it is today, with a long row of buildings on either side of Main Street between Olive and Gatlin Streets (was Meridian Street at the time). There were over forty businesses in the downtown area by 1904. Among them were blacksmith shops, an ice cream factory, livery stable, a saddle maker, hat shops, an opera house, Chinese laundry, meat stores and hotels. Also, there were dry goods, general merchandise, hardware and furniture stores. Several businesses were labeled "colored" on a 1904 map sketch and were owned by families who remained in business for many years. These "colored" businesses were located primarily on the north side of Main Street, west of what is today Olive Street (Inventory #130 and #132).

In 1904, there were two hotels and two banks in downtown, one of which is the Merchants and Farmers Bank (Inventory #120), built circa 1903. (It was individually listed on the National Register on 14 May 1987.) Shortly after the turn of the century, Okolona acquired a telephone system. In 1907, the first "horseless carriage" appeared in Okolona. The town continued to prosper though the 1910s and 20s, with a city steam electric plant and four cotton gins. The city's sewage system was installed between 1912 and 1915.

Because most of the older industrial buildings that stood between the railroad and the downtown have been demolished, the district, as it survives today, is illustrative of the development of commerce and residential neighborhoods. Almost all of the contributing residential architecture in the district is a direct result of the prosperity related to the industrial development spawned by the railroad and the commerce the town provided to the Eastern District of Chickasaw County.

Early twentieth century houses range from modest Craftsman and Colonial Revival bungalows (Inventory #8, #29, #39, #84, #220, and #222) to fine examples of such styles as Colonial Revival (Inventory #39, #66, #169, #207, and #211), Neo-Classical (Inventory #59), Queen-Anne (Inventory #71, #187, #201, and #209) and English Cottage (Inventory #72, #73, and #160). The houses lie within three blocks of the downtown in all directions.

Okolona is notable for its well-preserved early twentieth century churches and institutional buildings. The churches include the First Methodist Church (#136), built in 1907-08; Grace Episcopal Church (#151), built in 1908; Okolona Presbyterian Church (#143), built in 1919; St. Theresa's Catholic Church (#177), built about 1922; and the First Baptist Church (#87), built in 1924. The Carnegie Library (#139) was built in 1915, and the Okolona High School (#158a) was built in 1924.

Decline and Renewal

With the Great Depression beginning in 1929 and lasting throughout the 1930s, Okolona was hard hit. The U.S. Census figures indicate a 47% loss in population from 1920 to 1940. All three banks closed and none existed at all for several months. In 1934, the Mobile and Ohio Railroad provided the only major payroll in Okolona. The only substantial new construction during the 1930s was the U.S. Post Office (Inventory #137), built in 1937, with Public Works Administration funding.

Soon after World War II, Okolona began a short period of growth, according to the U.S. Census figures. Scattered late 1940s houses were built among the older homes of Okolona (Inventory #76, #77, #148, and #216). This period saw the arrival of several new industries, among them a large furniture manufacturing company and the Delta Trouser factory.

However, by the 1960s and 70s, changes in agriculture and transportation had begun to bring about a loss of population in Chickasaw County and a substantial economic decline. Okolona suffered the loss of the railroad, the cotton compress, the cotton oil company, and the lumber company, all of which had a depressing effect from which the town has not yet recovered. Construction in more recent years has largely been infill housing and some replacement of commercial buildings within Okolona's historic district, along with some highway-related sprawl on the fringes of the community.
