#### **Physical Description:**

The Minneapolis Brewing Company Warehouse is located on the east side of Faith, SD, along the railroad bed that was once a part of the Milwaukee Road. Faith is a small, less than 600 people, rural town. The rural landscape and setting for the warehouse has changed little since the building's construction in 1911.

The warehouse is not oriented on a true north-south axis, but faces slightly south-southwest. For the purposes of this description the front façade of the building will be called the south elevation. The warehouse features three sections, a main section and two shed-roof sections. The building is wood clad with an asphalt-shingled roof and a concrete foundation. The central section is two stories with a medium-pitch, front facing, gable roof. On the south façade of this section is a small loft door centered under the gable peak and a small opening, 31/2 to 4 feet square, with a wooden batten door at ground level. To the left of this opening is a similar wooden door of the same width but 51/2 to 6 feet high. This door is on the western shed-roof section of the warehouse. A shorter shed-roof section at the building's east end features another 6-foot high door. Above this door is a smaller upper door, made of the same wood materials.

The shed roof on the west part of the structure begins about one foot below the gable roof and is steeply pitched. The west elevation features two fixed nine-light windows. There is another window on the north elevation of this shed roof portion of the warehouse, as well as another wooden door. The central section on the north elevation has two small openings about 4 feet off of the ground, and a wooden ladder affixed to the wall leading to two small openings under the gable. The larger of these openings is currently covered with a wooden louver. The shed-roof portion features a door similar to the one at the southwest corner of the building. There are no openings on the east elevation of the building.

The building is constructed with a framework of 8X8 wood beams. The interior and exterior were then covered with 1X6 boards. Sawdust was packed between these walls to serve as insulation. The exterior cladding is narrow tongue and groove siding. The second story, where the ice was kept, features a corrugated, galvanized metal floor. There are troughs around the second floor to collect the water from melting ice and drain it to the outside.

The warehouse has seen very few alterations during its life span. Two small loading docks, one on the south and one on the north were removed soon after the building stopped functioning as a beer warehouse in 1919. Some windows have been broken out and replaced over the years and a deteriorated chimney was removed around 1991.

#### Statement of Significance:

(8-86)

The Minneapolis Brewing Company Warehouse is significant under Criterion A as an early example of commerce in some of the last settled areas of western South Dakota. It is also significant under Criterion C as an intact representative example of a distinct type of construction.

In 1911 the Minneapolis Brewing Company contracted with James Flannery and Golden Grain Belt Beer to wholesale beer from Faith, South Dakota. The Minneapolis Brewing Company Warehouse was constructed to support this venture. The warehouse stored beer on the first floor as it was brought into town by rail. Ice was harvested from local ponds and cut into rectangular pieces. They were placed in the second story of the warehouse and covered with sawdust to retain the cold as long as possible.

The Warehouse served as a distribution point for not only local saloons, but for a larger region, including several counties. Although the building served its purpose well, it only operated as a storehouse for beer for eight years. When prohibition came into effect with the passage of the Eighteenth Amendment making it illegal to distribute and sell alcoholic beverages, the usefulness of the building as a beer storage facility ended. From 1919 until 1991 the building was used mainly for storage. It has seen very little alteration and is in very good condition.

Architecturally the building stands out as a prime example of a type of building meant to serve a particular function. The building was constructed especially sturdy using a framework of 8x8 beams since at any given time it could be holding several hundred cases of beer and up to 40 tons of ice. The use of sawdust within the wall cavities and the galvanized flooring in the upper level also lend themselves to the special techniques of construction of a building to store cold beverages.

The town of Faith had only been established a year prior to the construction of the Warehouse. The Milwaukee Railroad started building westward and many small towns sprang up along the proposed line, each hoping their town might be the final destination on the line. Many people across the state were ready to move on a minute's notice to reach the chosen town and establish their businesses as soon as possible.

Finally, in March of 1910, the Railroad Company announced the "end of the line" by buying land on the western edge of the Cheyenne Indian Reservation. The president of the company named the

new town "Faith" after one of his daughters. Faith's first bid for fame came in those early years as the largest initial shipping point for livestock on the Milwaukee Railroad System. Although Faith no longer has a train, it still has one of the largest livestock markets in the country.

The Minneapolis Brewing Company Warehouse is a highly intact building dating from the earliest years of Faith's history. It still stands as an architecturally and historically significant reminder of the town and region's glory days.
