# **Description:**

Old Canterbury Road in Plainfield represents the former course of Route 14A, known today as Canterbury Road, before being bypassed by a state-highway construction project in the 1930s. It is a narrow, curving paved road, about 20 feet in width, bordered by a verge of shrubs and vines about 14 to 16 feet wide on either side, beyond which are stone walls (Photograph 1). A utility line runs along the north side of the road only for a short distance at the extreme western end. The stone walls are overgrown with ferns and ivies from late Spring to late Fall (Photograph 2) but are clearly visible at other times of the year. The buildings along this part of the nominated segment consist of both houses of modern construction, which are all set back far enough from the road that they are not readily apparent, and 19th-century houses, including a 2 1/2-story clapboarded house at the west end dating from 1816 (48 Old Canterbury Road, Photograph 3) and a similar-sized Greek Revival-detailed house at the east end, where Old Canterbury Road intersects with Exley Road and Route 14A.

The land on the north side of the road is in large part open and is cultivated for hay or corn. Although somewhat obscured by shrubbery and the foliage of the line of deciduous trees along the road in summer, these fields are readily apparent through breaks in the vegetation and are clearly visible once the foliage dies down (Photograph 6). On the north side of the middle portion of Old Canterbury Road there is a stand of large old gnarled sugar maples, which, despite missing many of their larger branches, continue to contribute to the overhead canopy that shades the road (Photographs 5 and 6).


Because of the continuity of agricultural use and the resulting visual qualities, the nominated segment was extended eastward along Route 14A. There the buildings include a mix of mid-20th-century farm structures and older sheds and barns (Photograph 5), and the roadway itself is wider. There are two 12-foot travel lanes, a 10-foot-wide paved shoulder on the north side, and a six-foot shoulder along the south side. The road is flanked by a grassy verge 28 feet wide on either side. As it approaches the east end of the nominated segment, defined as the crossing of the power lines about 1,200 feet from the intersection of Old Canterbury and Canterbury Roads, the paved shoulders disappear and the verges narrow to 16 feet on the north side and eight feet on the south, yielding the usual overall width of about 50 feet. At this end, the remnants of stone walls are in place on both sides of the road, and there are expansive views of plowed fields and pasture both to the north and to the south (Photograph 8).



### Significance:

**Multiple Property Listing**) Page 1 The nominated segment, consisting of Old Canterbury Road and its continuation along Canterbury Road

(Route 14A) in Plainfield, is significant because it allows one to imagine the appearance of the Connecticut countryside--the cultivated fields, woods, stone walls, and narrow, windy roads--that the French army encountered as it made its way to and from the Battle of Yorktown, the engagement that decided the outcome of the American Revolution (Criterion A). Marching in divisions from their third camp at Plainfield Center to the fourth camp along the Shetucket River in Windham, the troops under Count Rochambeau's command passed over this segment in the middle of June 1781 and again in November 1782, on the return march from Yorktown.

The Connecticut landscape experienced by the French consisted of both open fields and stretches of woods, since the full extent of land-clearing for agriculture had not yet been reached. In the words of Claude Blanchard, Rochambeau's chief commissary:

The country is a little more cleared, especially in the environs of Plainfield, where, nevertheless, there are only five or six houses. I saw some farms sown with rve and wheat, but especially with maize ... and with potatoes. I also passed through many woods, mostly of oaks and chestnut trees. ... [west of the Plainfield camp] the country is very similar to the environs of Plainfield; yet more pasture lands there, which are in valleys. So we ascend and descend continually on these roads (Blanchard 1969: 108-109).

The hilliness noted by Blanchard was but one of the deficiencies of Connecticut's early roads, at least in the opinion of the French officers responsible for moving thousands of troops and hundreds of artillery pieces and supply wagons. In addition to steep hills, the French found the roads narrow, littered with stones, and in some places, too overgrown with vegetation to allow a wagon to pass (the main column had to be preceded by a company of ax-wielding pioneers). The particular part of the route represented by the nominated segment was regarded by the French as better than the section east of Plainfield; nevertheless, the baggage for the Bourbonnais regiment was greatly impeded by the condition of the roads and arrived very late for the Windham encampment.

The authenticity of the nominated section of road is substantiated by the general topography as shown on the French route map (Figure 2), though the lack of a consistent north inherent in the format is particularly apparent for this portion. The bend in the Quinebaug River as it cuts through the steep ridges is an easily identifiable reference point. The presence of old houses along the route also helps to confirm the antiquity of the general alignment, even though they are not quite as old as the period of the French marches.

### **Verbal Boundary Description:**

The nominated property consists of Old Canterbury Road and the portion of Canterbury Road (Route 14A) from its intersection with Old Canterbury Road eastward approximately 1,300 feet to a point where an electrical power line crosses. The road is construed as including the full width of the public right-of-way.

### **Boundary Justification:**

The boundary includes the portions of Old Canterbury Road and Canterbury Road (Route 14A) that retain the visual qualities that convey the segment's historical significance as a portion of the route traversed by the French Army in 1781-1782. Farther west on Route 14A, beyond the western terminus of Old Canterbury Road, the stone walls are no longer in place, the land is not open, and the road has been substantially widened.

The portion of Route 14A east of the intersection with Old Canterbury Road was included because the roadway, though widened, retains remnants of stone walls on both sides and because this portion is characterized by expansive views of cultivated fields. Farther to the east, the fields are interrupted or replaced by denser modern residential development.
