Description The Jacob Wingard Dreher House is a ca. 1830-50 two-story, rectangular, weatherboarded frame farmhouse with a gable roof and a one-story, shed-roofed porch on the facade. A ca. 1910 single story wing is connected to the left elevation by a porch. The gable ends are pedimented. The facade is divided into five bays on each story. The first story has three doors flanked by end windows; the second story has a window in each bay. First story windows are nine-over-six; those on the second are six-over-six. The central door is framed by a multi-paned transom and sidelights above recessed wood panels. The front porch, which is supported by square wood posts, extends to shelter the ca. 1910 left wing. To the right of the house is a one-story, frame, weatherboarded store building, which ca. 1945 was moved from its original location anterior to the house on the same side of Old Dreher's Ferry Road.

Significance The John Wingard Dreher House is a representative antebellum Lexington County farmhouse. Believed to have been built either by Jacob Wingard Dreher (1931-1905) or his father Daniel (1798-1832), the house is associated with a prominent Lower Dutch Fork farm family of pioneer German extraction; the simple architecture of the house is typical of the German farm folk. A prominent farmer, magistrate, churchman, and storekeeper, Jacob Wingard and his wife Ann Hiller were parents of nine children. Three sons, Dr. T. H. Dreher, L. E. Dreher, and Frank E. Dreher, were active in public affairs.<sup>47</sup> Another son, John E. Dreher, operated the 600-acre tract containing the house from 1913 until all but 150 acres were sold for the Lake Murray project when the Jacob Dreher estate was settled in 1926.<sup>48</sup> In 1945 the present property was purchased from John E.
