The Morse Residence faces southeast onto Oak Street, next to the former Free Methodist Church, between Fourth and Fifth Streets. The house is located near the western edge of town in an older residential neighborhood. There are large Persian Walnut trees in the front and side yards.

ARCHITECTURAL DESCRIPTION:

The Morse Residence is one and one half stories high and "T" shaped in plan. It has a wood post and brick foundation, except for the addition to the rear of the building which has which has a poured concrete foundation. The house is sided with shiplap and has a medium pitch gable roof with boxed eaves. The windows are four over four double hung sash with pedimented cornices. There is a small stoop with a shed roof supported with brackets over one of the doors on the front facade; it appears the stoop was added in the 1920's. A second porch, supported by one, square, solid post extends across the recessed portion of the front facade. A large addition which is sided with plywood and has metal sash windows has been built on the rear of the building. The house measures 35' X 49'.

HISTORICAL DESCRIPTION:

Very little information has been found on this residence. In 1873, the property was sold to William Hash, (Resource #18) who was a farmer and later a land speculator, for \$6.00 at a Sheriff's Sale. The sale was a result of a suit by Daniel Barnum against Andrew Smith for non-payment of a promissory note. It appears that the house was built in the 1870's or early 1880's because of its form and architectural detailing; the window detailing is similar to the Dr. Stuart Residence (Resource#3). A 1905 Map of Dayton, annotated by Bingham Gabriel, indicates that "Morse, Sr." resides there. The 1900 census lists Robert and Isibella Morse as residing there and owning the property. Little is known about the Morses, especially their relationship to Benjamin and Rosina Morse who resided around the corner of Fifth Street, (Resource #18), or to Lee F. Morse who sold the adjacent property to the Free Methodist Congregation in 1866.


SIGNIFICANCE:

The well maintained Robert Morse residence represents a local interpretation of the Gothic Revival style of architecture, popularized in Dayton during the latter part of the 19th century. Criterion c.
