STATEMENT OF SIGNIFICANCE

Architecturally, the Old Court Hose is a physical document of the graceful, ante-bellum era and the difficult years of Reconstruction. The building's elaborate detail and massive proportions attest to the affluence of pre-Civil War Newberry County. Its eye-catching bas-relief remains as a reminder of the spirit of South Carolinians during the bleak period of Reconstruction.

This building, the fourth in a series of five Newberry County Court Houses, was used for court sessions between 1852 and 1906. Presently, the Social Security Office and County Development Board occupy the first floor. Restoration of the upper floor for adaptive use as a community hall includes kitchen equiptment, air-conditioning, heating, repainting.
