The Lawton Mills Historic District consists of over 100 houses and other mill-related structures surrounding a large former textile mill in Plainfield, Connecticut. Arranged west and east of the mill, most of the houses are plainly detailed former tenements built to accommodate the mill's workers. The district also includes a large Neo-Classical building that served as a recreational building for the mill workers and the Lawton Inn, a Colonial Revival structure built to lodge visitors and the travelling representatives of the mill when they were in Plainfield. The district extends along Railroad Avenue to include several commercial and religious buildings that were either associated with the mill or that date from the same period.

The first of the mill's structures (Photographs 1, 2, and 3) were located immediately south of Railroad Avenue and consisted of a threestory spinning mill 225' long by 100' wide, a one-story weave shed which was connected to the south end of the mill, 22' by 150', and a number of ancillary buildings, including a storehouse, a picker house, a boiler house and engine room, and a 150' high smokestack. All structures were built of brick. The original power source was a Cooper cross-compound engine producing 1,209 horsepower. The architect was Lockwood, Greene & Co. of Boston, the nation's premier textile engineering firm. The capacity of the mill was 30,000 spindles and 250 to 300 operatives were employed. In 1911 the size of the mill was more than doubled. A 180' addition was constructed on the north side of the original spinning mill and the weave shed was extended 200' to the south. Then, a second mill and weave shed, duplicating the dimensions of the expanded original mill, was built, with the weave sheds joined together to form a structure almost 2,000' in total length, the weave sheds alone measuring almost 1,000'. Another steam engine was employed, and the entire mill was illuminated with electric lights. Again the architect was Lockwood, Greene & Co. At its peak, Lawton Mills had a capacity of 130,000 spindles and employed 1,200 people. The only other industrial structure in the district is a small onestory brick factory built in 1915 to accommodate a textile-machine roller-covering business.

The district's mill housing was built in two phases, paralleling the expansion of the mill (Photographs 4 through 7). Initially, a number of tenements were built in rows to the west of the mill, across the tracks of the Norwich and Worcester Railroad. Later, additional mill housing was constructed on a newly purchased tract of land between the mill and Norwich Road (Route 12) to the east. Eventually, the company constructed 125 two-family tenements for its workers and about 15

houses for supervisory personal. The 1 1/2-story plainly detailed houses have a center cross gable and a double central entry.

The Colonial Revival style is seen in several buildings erected by the mill company. Houses built for supervisory personnel (Photograph 8), Harold Lawton's own house (Photograph 9), and the Lawton Inn (Photograph 10) all display details of the Colonial Revival style, such as gambrel roofs, small-pane sash, and large central chimneys. The Community Building (Photograph 11) is also of Colonial Revival design, particularly the cupola, although the stuccoed walls and heavy timbers seem derived from Spanish Mission architecture of the Southwest; it currently serves as Plainfield's Town Hall and as a recreation center (it was built with an indoor swimming pool).

The commercial architecture of Plainfield is fairly limited. There are a few plain c.1900 buildings with the then-popular bracketed cornices, such as the former opera house (Photograph 15), and a small but elaborately detailed brick Neo-Classical Revival former bank (Photograph 16). There is only one large brick block, built in the 1920s for the Mercier drug and department store (Photograph 14).

The great majority of the buildings in the district retain their original form. Replacement of original clapboard exteriors with modern siding materials is the chief alteration evident in the district, but even where this has occurred, enough remains of entry and window trim to indicate the buildings' original detailing. There are very few noncontributing buildings to interrupt the concentration of historic buildings within the district. The boundary was delineated so as to include all contiguous formerly mill-related properties. The boundary generally follows property lines; however, some property lines were cut so as to exclude excessive land or buildings that were not associated with Lawton Mills.

The count of contributing properties includes one site, a small public park with war memorials (Photograph 12), and two structures, both of which are water towers built by the mill to provide water for fire protection and for domestic use in the village (Photograph 7).

In the Inventory that follows, the term "siding" is used to indicate either vinyl or aluminum siding, and "composition" indicates any of a number of pressed-fiber shingle materials, such as asbestos and wood pulp. Contributing resources are enumerated in the "C" column and noncontributing resources in the "NC" column.

#### Summary

The historic resources included in the Lawton Mills Historic District are significant because they illustrate the tremendous impact of textile manufacturing in the development of eastern Connecticut (Criterion A) and because they embody the distinctive architectural and spatial characteristics of a 19th-century mill town (Criterion C). In the early years of the 20th century, the economic and social life of Plainfield was transformed when Harold Lawton built a large steampowered cotton factory that necessitated hundred of workers. The presence of the mill and its economic success allowed this part of Plainfield to grow and prosper, changing it from a minor railroad junction into a vibrant small town, with numerous stores, churches, a bank, and places of entertainment.

#### Historic Significance

Harold Lawton's first experience of cotton manufacturing occurred while he was a young man in England. Lawton emigrated to America in 1872 and held a series of successive jobs in mills located in Rhode Island and eastern Connecticut, as well New Hampshire and Canada. In 1901 Lawton became superintendent and manager of Baltic Mills in Sprague, Connecticut, and remained there until he built his own mill in 1905. It is unknown why Lawton chose Plainfield as the site of his mill. Plainfield Junction, a terminus for both east-west and north-south rail lines, provided excellent transportation facilities for the delivery of cotton and coal and for the shipment of finished goods. Also, the presence of numerous cotton and wool manufacturers already at work in town provided a pool of skilled, experienced textile workers.

Lawton purchased the site of the former Robinson and Fowler Foundry and constructed a three-story cotton spinning mill and an attached one-story weave shed. The company's product was fine combed goods. In 1911 the size of the mill was doubled and all buildings were illuminated by electric lights. Eventually, the mill went from the capacity of 30,000 spindles to 130,080 spindles. The mill employed 1,200 people and had 2,442 looms.

To accommodate its workers, Lawton Mills constructed 125 duplex residences between 1906 and 1911 on land located east and west of the mill. Originally, Lawton wanted the residents of Plainfield themselves

to construct houses for the mill workers. William Payson Babcock and his brother Telly bought a large plot east of the mill. They sold some lots to prospective homeowners and built one tenement; however, they did not meet with overall success. They then sold the land to the mill company, which used it to build houses for supervisory personnel. Since other developers also experienced little success, Lawton Mills built the majority of the village's tenements.

The mill promoted growth in Plainfield's commercial district. Along Railroad Avenue a bank was built in 1912 (with Harold Lawton as president), as well as an opera house and several large stores. Edmund Mercier built a drug and department store around 1920 that sold a wide variety of goods, including a complete line of clothing.

Under the leadership of Samuel Taylor Butterworth, Harold Lawton's successor, Lawton Mills concerned itself with its workers' well-being. Butterworth, like Lawton, had held a number of successive jobs in nearby mills before he assumed his position at Lawton Mills. Lawton Mills was an extremely paternalistic company. The mill realized that contented and satisfied workers produced better results. The mill houses had indoor plumbing and electric lights, two features that were far from common in the industrial housing of the period, and they were exceptionally well-maintained. The company constructed a recreation building in 1920 with an indoor swimming pool, bowling alleys, pool tables, a card room, and a library. The mill also built the Lawton Inn to accommodate the company's travelling representatives and visitors. Because of the rapidly increasing number of school-age children in the village, a new public school was constructed in 1912. Harold Lawton contributed one third of the \$15,000 needed for the building.

Many of the workers at Lawton Mills were immigrants, and their presence affected the town's social life in many ways. To supply the religious needs of the majority of millworkers, who were French Canadians, a Catholic mission was formed soon after the mill was opened, and services were held in various halls until a church was built in 1907. In 1929 a Catholic elementary school was opened. There were also a number of skilled textile workers from England, and in 1914 an Episcopal church was built on Norwich Road.

The quarter-century after the building of Lawton Mills was a positive period in the history of Plainfield. The mill offered steady employment, paid good wages, and kept its housing in excellent condition. To be sure, the governance of the mill and its workers'

lives was pure paternalism, not democracy. The mill's managers promoted schools and recreation for their own interests, and workers had no voice in their administration. Nevertheless, under the leadership of Harold Lawton and Samuel Taylor Butterworth, the company's policies were genuinely benevolent and brought many advantages to its employees. Unions found it difficult to organize Lawton Mills, and for the company's first 30 years, no strike was ever called.

With the onset of the Great Depression, Lawton Mills entered a period of decline. Losses mounted steadily after 1930, and the company found it increasingly difficult to finance needed improvements. In early 1936 the first strike in the company's history stopped production, and in March, nervous shareholders voted to liquidate all assets.

The closing of Lawton Mills left a tremendous void at the center of community life in Plainfield. Gradually however, space in the empty mills was rented to other companies, and by 1940 the economic outlook was improving. Growth continued after the Second World War, and today the area possesses a healthy mixture of diversified industries and historic areas of great character. The future of the mill itself, however, is less certain; most of the complex is currently vacant.

#### Architectural Significance

The huge mill complex and the nearby tracts of mill-related housing make Plainfield an exceptionally good example of the mill village, a settlement pattern found throughout eastern Connecticut. The streets of nearly identical employee houses that surround the mill re-create the sense of order and company control that historically characterized such villages. The paternalistic presence of the mill is further recalled by the former community building and the Lawton Inn, indications that Lawton Mills provided not only work and shelter but also other necessaries of life and even opportunities for recreation.

The mill company's own buildings, the largest buildings in the village, are also the most elaborately detailed, symbolizing their central importance. Of these, the Colonial Revival Lawton Inn is perhaps the most impressive: its slate-covered gambrel roof, fan lights, and Neo-Georgian entrance treatment recall the formal architecture of the Colonial period. The Community Building, also a Colonial Revival design, continues the theme with its overall symmetry and cupola,

although the stuccoed walls and heavy timbers seem derived from Spanish Mission architecture of the Southwest. Finally, Harold Lawton's own house, surprisingly modest for the richest man in the village, incorporated Colonial Revival elements, particularly in its porch details.

In contrast, the houses built for the mill's workers are archetypal company-built dwellings: plain in form, with symmetrical duplex or other modular plans. As was typical, most of the houses are devoid of architectural embellishment. Only the houses built for supervisory personnel have a semblance of architectural style. Although rather plainly detailed, these have the gambrel-roofed or hip-roofed box-like form associated with the Colonial era, and many have a large central chimney, small-pane windows, and other Colonial Revival details.
