The building which housed the Robinson Business College is located in a modest African-American neighborhood in southern Monroe. Built quickly and inexpensively in 1946 to open that year for students, the one story building is constructed of concrete blocks with brick veneer accents on the facade and one side elevation. Although there have been alterations associated with its recent conversion into a hair salon, the building still would be easily recognizable to someone who attended school there the year it opened.

The roughly 4300 square foot rectangular building has a low pyramidal roof and is devoid of ornamentation. There is a small shed roof projection at the rear corner which appears on a 1950 Sanborn map. The metal windows on the side elevations and most of the rear elevation are original. Grouped in twos, each has four horizontal panes.

Alterations to the exterior are as follows:

- (1) Some of the windows on the facade have been covered with wood panels while others have been partially filled in to accommodate smaller modern windows. Burglar bars have been attached to the windows.
- (2) Doors appear to be of recent vintage.
- (3) A section of the facade was damaged in an automobile accident some years ago. This was repaired with concrete blocks with an openwork pattern.

The interior of the building is very simple and functional. The floorplan allows for various classrooms, a small registrar's office and a long, narrow administrative office. The registrar's office retains its curving counter and two interior windows.

Changes to the interior include the placement of glass doors in the wide opening between the two large classrooms at the western end. According to B. D. Robinson, who founded the school along with his wife, the opening between the two classrooms was always large. It appears from interviewing Mr. Robinson that there may have been partitions or some type of folding door in the opening originally. One of the classrooms on the eastern side of the building has been subdivided, although the walls are of a temporary nature and do not extend to the ceiling.

### Assessment of Integrity:

Despite the above alterations, the Robinson Business College building would be immediately recognizable to someone who attended school there in 1946, which is the litmus test for integrity under Criterion A.

The Robinson Business College is locally significant in the areas of education and ethnic heritage because its opening in the nominated building in 1946 represented a breakthrough in professional educational opportunities for African-Americans in the Monroe area.

Robinson Business College began in the home of Mr. and Mrs. B. D. Robinson in the spring of 1944 with four students. Enrollment increased, necessitating the construction in 1946 of the nominated building. In September 1946 twelve "regular" students enrolled and forty-six veterans (the latter via the new GI Bill). Initially there were two teachers. The course of study involved one and two year programs in areas such as executive secretarial, accounting/bookkeeping, typing, stenography, and business administration. By the time the school closed in 1988, the faculty had grown to seven.

Although both individuals played critical roles in the school, Mrs. Robinson seems to be regarded as the driving force behind the institution's founding and success. A graduate of Southern University in Baton Rouge and Tuckers School of Business in St. Louis, Missouri, she dedicated her life to assisting young blacks in the pursuit of secretarial and business careers. Interviews with graduates reveal that the Robinsons did much more that provide a much needed professional educational opportunity. They were both consistently described as "motivators." Graduates speak passionately about how Mrs. Robinson instilled confidence in her young protegees -- that she made them believe they could achieve anything with the proper skills and attitude. An interesting aspect of the curriculum emphasized by graduates during interviews conducted for this project was a course essentially in behavior -- proper deportment and diction, pointers on how to interview well, etc. It is described in a 1980s catalog as "personality development." Graduates often refer to the room where it was taught as the "charm room."

Although almost all of the school's history is within the last fifty years, the Division of Historic Preservation believes that Robinson Business College is eligible for the Register because its very opening was an important breakthrough for African-Americans in the Monroe area, as noted in the summary paragraph above. Prior to its opening, blacks in northern Louisiana seeking professional educational opportunities beyond high school were limited to Southern University in Shreveport, about 100 miles to the west of Monroe, and Grambling University, a teacher's college about 35 miles to the west. With the opening of Robinson Business College in the nominated building in 1946, there was a place locally to acquire a one or two year program of study leading to employment in the secretarial and business fields.

(The closest place where there might have been a business school for African-Americans would have been Shreveport.) In filling a need for professional education on the part of students, the Robinson Business College in turn filled a void locally for black businesses in need of professionally trained secretaries, accountants, etc. Prior to Robinson's opening, they had to "import" employees from elsewhere in the state where such training was available.

The principal service area for the school was Monroe and the surrounding rural parishes. Monroe in 1940 was the state's fourth largest city, with a population of 28,309, and in 1950, the fifth largest, with a population of 41,272. Forty-two percent of its population was African-American. In addition to this obvious base, Mrs. Robinson recruited actively for students in the rural high schools near Monroe. (These students either boarded somewhere nearby or lived in one of two bungalows in the neighborhood acquired by the school.)
