

Description

This one- and one-half story bungalow is located on the west side of Wentworth Avenue, two lots north of Pinehurst Drive, within the Oak Knoll subdivision. The dwelling has a deep front yard set-back covered by a grass lawn. A meandering driveway follows the northern property line, concluding at the northwest corner of the property in a wide turn-around access to the historic two-bay automotive garage. Between the garage and house is an historic gazebo, whose three lattice walls are framed by turned wooden columns and a roof of wooden rafters. The garage and gazebo are contributing secondary structures. A non-contributing swimming pool, introduced to the site in 1954, occupies most of the southwest corner of the garden. A concrete block wall located between the house and the garage was added in 1952. Large mature deciduous trees effectively screen the northern edge of the property; a mixture of deciduous and palm trees defines the southern line of the property. A single mature palm tree is planted within the recessed area formed by the two wings projecting from the western facade. The house's foundation planting consists of clipped hedges and exotic flowering plants. The residence, garage, and gazebo have had very little alteration since their construction, and the property retains integrity.

The structure of the house consists of a concrete foundation, hollow tile first story and a wood stud frame partial second story. The dwelling has an irregular shaped plan with extensions projecting from three corners of the central volume. Additionally, a wide and deep front porch with a partial conical roof wraps around the northeast corner of the house, merging with the northern roof plane of the house into a porte-cochere. Stylistically, the dwelling and garage exemplify a California interpretation of the English Cotswold cottage. This architectural imagery is conveyed through the low-lying horizontal form of the dwelling and garage whose arcing and hipped roof planes with rolled eaves are wrapped with wooden shingles. These shingles replace the highly authentic use of thatch that originally covered the roof (by 1928). The gravity-bound quality of the house is further emphasized by the massive entrance porch whose weight is borne by squat brick piers and blocky wooden supports. Other elements contributing to the architectural character of the house are the decorative barge board pattern of the entrance porch, and the use of half-timbering (or black and white work) within the arched gable end of the porch and beneath the soffitt of the octagonal bay windows projecting from the east (front) and south elevations of the second story. Two brick chimneys are visible from the street; the southern and more prominent stack is ornamented by decorative tiles. The paneled entrance door flanked by leaded glass windows is sheltered beneath the porch. Secondary access to the house is provided from recessed porches located within the northern and western facades. A bow window lit by a row of casement windows with transoms is located north of the principal entrance; this is visually balanced on the street facade by a three-part window with a large central pane of glass flanked by casement windows. A variety of window types are used throughout the house. The first story is sheathed in stucco; wooden shingles clad the second story. The only notable exterior alteration is the enclosure of

porch located at the southeast corner of the house (date unknown). This is not

visible from the street, and is barely detectable from the rear of the house. One of the most exceptional features of the interior is a large Batchelder-designed fireplace in the living room. The dining room retains its historic wood paneling, paneled pocket doors, and built-in cabinetry. The design of the staircase, which rises from the entrance hall, refers to the classical tradition of eighteenth century England more than to the medieval forms of the Cotswold cottage.

## Statement of Significance

Built in 1917, the house at 1233 Wentworth Avenue was designed for Lydia C. Edmonds, a widow, by the architect Arthur S. Heineman. The dwelling represents the property type "Arts and Crafts Single-Family Residences in Pasadena," and is an excellent example of a Cotswold cottage (English influenced) within the subtype "one-and-one-half-story bungalow." It meets the registration requirements under Criterion C, as it exemplifies the values of design, craftsmanship, and materials which embody the philosophy and practice of Arts and Crafts period residential architecture in Pasadena, and the property retains integrity. Distinguishing features associated with the Cotswold cottage include the shingle-clad roof with rolled eaves, low lying horizontal form emphasized by a wide entrance porch/portecochere, decorative barge board, and half-timbering.

## Verbal Boundary Description

That portion of Lot 7 Oak Knoll, sheet "A", in the City of Pasadena, County of Los Angeles, State of California, as per map recorded in Book 10, pages 114 and 115 of Maps in the office of the County Recorder of said County, described as follows: Beginning at a point on the easterly line of said Lot 7, distant South 8 degrees 40'00" East, 100.00 feet, as measured along said easterly line from the northeasterly corner of said lot; thence along said easterly line North 8 degrees 40'00" West, 100.00 feet to said northeasterly corner; thence along the northerly line of said lot 7 South 81 degrees 20'00" West, 262.83 feet to the northwesterly corner of said lot; thence along the westerly line of said lot, South 1 degree 26'40" West, 101.47 feet and North 81 degrees 21'18" East, a distance of 280.64 feet to the Point of Beginning.
