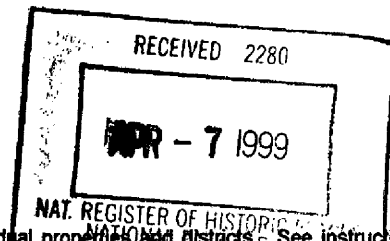

SUMMARY

Edison Park Elementary School, constructed 1927, is a two-story, T-shaped Mediterranean Revival style building constructed of stuccoed hollow clay tile. It has a flat, built-up roof surrounded by a parapet decorated with a pent roof surfaced with clay tile and supported by carved brackets. The areas of clay tile are pierced by pillars that are extensions of the vertical wall bays that separate the major window and door bays. The major entrances to the building are defined by frontispieces that have shaped parapets and feature decorative elements executed in bas-relief. The major fenestration consists of a multi-light variety of double hung, wood sash windows. The building rests upon a poured concrete foundation. In 1958, a two-story, stuccoed, concrete block building was erected northwest of the original school and connected to it by a narrow, two-story corridor. The style of the building reflects, but does not imitate, the original structure. A noncontributing school building, constructed in 1992, is found immediately northeast of the historic school building. In 1991, the Edison Park Elementary School became a magnet school providing instruction in the arts for students in kindergarten through fifth grade.

SETTING

Edison Park Elementary School is located at 2401 Euclid Avenue (Photos 1-2) in a residential area south of downtown Fort Myers, Florida, a city of approximately 400,000 residents found in Southwest Florida near the mouth of the Caloosahatchee. The building occupies the approximate center of an irregularly-shaped city block and is flanked on the northeast by a non-contributing school building. The school property is bounded on the west and south by Euclid Avenue, on the north by Edison Avenue, and on the east by Cleveland Avenue (U.S. Highway 41). The school property is landscaped with several mature live oak and laurel trees and also features smaller oak and palm trees.

PRESENT AND ORIGINAL APPEARANCE

Exterior

Main (south) Facade

The main (south) facade of the school is divided into eleven major and minor bays separated by parapet risers (Photo 3). The central entrance bay (Photos 4-5) features a one-bay, recessed porch surrounded by a frontispiece richly decorated with classical style, terra-cotta

ornamentation executed in high and low relief. Set within the porch is a double-leaf, wood and glass door with a sixteen light transom that provides access to the building. The front of the porch bay features a narrow surrounds decorated with acanthus and anthemion motifs. The same motif is continued in the entablature with corner pedestals that separate the entrance from a pair of narrow second story windows flanked by pilasters that support an elaborately decorated terra-cotta arch. The frontispiece terminates in a curvilinear parapet that rises above the clay tile covered pent roof. The pent roof elements on either side of the central parapet shelter groups of five windows in the second story (Photo 6). The windows have decorative terra-cotta surrounds that include an acanthus cornice, foliated frieze, and fluted pilasters with ornate bases and capitals. The lower story windows in the bay immediately flanking the main entrance are unadorned and consist of single narrow windows flanked by paired double-hung sash window. The same fenestration arrangement is continued throughout the remaining bays of the main facade. The outer wings of the facade are identical and contain two single double-hung sash windows flanked by groups of five windows in each story (Photo 7).

East and West Elevations (East-West Section)

The side elevations of the east-west section building have the same configuration (Photos 8 and 9). A central shaped parapet is bracketed by pent tile-covered roofs that extend to corner parapet risers. A terra-cotta quatrefoil is centered on the parapet. The pair of second story windows are topped by transom lights. A terra-cotta entablature, similar to the one above the main entrance on the facade, is located between the windows and a recessed entrance. Rectangular panels with masonry sills flank the central bays in both stories.

North Elevation (East-West Section) (Photos 10-11)

The fenestration on the rear elevation of the wings is asymmetrical and consists of single, paired, and grouped windows in rectangular openings.

North Auditorium Extension (Photos 10-12)

A flat roof extension, which houses the school's auditorium, projects from the center of the rear elevation. The parapet of the auditorium contains a series of curvilinear parapets. Pent roofs extend to cover 8-light fixed clerestory windows. The ground floor windows of the auditorium are set in groups of three, each with its own three-light transom.

Exterior Alterations (Photo 13)

In 1958, a two-story, stuccoed, concrete block building was attached to the west wing of the 1927 structure by a two-story corridor. The style of the addition reflects, but does not imitate, the original structure.

Interior

The main entrance opens into a foyer, which leads to the main hall (Photo 14). North of the foyer are doors to the auditorium flanked by two sets of stairs leading to the second floor. The main hall (Photo 15) runs east to west and retains much of its original woodwork in the form of pine chair rails and baseboards. Sets of paired doors with transoms lead from the main block of the building to the wings.

The auditorium (Photos 16-17) retains many of its original characteristics. The floor of the auditorium slopes toward the stage area. The stage, which retains its original pine floor, has a semi-circular extension that projects toward the seating area. Its rectangular opening has a proscenium decorated with a floral pattern and a center crest. The windows of the room also have carved wood surrounds consisting of slender pilasters with simple capitals and attached carved crests. Elaborate metal rosettes hold the theater's globe lighting fixtures. The ground floor seats 340 persons and the balcony 116. To the rear of the stage is a narrow hall (Photo 18) that separates the original auditorium from a concrete block dressing room and storage addition that was constructed in 1958.

At the west end of the main hall on the first floor is a passage (Photo 19) that leads to the 1958 building. Only three of the classrooms (Photo 20) on the ground floor remain in their original configuration. Some of the original blackboards and wood moldings remain in those rooms. Additional sets of stairs (Photo 21), which retain their original balustrades and newel posts, are located at the east and west ends of the hall. Most of the interior spaces of the second floor are intact. The second floor hallway (Photo 22) resembles the one on the first floor, with the exception of a large open landing that is reached by the central stairs. The auditorium balcony is accessed through a pair of wood panel doors (Photo 23) on the north wall of the landing. There are six classrooms on the second floor (Photo 24).

Interior Alterations

In its original configuration the building contained seventeen classrooms, a library, two offices, an auditorium, and girls' and boys' restrooms on the first and second floors. In 1958, the classrooms at the northwest corner of both floors of the building were subdivided into offices, and halls were added to connect the original building with the two story corridor that leads to the northwest building (Photo 19). Administration offices were placed in the classroom space immediately east of the main entrance. Also in 1958, a small concrete block addition was constructed at the rear of the auditorium to provide storage space and girls' and boys' dressing rooms (Photo 18). In 1968, classrooms on the first and seconds floor were subdivided to create larger boys' and girls' restrooms. The interior of the building received a major renovation in 1992. All of the ceilings in the school have been lowered to provide space for electrical and air conditioning conduits.

NONCONTRIBUTING BUILDING

A two-story, noncontributing school building, constructed in 1992, is found immediately northeast of the historic school building. This building is not included within the historic property boundaries.

STATEMENT OF SIGNIFICANCE

SUMMARY

Edison Park Elementary School is eligible for listing in the National Register of Historic Places under criteria A and C at the local level in the area of architecture and education. Completed in 1927, the building is associated with a massive building campaign undertaken by the Lee County School Board in the 1920s to improve and consolidate school facilities throughout the county. It is an excellent example of Mediterranean Revival style architecture applied to a large public school building constructed in the city of Fort Myers, Florida during the land boom years of the mid 1920s. It contributes to the *Historic Resources of Lee County* multiple property group under historic context V, **Historic Development of the Lee County School System, 1887-1950** and property type F.3 **Educational Buildings**.

STATEMENT OF SIGNIFICANCE

In 1911 the City of Fort Myers took its first steps toward establishing modern educational facilities for its school age children by erecting a large brick schoolhouse, known as the Gwynne Institute, in the downtown area. The city grew steadily over the following decade and two additional schools were constructed. The pace of growth quickened as Fort Myers entered its most significant period of development during the Florida land boom years of the mid 1920s. By 1925 the school system had again become overcrowded. Gwynne Institute, which was then operating as an elementary school, was forced to implement double sessions to handle its large enrollment. With the need for a new school becoming acute, local school officials began to make plans for the erection of a new school that would augment the existing elementary school facilities.¹

Early in 1925 the Fort Myers school district petitioned the Lee County Board of Public Instruction for permission to issue bonds for new schools, part of which would be slated for the erection of a new elementary school in the city of Fort Myers.² Plans for the school were completed by local school architect L.N. Iredell in October 1925. Iredell's design called for the erection of a two-story Mediterranean Revival style building with seventeen classrooms, a library, and an auditorium capable of seating 500 people. In late January 1926, the J.M. Lawton

Company was awarded the contract for construction with a bid of \$149,500. The final cost of the school was later estimated at \$161,300.³

In March the Lee County Board of Public Instruction purchased an entire block of land in the largely undeveloped Edison Park Subdivision for \$65,000. The subdivision, owned by the New Homes Development Corporation, had yet to be formally opened. The property deeds carried a series of restrictions that governed the size, cost, and type of buildings that could be constructed and included a requirement that all houses have Mediterranean style designs. The sale of the land to the LBPI was contingent upon the New Homes Corporation's assurance that the surrounding streets would be paved with asphalt and sewer, water, and gas lines installed by January 1, 1927.⁴

The cornerstone of the building was laid at a ceremony held on May 13, 1926. All local schools were closed at noon to allow school children to take part in the festivities. The renowned inventor and long-time winter resident of Fort Myers, Thomas Alva Edison, and his wife, Mina, were present and participated in the dedication by planting a Cuban laurel tree that still stands on the property.⁵ The school officially opened in March 1927. It has been in continuous use as a school since that time. For a time, the school auditorium was the largest in Fort Myers and was used as a community center, hosting a wide variety of entertainment productions.⁶

At the time it was constructed, the Edison Park Elementary School embodied most modern concepts in primary and secondary education, as it was envisioned nationally in the 1920s. It was a central school plant that combined classrooms, a library, an auditorium, a nurse's office, and administrative offices in a well-lighted building that was designed for the education of

children of both sexes extending across a range of grades. It was constructed as part of the first concerted effort by the county's school districts to provide modern and safe educational facilities for their school age children. The building is also significant as an example of combining contemporary stylistic architectural concepts in educational facility design.

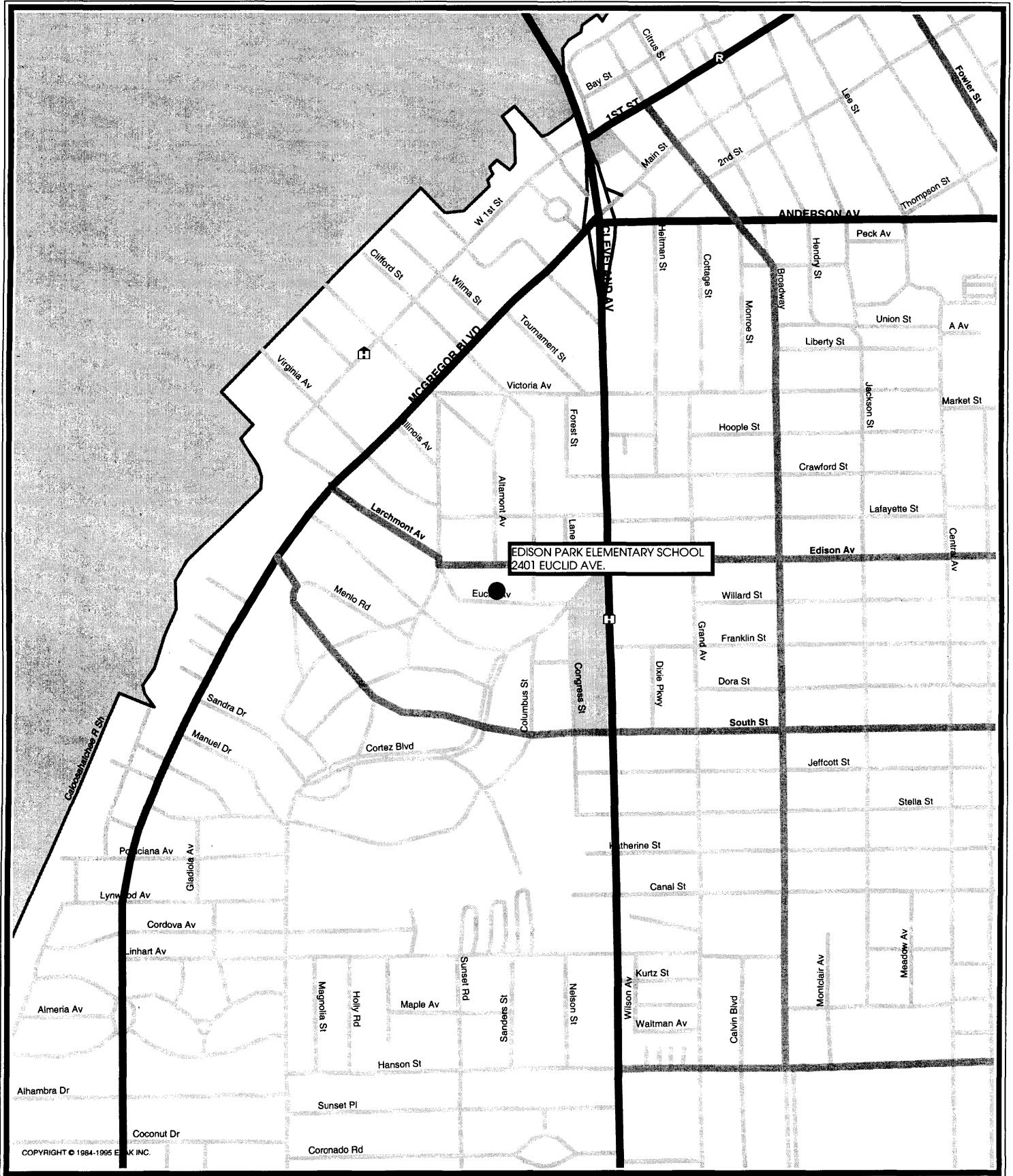

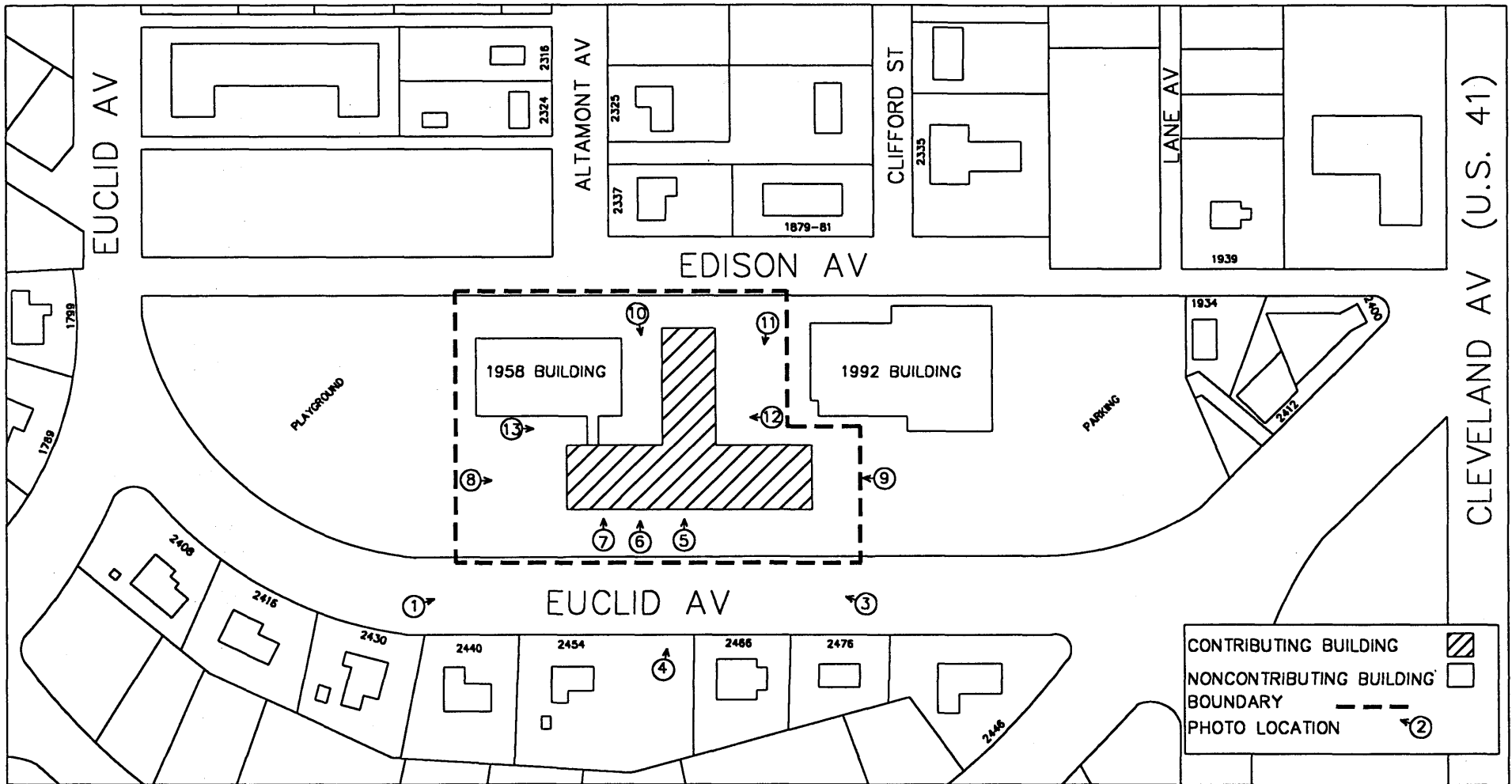
- 6. Interior, Second Floor, Looking West from East Wing

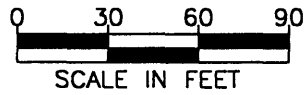

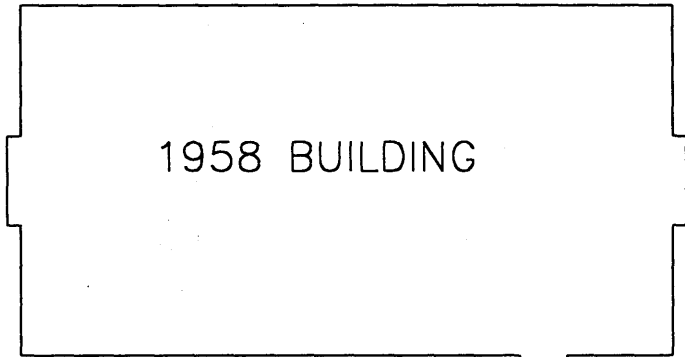


CONTRIBUTING BUILDING

PHOTO LOCATION	

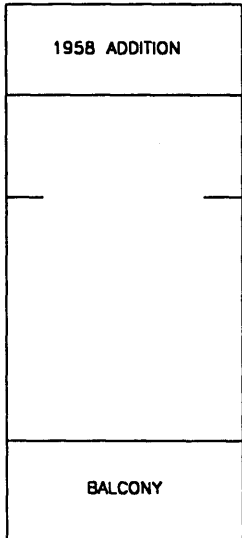
