Expansion Narrative Description

In the fall of 1997, two areas adjoining the existing College Place Historic District were surveyed with the proposal of listing in the National Register of Historic Places. This expansion to the College Place Historic District runs along two streets: West Lelia and West Mattie Lou. Both areas of the proposed expansion are contiguous with the existing boundaries, setting and landscape, with its grid street pattern, well established trees and shrubs, sidewalks, and closely spaced houses. Eleven residential resources are being added to the district: nine contributing and two noncontributing. There are seven houses and two outbuildings that contribute to the historic character of the district. Nearly all of the resources being added to the College Place Historic District were constructed from the end of the Depression to 1944, reflecting Florence's dramatic boom periods during the early decades of the twentieth century (see the Cherry Street Historic District National Register nomination for a good history of Florence's boom periods). The architectural character of the expansion area is simplistic, reflecting stylistic trends of the period. Bungalow forms still predominate with minimal decoration but Colonial Revival influences can also be seen on a couple of the houses.

- 49. 109 West Lelia Street (Fieldstone Cottage) 1939; bungalow; one- and one-half-story fieldstone house with a side-gabled asphalt roof with exposed eaves and rafter ends; two sets of concrete steps lead up to the centrally located entrance with bracketed gable stoop; 6:6 wood windows with brick sills flank the entrance with one on the eastern side and a group of two on the western side; stone chimneys on the front facade and eastern elevation. - -- outbuilding: 1955; one story, one bay, front-gabled, stone garage. (NC, due to age)

supported by a single frame stuccoed post with a low frame stuccoed wall continuing to the front steps; a pair of 3:1 wood windows are located on the recessed southern facade of the house; a single brick chimney can be found on the eastern elevation; front steps are flanked by low frame stuccoed square bases; Hubert J. House, builder. (C)

#### Archaeological Component

Although no formal archaeological survey has been made of the district expansion area, the potential for subsurface remains is good. Buried portions may contain information that may be useful in interpreting the neighborhood.

### Section VIII. Expansion Statement of Significance

#### Architect/Builder: Gargis, Cecil R., builder

Explanation of Expansion: The College Place Historic District is being expanded to incorporate eleven resources contiguous to the existing boundaries that have the same developmental history and architectural styling. The expansion is the result of additional survey work conducted in the fall of 1997 at the request of the property owners, so that they might take advantage of National Register listing. The great majority of buildings included in the expansion retain their original architectural integrity and contribute to the existing district in location, design, material, workmanship, feeling, and association. Just like the houses in the existing district, these are similarly styled and reflect a slice of life in Florence. Notable people who have lived in the houses in the expansion include Ms. Helen Chandler, a beloved and long-time educator in Florence City Schools and Mr. M.P. Curren, owner and operator of the popular Florence Bakery. Three of the seven houses in the expansion area were built by Mr. Cecil Gargis, a local contractor who was very active during the early 1940s through the mid-1950s. The small scale houses he built are structurally sound and have nice interior details.

Verbal Boundary Description: The boundaries of the expansion to the College Place Historic District are indicated on the enclosed map at 1"=200'.

Boundary Justification: The expansion boundaries were drawn to include eight homes and their outbuildings along the eastern side of Sherrod Avenue, the main street through the existing College Place Historic District, on West Lelia and West Mattie Lou Streets. The great majority of these resources contribute and are contiguous to the existing boundaries.
