8. Significance: Built in 1911, and unmodified since, this house meets Criterion C as a good example of the incorporation of rectangular plans into the New Mexico Vernacular vocabulary which occurred generally across the state after about 1910.

10. Geographical Data: Approximate Acreage: less than one. Quadrangle Name: San Lorenzo, N.M. Scale: 1: 62.500 UTM References: 13 227000 3630200 Verbal boundary: A rectangle, roughly 155' by 80', as shown in map 12 formed by lines parallel to and ten feet from the north side of the house, the east side of the eastern most shed, the south side of the southernmost shed and the west side of the southernmost shed. Since this is an unplatted area, this boundary has been created to include only the buildings.
