SUMMARY

The post office building was the beginning of a permanent home for mail service in Stuttgart. Having ten different locations prior to the 1930s, approval was given to build a permanent location for the post office in 1931. An addition was constructed in 1966, increasing the work space by 3,000 square feet. This building served the community until the summer of 2002 when a new post office was built in Stuttgart. This one story brick building with a partial basement is a good example of Neoclassical/Colonial Revival design. The building is located on the southwest corner of Maple and Third Streets, one block west of the downtown Main Street shopping area. The interior has had minor changes over the years with most being made at the time of the addition. Marble wainscoting in the foyer was installed at that time. The exterior is in excellent condition and only changed by a ramp off the south side of the entry porch in 1995 for handicap accessibility. The addition in 1966 was designed to match the existing building.

ELABORATION

The Stuttgart Post Office is a one-story, rectangular-shaped building located on the corner of Maple and Third Streets. It was built in 1931, in the Colonial Revival style, with Neoclassical influences. In 1966, two modifications were made. The first was the expansion of the rear work space by 3,000 square feet on the north façade of the building. The new space was designed by the Government Services Administration, and the contractor was ACS Construction Company of Greenwood, Mississippi. The addition was constructed to match existing brick, mortar, windows, and concrete casements. The second addition was the concrete parking lot to the south of the building.

Front/East Façade

The main floor of the building is raised with four concrete steps going up to the full height entry porch which has four limestone columns. This entry is on the east side of the building facing Maple Street. There are six wood-framed, double hung, twelve-over-twelve windows, two of which are to the left of the entry, with the remaining four to the right. They are aligned horizontally in symmetrical rows with limestone sills, keystone lintels and limestone swags above them. The cornice has limestone dentil work which goes around the entire building with pineapples featured at the corners.

Side/North Façade

The north side of the building is comprised of six wood-framed, double-hung, twelve-over-twelve windows. Each of the six windows consists of the same elements as the windows on the front façade: limestone sills, keystone lintels and limestone swags. The cornice on the north façade is the same as on the east, with the same limestone dentil work featuring pineapples at the corners. This feature continues in the same manner along the remaining two facades of the building.

Rear/West Façade

The loading dock is located at the West façade. Five concrete steps lead up to the dock, which is covered by a flat roof that is supported by five metal posts. There are two sets of double doors at the loading dock, one of which is in the center of the dock, and the other is on the left side of the dock. A third entry is located on the right side of the loading dock, and is a single door. There is a single wood-framed, double-hung, twelve-over-twelve window in the extreme left corner of this façade. The cornice on the west façade is the same as on the east, with the same limestone dentil work featuring pineapples at the corners.

Side/South Façade

On the south facade of the building there are concrete stairs leading down to the basement level with double doors for entry to that floor. There are windows and light wells on this facade. The window wells for the basement windows are formed with limestone and are the full height of the basement windows. There are six wood-framed, double-hung, twelve-over-twelve windows on the main floor of this façade, with one wood-framed, double-hung one-over-one window between the fifth and sixth windows. These six windows have the same architectural elements as the windows on the north and east facades: limestone sills, keystone lintels and limestone swags. There is another light well at the extreme left corner of this façade, as well as a pair of wood-framed, double-hung, six-over-six windows. The cornice on the south façade is the same as on the east, with the same limestone dentil work featuring pineapples at the corners.

Interior

The interior has had minor changes over the years with most being made at the time of the addition. Marble wainscoting in the foyer was installed at that time.

INTEGRITY

The Stuttgart Post Office retains good architectural integrity, and closely reflects the time of its construction in 1931. The building retains its original windows, and all of the entrances are intact. Though there is a 3,000 square foot modification that was added to the north façade of the building in 1966, the Government Services Administration and ACS Construction Company, of Greenwood, Mississippi, took special care to match existing brick, mortar, windows and concrete casements. This modification does not overpower the original building.

SUMMARY

The Stuttgart Post Office located at the southwest corner of the intersection of Maple and Third Streets in Stuttgart, Arkansas, is being nominated to the National Register of Historic Places under **Criterion C** with **local significance** for its good Neoclassical/Colonial Revival style architecture and **Criterion A** for its association with the development of postal services in Stuttgart.

ELABORATION

In 1813 Arkansas County was created. It contained over ¾ of the present state. In 1821 other counties were taken out of this county and counties would continue to be formed out of Arkansas County for approximately forty years. In 1862 the State Legislature and General Assembly passed an Ordinance for the benefit of Arkansas County which prohibited any more counties being formed from this county without the vote of the people of Arkansas County. By 1889 the current boundaries of the county were established.

In October 1878, the Reverend Adam Buerkle and twelve families of German immigrants founded a settlement at the former Gum Pond Plantation on the Grand Prairie in Arkansas County. The next year the small colony was joined by sixteen additional families and in 1880, Adam Buerkle petitioned for a post office named Stuttgart, after Buerkle's old home in Germany. The county's first post office was established in the Buerkle home in 1880. The Stuttgart Post Office moved about ten times before approval to build this building came in 1931. Congressman D. D. Glover was credited with getting the bill through Congress to build the new Post Office building in 1931.

The current building was started in 1931 with the General Services Administration's James A. Wetmore serving as Acting Supervising Architect, and J.A. Auges as General Contractor. The building was dedicated the following year, in 1932. Carl Denslow was postmaster at that time. The Stuttgart Post Office received a first class rating in 1944. The advancement in class is determined by the amount of revenue taken in by a post office. The Stuttgart Post Office started out servicing 15 families and in 1970 made 4,512 family deliveries, (city and rural), and 373 business deliveries. The original building was reported to have cost around \$60,000.

In 1966, 3,000 square feet of additional work space was added to the north side of the building. The remodeling project was reported to cost \$144,957. This was again handled by the Government Services Administration and the contractor was ACS Construction Company of Greenwood, Mississippi. The addition matched existing brick, mortar, windows and concrete casements. A new parking lot was also built on the south side of the building. In 1995 a new ramp was added onto the south side of the front entry porch to make the building handicapped accessible.

In the fall of 2002 the Stuttgart Post Office was relocated to a new building on Michigan Avenue. This ended more than 70 years of service to the public from its location on Maple and Third streets. In December, 2002, the City of Stuttgart purchased the building from the Postal Service and is in the process of converting the building into an administration building for the city.

STATEMENT OF SIGNIFICANCE

The Stuttgart Post Office located at the southwest corner of the intersection of Maple and Third Streets in Stuttgart, Arkansas, is being nominated to the National Register of Historic Places under **Criterion C** with **local significance** for its good Neoclassical/Colonial Revival style architecture and **Criterion A** for its association with the development of postal services in Stuttgart.

VERBAL BOUNDARY DESCRIPTION

Beginning at the northeast corner of Block 5 of Porter's Addition to the City of Stuttgart, running thence South along the West line of Maple Street, One Hundred Seventy (170) feet; thence running West One Hundred Fifty (150) feet; thence running North One Hundred Seventy (170) feet to the South line of Third Street; running thence East along the South line of Third Street One Hundred Fifty (150) feet to the point of beginning, same being a parcel of ground fronting 170 feet on Maple Street and fronting 150 feet on Third Street, lying in the County of Arkansas and State of Arkansas.

BOUNDARY JUSTIFICATION

The boundary contains the land that is historically associated with the Stuttgart Post Office.


