#### **Summary Paragraph**

Milestone 7 is the first of a series of 23 historic granite wayfinding markers positioned at roughly one mile intervals along the route of the old Main Road in Southold Town. These markers were set by the Town of Southold (Suffolk County, NY) in 1829 to mark the distances in miles from the Suffolk County Hall/Courthouse in nearby Riverhead. The stone is located in Laurel, a hamlet that borders Riverhead Town to the west, and is now situated on a short stretch of the "old" road (Franklinville Road) that resulted from the straightening and widening of the original Main Road. The milestone is set on the south side of the road, partially obscured behind a split rail fence but within the right-of-way of this town-owned roadway. It faces north toward the roadway, its carved inscription meant to inform passersby of the distance from the county center. A private property (not included in the boundary of this nomination) that preserves an 18<sup>th</sup> century wood frame dwelling and a post-and-beam barn is situated directly behind (south) of the milestone. The marker is set within the right-of-way of Franklinville Road, a town-owned roadway.

#### **Narrative Description**

The milestone is carved from granite and measures approximately five feet in length overall, with its inscribed upper portion set approximately two feet above grade and its lower, three-foot section anchored below ground level. The visible portion of the stone bears the inscription "7M/to Suffolk/C(ourt) H(ouse)," which signified the distance of the marker from the Courthouse or County Hall, then located at the Suffolk County center in Riverhead (building is no longer standing). The surface of the upper section is carefully tooled and measures 12" wide by 6" thick. The carved lettering is chiseled approximately ½" into the face of the stone; although weathered, it is clearly decipherable. Traces of white paint may be observed on the surface of the stone (application date unknown). The stone also preserves the evidence of having been struck, perhaps by passing vehicles, resulting in edge chips along its west-facing side.

**Statement of Significance Summary Paragraph** (Provide a summary paragraph that includes level of significance, applicable criteria, justification for the period of significance, and any applicable criteria considerations.)

Milestone 7 is significant under Criterion A in the areas of settlement and transportation as one of a series of stone wayfinding markers installed in 1829 by Southold Town along its Main Road (formerly "King's Highway"), and measuring distances in miles to and from the Suffolk County center at Riverhead. Along with the accompanying series of 23 historic wayfinding markers in Southold Town, Milestone 7 is a rare surviving object from the Republic's early history of road-building. All but one of the original series of 24 stones survive that stretch the length of the town from Laurel (west) to Orient Point (east), of which Milestone 7 is numerically the first. Together with the additional markers in the series, it defines the route of the original roadway along which travelers passed by foot, horse or horse-drawn conveyances in the early 19<sup>th</sup> century. Its installation in 1829 was dictated by New York State law, which reflected a nationwide mandate to mark the wider, public highways which served as postal routes and as primary corridors between major population centers. The significance of Milestone 7 as an early 19<sup>th</sup> century wayfinding marker reflects the growth of the country in that period and the recognition that roadways had begun to replace inland and coastal waterways as a means of facilitating internal transportation, commerce and exploration.

**Narrative Statement of Significance** (Provide at least **one** paragraph for each area of significance.)

Milestone 7 is located in the hamlet of Laurel. This rural area, known as the "Middle District" for its location at the boundary between Riverhead and Southold, developed into the hamlet of Franklinville during the nineteenth century; the hamlet was renamed Laurel when residents seeking a post office discovered that another "Franklinville" already existed in New York State. During the mid-twentieth century, the road was straightened and this stretch of Main Road was bypassed.

Milestone 7, which was placed seven miles from the Suffolk County court house or county hall in Riverhead, is coincidentally set near the boundary between Southold and Riverhead Towns. Its placement on the south side of the road, with its inscription facing north toward passersby, fulfilled a New York State Session Law passed in 1827 mandating that municipalities install such markers to inform travelers of the distances between their destinations, and the progress they had made along the way.

Milestone 7 meets the following registration requirements:

The stone is one of 23 such markers set at approximately one-mile intervals along the original Main Road, which now includes sections of Franklinville Road (town), Route 48 (county) and Route 25 (state) as a result of road straightening in the 20<sup>th</sup> century.

The stone is carved from granite and measures 27" high by 12" wide and 6" thick above grade, with a lower section firmly anchored below grade. It retains a high level of integrity, and preserves carved lettering and numbering that is site-specific to its distance from the 19<sup>th</sup> century county center in nearby Riverhead. Its physical integrity is determined by the extent to which its above-grade section retains sufficient mass and carving to identify it as one of a series of such historic markers.

Finally, Milestone 7 preserves the integrity of its location as a wayfinding marker set within the right-of-way of the historic Town roadway. Its placement at the edge of Franklinville Road, within eyesight of passersby, retains its association with this remnant of the old Main Road, which has since been straightened. Milestone 7 remains a highly visible feature of this section of the road.


