Description

The Plainview Carnegie Library is located on the edge of the downtown business district of Plainview (1992 population: 1483), a town situated in the northwest part of Pierce County, Nebraska. The building faces east and is located on Highway 20, one block north of Locust Street, the town's main thoroughfare. The library, dedicated on April 5, 1917, is one of forty-six Carnegie libraries constructed in Nebraska during the last phase of the Carnegie Library "Wholesale" period, and conforms to the building plan prototype established by Carnegie. The one-story building is rectangular shaped with a raised basement, and is designed for efficiency. The original exterior configuration and detailing of the building remains intact; the building retains a high degree of historic integrity.

Constructed in 1916-17, the Plainview Carnegie Library is a one-story with raised basement brick building, measuring 30' x 42', with a hipped roof showing wide eaves and modillions. The building incorporates Prairie style detailing in its design, and displays a Neo-Classical Revival frontispiece. Fenestration consists of double hung window units. Concrete steps leading up to the entrance landing are flanked by brick banisters with concrete copings. Entry features consist of a new glass door unit with book drop and original multi-paned transom. The word "Library" is inscribed in a concrete header above the entrance. An additional entry is located on the south facade. The library's architectural design is enhanced by the use of dark colored brick in the basement level, and accenting window and door openings, quoining, and cornice and water table areas. A concrete and brick raised platform to the rear of the library encloses an old cistern. The cornerstone in the northeast corner reads "Carnegie 1916."

The interior of the library's main floor includes a foyer with steps leading to the main library room and the basement. The library features 12' ceilings, the original oak floors and woodwork, and plastered walls. Bookshelves extend along the outside walls and are strategically located throughout the room. The librarian's desk is in the southwest corner of the room, and a small alcove opens to the west. The lower level contains a restroom, Chamber of Commerce office, furnace room, and a children's reading room, completed in 1977. Today, the building continues to function as a library.

Statement of Significance

The Plainview Carnegie Library meets the registration requirements of the National Register of Historic Places Multiple Property Documentation Form, "Carnegie Libraries in Nebraska, 1899 to 1922," and is significantly associated with the historic context "Educational Enrichment, Carnegie Libraries." The property is locally significant in the area of public education (Criterion A) as an important example of the property type "Carnegie Libraries in Nebraska." The period of significance is derived from the year its operation began (1917).

On January 11, 1908 a library room was established in a building on the Frost Block in Plainview. A Library Board was also formed. Officers and a Book Selection Committee were elected. A library ordinance was passed on February 22, 1908 and the library board met with the school board for the purpose of securing the school library. One hundred twelve volumes from the school were given to the public library in the form of a loan.

On August 25, 1914 a letter from the State Librarian was read to the Library Board regarding a Carnegie sponsored library. Authorization was made to explore the possibility of a Carnegie Library in

Statement of Significance (continned)

Plainview. A postcard picture of a Carnegie library was received and examined by the Library Board on April 19, 1915.

A vote was taken to make application for \$6,000 for a Carnegie library on October 15, 1915. The application was sent to James Bertram, secretary of funds. To obtain a Carnegie gift the City Council had to pledge that the city would maintain and support the library by one-tenth of the amount requested and to obtain a suitable site. Thus, a committee was also appointed to secure a building site. Two lots were purchased from H.L. Buckingham for \$2,000 on January 21, 1916, consisting of a site 84' x 140'. The Community Club donated \$344.81 for the purchase of the lot. Miss Charlotte Templeton, Secretary of State Library Commission, came to Plainview on January 27 to offer suggestions on heating and lighting in the new library.

Architect J.C. Stitt of Norfolk, Nebraska drew up plans for the library building, and Frank T. Houx of Sioux City, Iowa served as the contractor. Construction on the library began in October of 1916. The building dimensions, floor plan, and materials conformed to the standards of the Carnegie Foundation's library program. The library moved into its new building on March 14, 1917. Dedication was held on April 5, 1917 at the Plainview Opera House. The front page of the April 12, 1917 issue of **The Plainview News** read: "The dedicatory services of the Plainview public library were held in the Plainview opera house on last Friday evening, and a large and appreciate audience was present....After the program the people were received at the new library building by the committee which had been in charge of the construction work....Many remarks were made in a complimentary way of this excellent new library building, and when the News says we are "proud of it" we voice the true sentiment of all our people." The cost of the library was approximately \$8,000 of which \$6,000 was provided by Carnegie.

Kindergarten classes were held at the library in 1920, paying rental of \$35.00 per month. It was also used as a polling place beginning in early years. The books were catalogued according to the Dewey Decimal System in 1939. A children's room was opened in the basement in September, 1977. Previously, the room had been used for caucuses and other public meetings.
