

SUMMARY

The Willie Lamb Post 26 American Legion Hut is a brick masonry building located one block west of the commercial area in the small town of Lepanto in Poinsett County. The building sits atop a continuous brick foundation and is sheltered by a composition shingle covered side-gable roof. The original six-over-six double-hung windows remain intact, but have been covered with plywood. In the early 1980s three dormers and a roof-line balustrade were removed from the building's roof. The changes that have occurred to the building are not major enough to heavily detract from the building, especially when considering its role and the organization's role in the community. The Legionnaires plan to raise funds to restore the windows and doors. They also hope to eventually recreate the dormers and roof balustrade using historic photographs to assure accuracy. It is hoped that being nominated to the National Register of Historic Places will increase awareness and help them raise funds to return the building to its original glory.

ELABORATION

Constructed in late 1937 and early 1938, the Willie Lamb Post 26 American Legion Hut is a brick masonry building located in the small town of Lepanto in Poinsett County. The building is designed in a simplified Neoclassical style with a full front porch supported by six square Doric columns. The building sits atop a continuous brick foundation and is sheltered by a composition shingle covered side-gable roof. Although the majority of the building is brick, the gable ends are sheathed in white clapboards. The building also features a large brick chimney that is centrally located along the north exterior wall of the building. The original six-over-six double-hung windows remain intact, but have been covered with plywood. In the early 1980s three dormers and a roof-line balustrade were removed from the building's roof. The building still retains enough historic fabric and appearance to convey its historic feel and function.

West Elevation

The front of the building faces west and is sheltered by a full front porch. The porch is topped with a shed roof and supported by six square columns. Entry to the building is through a pair of centrally located double doors. The original French doors have been replaced with more secure metal doors. The entryway is flanked on each side by four windows resting atop concrete sills. The original double-hung windows remain intact, but have been covered with plywood. The Legionnaires plan on restoring the windows and removing the plywood.

South Elevation

A side entrance is centrally located beneath the building's south facing gable. The entryway is sheltered by an awning style porch topped by a gable roof. The double doors have been replaced by a large air conditioning unit that was installed in the 1960s. The entryway is flanked on each side by a single double-hung window. These windows are also intact, but have been covered with plywood.

East Elevation

The back of the building faces east. The elevation is made up in part by the main body of the building. However, the majority is comprised of a gable-roofed rear projection. As with the rest of the building, all original double-hung windows remain intact but have been covered with plywood. Single window openings fenestrate the main portion of the building to the north and south of the rear projection. The back projection is fenestrated by three windows followed by a two-window ribbon. A back entrance to the building is also located north of the ribbon of windows. The final fenestration found on the rear elevation is a ribbon of two windows located on the north facing wall of the projection.

North Elevation

The focal point of the north side of the building is a large brick chimney located on the building's exterior. Single windows flank both sides of the chimney, but have been covered with plywood.

SUMMARY

The Willie Lamb Post 26 American Legion Hut is eligible for listing in the National Register of Historic Places under **Criterion A** with **local significance** for its association with the local activities of the American Legion in Lepanto. From housing flood refugees to hosting the annual "Terrapin Derby", the Post has performed many important roles for the community over the years. The Willie Lamb Post 26 American Legion Hut is a long standing reminder of the group's positive influence and contribution to the small town of Lepanto, Arkansas.

ELABORATION

History of the American Legion

The American Legion was founded in France during the relatively uneventful days that followed the signing of the armistice that ended World War I. American enlisted men from all three of the principle branches of the service then in existence- the Army, Navy and Marine Corps were billeted in various locations for the purpose of maintaining a military presence while negotiators worked out the details of the treaty that would outline the future for much of Europe for the next decade. These servicemen found life during the occupation uneventful, which only added to their dismay at not being able to return home to their families. A small group of officers, Lt. Colonel Theodore Roosevelt Jr. and Lt. Colonel George A. White, met to discuss the possibility of establishing a veterans' organization that would include all branches of the military. The organization would serve the immediate purpose of providing an outlet for some of the energy and frustration felt by the troops still in Europe, and fulfill a long term goal of establishing a national veterans' organization that would provide its members with a social organization and also as a vehicle to voice their concerns on national defense, social programs and veterans' affairs.

Successive meetings over the course of the next several months in both Europe and America further defined the Legion's mandate and purpose. However, it was the shooting of four Legionnaires during an Armistice Day parade in Centralia, Washington, in 1919 by Socialists IWW organizers and the trial that followed that both galvanized and tempered the Legionnaire spirit. In the trial they were portrayed as the aggressors; however, both the public and the Legion press recognized the dangers of extremism by any party. They also recognized the need for responsible vigilance against any activity that threatened the democratic form of government. The American Legion began to grow steadily thereafter through an organization of elected officers on the national, state and local level that provided a voice for its members regarding a variety of national concerns. During the Depression the American Legion distinguished itself through the expansion of local programs targeted at youth. Three main programs were American Legion Junior Baseball, the American Legion Oratorical Contest and Boys' State.

Willie Lamb Post # 26

The Lepanto American Legion post was organized in 1928 and was officially chartered in 1929. The Post was named for Willie Lamb, a local resident who had been killed in World War I. The Legion originally met in the Marcom Warehouse. They then rented the J.E. Murphy Warehouse. While renting the Murphy

Warehouse, the Legionnaires would stage boxing bouts and wrestling matches to raise money for their own hut. Finally enough money was raised to purchase a building that had formerly been used as a pool hall. The building burned in 1932 and the Legion once again had to look for a different meeting place.

The Legionnaires decided to take advantage of a newly organized "New Deal" program, the Civil Works Administration. They applied for funding from the C.W.A. in late 1932 or early 1933 and were awarded funding to construct a new Legion Hut. To meet C.W.A. requirements, the American Legion conveyed ownership of the parcel of land to the city of Lepanto for the amount of one dollar. In return the city gave the American Legion a 99 year lease on the property. Construction on a new hut was begun in 1933 and finished in 1934. Unfortunately the building would be short lived. In 1937 the hut was used to house refugees when a flood occurred in the area. The building sustained some damage while housing the refugees and required major clean up and repairs. During the repair phase the building caught fire and burned to the ground. Once again the Legion was without a home.

It was decided that a new building be constructed to replace the burned structure. Construction began on the building in late 1937 and was finished in early 1938. The Colonial Revival style, brick building was completed at a cost of \$8,000. On March 4, 1938, the Lepanto News Record announced: "The new American Legion Hut, home of the Willie Lamb Post No. 26 and Willie Lamb Unit No. 26 of the American Legion Auxiliary of Lepanto will be opened to the public for the first time next Wednesday."

During the open house gifts ranging from kitchen utensils to \$75 in cash were all donated to the Legion from local townspeople. The News Record reported: "The hut, visitors exclaim from far and near, is the most attractive in the state."

The official dedication of the building took place on March 31, 1938. In attendance were State Commander W.R. Sisson and District Commander Dr. L.H. McDaniel. The dedication speeches covered topics from Americanism to ongoing German military actions in Europe. Among the more than 300 people who attended the dedication was Mrs. Katie Lamb, Gold-Star Mother of the Post. The Post was named after her son Willie, who had died during fighting in World War I.

Events from dances to fund raisers have been held in the building during its time of service. Today it is still frequently used and is the host facility for the annual Terrapin Derby. The Legionnaires of Willie Lamb Post 26 are still active in the community and hope to preserve this building for the next generation of both veterans and citizens of Lepanto.


