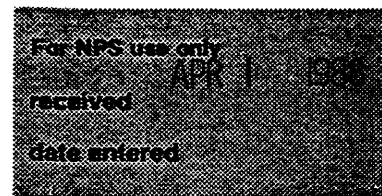

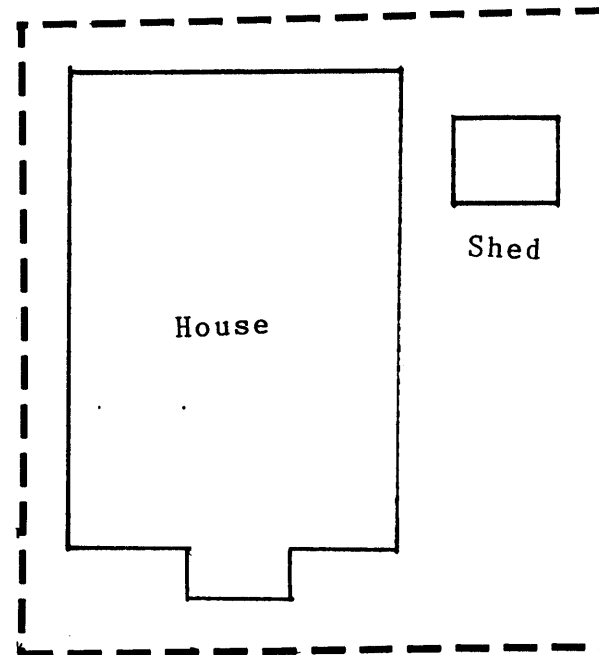
1. Name: Antonio Torres House, survey number 84
2. Location: approximately 200' north of Highway 90 immediately west of Mimbres River bridge
4. Owner: Antonio Torres, 1310 E. Belmont Ave., Anaheim, Ca. 92805
7. Description: Photo 46; map 10; stone rubble foundation; stuccoed adobe; corrugated metal hipped roof with gabled entrance porch; 6/6 double hung windows; single door. A contemporaneous wooden shed stands to the side of the house.
8. Significance: Built about 1930 by Antonio Torres and his wife Josefina Ancheta, a descendent of N.Y. Ancheta. They operated the Black Range station, half a mile east on Highway 90, for thirty years starting in the late 1920s. Although the house uses the locally typical adobe and corrugated roofing it has a rectangular plan and facade symmetry derived from turn-of-the-century Classicism which gave rise to a modest type in New Mexico which the Building Inventory Manual calls the Hipped Box. The house meets Criterion C as a good example of this historic building type.
10. Geographical Data: Approximate Acreage: less than one.

Verbal boundary: A rectangle, roughly 40' by 50', as shown in map 10, formed by lines parallel to and ten feet from the north, south and west sides of the house and the east side of the shed. Since this is an unplatted area, this boundary has been created to include only the house and shed.
