The Mann School #2 is located three and 1/2 miles northwest of Preparation Canyon State Park, west of the town of Moorhead. The area is geologically part of the Loess Hills. Erosion created long, winding narrow valleys or hollows that end in the Little Sioux River Valley. The school is located in a hollow near a creek that flows to the Little Sioux.

The original 1884 building is the standard rectangular structure. In the 1920's an addition was added to the east end to provide a cloakroom and internal stairway to the basement where a furnace was placed. For a time the basement was also used as an additional classroom. The foundation has a base of heavy clay over which cement blocks have been laid. The school has a traditional gable roof with a bank of 4 windows on the north and south sides of the building. There is weatherboard siding. The windows are 4 over 4 double hung evenly spaced on the original building with one window on the extension. The roof has weathered cedar shingles.

The interior has only a few educational furnishings. There is a slate blackboard at the west end and a few student desks. There is a cupboard for storage in the southeast corner. The building has been used for small farm equipment storage in recent years. The walls and ceiling are plaster and lath and there is wainscoting on the walls. There is a single door that leads into the cloakroom and an internal stairway to the basement and also an outside entrance.

The site originally was approximately one acre. However, after the school was closed in 1945, farmland encroached on the grounds so presently there is about 1/3-acre remaining.

Statement of Significance

The Mann School is locally significant under Criterion A in Education and Social History as a reminder of early educational practice and community involvement, and Criteria C Architecture as a good intact representative example of country school design with its rectangular form, simple exterior, window alignment and single classroom and the gabled roof. The exterior of the building remains today as it was when it was closed in 1945 with the exception of some damage on the southeast corner and on the roof. The interior has not been altered substantially but there is no equipment or educational material remaining in the building.

Unlike schools on the prairie that were located at the center of the four sections, schools in the Loess hills area were near the center of clusters of families. Historically the region was home to small farms that had a few dairy cows, raised some livestock and grew corn for sale and corn, oats and alfalfa for feed. It was said it took 20 acres to raise a single cow in the Loess Hills. The Richard Mann family was the first to move to the area in 1867, living first in a cave before establishing a homestead. In the years that followed, Danes primarily settled the area. Earlier, the nearby town of Preparation had been settled by Mormons and the first school in the region, a subscription or fee school, was formed in 1854. Public education followed the settlement of the hill area after 1870 and the Mann School was formed in 1884. It served the community until 1945 when it closed after the teacher unexpectedly left. By this time the class roll was under the minimum ten students. The district sent the students to a neighboring rural school for the balance of the year and to Moorhead school thereafter. The school was formally closed in 1945.

The Danes, like all other immigrant groups, were anxious to provide their children with an education that would allow them to integrate themselves into American society. The establishment of a school in this

relatively poor region is a testament to that fact. The area was not short on students, however. In the early 1900's fourteen families living in the valley sent children to the school and an average term would have over 20 students. The winter term meant having a male teacher whose primary concern was discipline rather than academics. The cost of operating this school a year was \$270 for salary, \$105 for supplies and repairs and miscellaneous expenses like \$2 to have the well cleaned. Sometimes additional expenses like the library law were resisted, not because of the intent, but the cost. The economic hard times of the 1930's reduced the number of families in the district and by 1945 there was a recognition that the school could not survive, regardless of its importance to the community. The school was used as a polling place for many years.

Parental support was evident in Mann School. They met at the beginning of the term to clean the building, "blacken" the potbelly stove and put linseed oil on the floor. They contributed blankets and clothes for the Christmas program in which every child had a "piece" or public presentation. And they sent their dimes to buy the teacher a gift. The mothers who made certain no one went hungry on the last day of classes catered the end of school picnic, held in nearby Fredrickson Canyon. During the summer, parents cooperated in keeping the grass and weeds cut on the grounds and often had potluck suppers on the grounds.

Although the location pattern was somewhat different from the rest of the state, Mann School exhibits characteristics similar to other country schools: the rectangular form, simple exterior, window alignment and single classroom and the gabled roof. It is distinctly recognizable as a school even in its present condition.


