#### DESCRIPTION SUMMARY

The Atlantic High School was constructed in 1937, and designed by the Des Moines, Iowa architectural firm of Keffer & Jones in the Moderne style. There have been no additions to the U-shaped school, but a separate junior high building was constructed in 1965, east of the original school, and is counted as a non-contributing building to this nomination. A combined football stadium/track is set in a natural depression to the southeast of the school buildings, and is counted as a contributing structure to this nomination.

#### GENERAL DESCRIPTION

The Atlantic High School is located on a gentle north-facing slope on the south side of Atlantic, Iowa. A separate junior high building, constructed in 1965, is to the east, and connected with a concourse. A two-block area in front of the school is maintained as open space. There are sidewalks and a footbridge for pedestrian students. The stadium housing the track and football field is set in a natural depression to the southeast of the main building. Athletic fields, including a baseball diamond, are located at the foot of the hill to the southwest. At the time of construction the school was on the south edge of town. It is now situated between the older residential neighborhoods to the north, east, and west, and the modern suburbs to the south. A new high school was constructed about one-half mile to the southeast in 1997, and the original building became a middle school, and the junior high building an elementary school. Together with Washington Elementary, also located south of the 1937 school, the three buildings and athletic complexes comprise a large educational campus. Because Washington was not constructed during the period of significance for the high school, it is not included within the National Register boundary.

The U-shaped school is composed of the three-story classroom central block, the tall, one-story gymnasium wing, and the two-story junior high and auditorium wing. The school was designed by Des Moines architects Keffer & Jones in the Moderne style. It is of steel-reinforced concrete and load-bearing brick construction. Above ground, it is finished with light brown brick in common bond. The Atlantic High School is accented with limestone, including belt-courses and coping, and the entrance facades. While the fenestration and window openings have been retained, most of the windows have been replaced with single fixed or casement windows, all of which are surmounted with a metal panel. The windows have continuous sills and lintels of limestone.

The symmetrical north-facing front facade of the classroom wing of the Atlantic High School is composed of the center classroom section flanked by projecting entrances. The entrance on the right side of the building is the main entrance, with the name of the school inscribed in stone, and more elaborate entry decoration. The right entrance projection is composed of three doors, with a stone surround. Above the doors are vertical panels that lead the eye upwards, where three sets of chevrons connect to the roof coping. To the right of the entrance is a stone plaque, set under a stylized chevron, inscribed with "Atlantic High School." Between the entrances are groups of four windows on each story, separated by brick pilasters.

The south facade of the school forms the U-shape, and is composed of the auditorium and gymnasium entrances. The gymnasium entrance is on the right, and is composed of three sets of double doors, separated by brick pilasters, with second story windows above that open into the gymnasium balcony. The pilasters are capped with stone, and there is a horizontal brick false front, surmounted by the gable roof of the gymnasium.

The auditorium entrance is of a similar style. There are three sets of double doors, separated by brick pilasters, and second story windows. The exterior walls of the stairwells project beyond the entrance and are finished with stone copings. To the left of the auditorium is the entrance into the original junior high classroom area. There is an open space between the two wings, planted with mature trees, and with benches flanking the sidewalk into the entrance.

The interior arrangement consists of the classroom block, with a center hall, and a perpendicular extension that contains the three original junior high classrooms. The unadorned halls have terrazzo floors, plaster walls with a chair rail above the lockers. The classrooms have hardwood floors, plaster walls, replacement windows and tile ceilings. The gymnasium has exposed arched roof trusses, hardwood floor, and a balcony on the south end.

The auditorium is the only interior space with any decorative detail. The auditorium foyer and lobby are paneled in marble, with iron grills over the radiators. The ticket booth is decorated with geometric details. The interior of the auditorium is decorated with the same chevron design that is on the main entry facade.

The track and football stadium was also constructed in 1937, and was considered to be the "finest football field around" (Chinitz 1987: 1). The football field is on the lowest level, with seating for the football teams on the long sides. The track surrounds the field and is situated about twenty feet higher than the football field. Enclosed bleachers for spectators are on both sides of the stadium, and set above the track. A small building housing the concession stand is connected to the west bleachers.

#### SIGNIFICANCE SUMMARY

The school is locally significant under Criterion A, as an example of a PWA school, and is also locally significant under Criterion C, as an excellent example of the Moderne style. Evaluation of the Atlantic High School for National Register eligibility is based upon criteria outlined in the Multiple Property Documentation Form *Public Schools for Iowa: Growth and Change, 1848-1966*, under the property type "High School." It is typical of the modern high school in its design, layout, and use of specialized rooms. Funding from the Public Works Administration helped many communities to construct public buildings during the Depression. The school has retained its integrity of location, design, setting, materials, workmanship, feeling and association.

#### RESOURCE HISTORY AND HISTORIC CONTEXT

The Atlantic High School was the second high school building in the town. The first high school was constructed in 1878, and a large addition was constructed in 1912. Population growth and the need for modern facilities necessitated the construction of a new high school. In July of 1935 the school board resolved to apply for a PWA grant. There was a successful campaign for the new high school; in November a \$160,000 bond issue was approved. Ground was broken in 1936, and the school was finished in May of 1937, opening in the fall of that year. It was considered a "show place" with a modern gymnasium that seated 1150, and an auditorium with a seating capacity of nine hundred. There was also a normal training room, and specialized classrooms for music, manual training, with separate rooms for cooking and sewing. In addition the third floor housed three science rooms: physics, chemistry, and biology and agriculture. The cafeteria and kitchen were in the basement, next to the Home Economics rooms. The school opened with approximately 500 high school students and 200 junior high students.

During the 1960s growing high school enrollment necessitated a separate junior high, which opened in 1965. Until then, there had been few changes in the high school building. In 1965, the cafeteria became the Home Economics room, and the old cooking and sewing rooms were used for band. Vocal music was also moved to the basement, and the music room became the principal's office. The side balconies in the gymnasium were closed off. In the 1990s, despite declining enrollment, a new high school was constructed with more modern technological facilities, and the former high school became the Atlantic Middle School. The older elementary schools were closed, and the junior high building became Schuler Elementary. Now, the two elementary schools, Schuler and Washington are on the same campus as the middle school.
