The Watkins House (c. 1903) is a large two-story brick home with a one-story section at the rear. Stylistically, the home combines elements of the Queen Anne and Colonial Revival. It stands on a large corner lot in a residential neighborhood within the Webster Parish seat of Minden. Although the house has received some alterations since construction, it remains eligible for National Register listing.

The Watkins House illustrates the turn-of-the-century tendency of architects and builders to combine elements of different styles. Characteristics of the Queen Anne found in the building include an asymmetrical footprint incorporating two projecting bays, a circular turret (interestingly enough, constructed without the usual conical shaped roof), and textured surfaces on the home's brick walls. These surfaces include several brick belt courses and panels of protruding bricks located on the home's front facing bay. Elements of the Colonial Revival style seen in the Watkins House include:

- 1) a portico with colossal Tuscan columns, a pediment with a raking cornice, an entablature with a modillion cornice, and an oculus,
- 2) additional gables treated as pediments with raking modillion cornices and oculi filled by leaded glass,
- 3) the extension of the portico's entablature and modillion cornice to encircle the house,
- 4) a two-story side porch featuring colossal columns and a Colonial Revival balustrade on the second level, as well as an additional balcony and porch balustrades in the Colonial Revival style on the facade, and
- 5) a front door and Colonial Revival mantel articulated in the manner of the Adam style.

In addition to its Queen Anne and Colonial Revival motifs, the Watkins House exhibits a number of other period architectural details. These include:

1) segmentally arched windows and doors suggestive of the Italianate style.

- 2) two elaborate heavily sculpted mantels with overmantels which present an overall Jacobean flavor. In addition, one of the mantels has an impressive bas relief design incorporated into its surround.
- 3) two sets of pocket doors.
- 4) a winder stair featuring paneling on its lower levels and a beaded board wainscot at higher levels.
- 5) unusual pinnacle-like elements rising from molded baseboards at each corner of every room on both floors.

The house is entered through a large entrance/stair hall which extends into the turret's first floor. From the back of this room a very narrow hallway extends to the rear, one story portion of the home. This hall was apparently used as an office by the home's original owner, for it is outfitted with built-in bookcases. A bedroom is located behind the entrance hall and staircase, while a parlor and dining room are found on the opposite side of the entrance hall and narrow hall/office. The rear one story portion contains a den (behind the dining room) and a closet and bath attached to the bedroom. A kitchen projects toward the rear from the den. The second floor contains a hallway/stair landing, a small turret room, three bedrooms, an early twentieth century sleeping porch (see below), and a bath. In addition, the house has a partial basement--a space which is slightly unusual for Louisiana.

The following alterations have occurred to the Watkins House since its c. 1903 construction:

1) the glazing of the second level of the two-story side porch to create the above mentioned sleeping porch, and the enclosure of a former small first floor porch located near the northeast rear corner of the home. In addition, it appears that either an additional porch on the east side of the rear one-story section was enclosed during the 1920s or a small addition was made to the house in that location.

- 2) several losses of historic material, including:
 - a) a mid-level balcony and rooftop balustrade which originally distinguished the turret,
 - b) part of the front porch balustrade,
 - c) at least two chimneys,
 - d) the removal of a small rear porch and the accompanying closure of a window opening onto it. A smaller casement window was installed nearby.
 - e) the replacement of one original tile firebox surround and hearth with marble,
 - f) the possible removal of two upstairs fireplaces, and
 - g) the loss of the leaded glass within two of the oculi. One remains empty; the other has been filled with a cast iron ornament in a snowflake pattern.
- 3) the addition of several modern features, including a 1970s-era beamed ceiling and stone chimney in one rear room, a louvered door covering the home's Adam-like main entrance door, a carport attached to one side of the historic house, and a garage connected to a corner of the home. The latter was later converted into a room.

Although several of the above histed alterations are regrettable, the house retains almost all of its original character defining elements. Furthermore, the features which make the Watkins House architecturally significant remain. Only the loss of the turret's balcony and rooftop balustrade have any impact on this significance, and this impact is minimal. The feature is still clearly identifiable as a Queen Anne Revival style turret--an element which is rare within Minden and the rest of North-Central Louisiana. In addition, the unusual textured treatment of the exterior walls survives intact, as do the portico and other Colonial Revival style features upon which the building's significance is also based. As a landmark in the late nineteenth-early twentieth century residential heritage of Webster Parish, the Watkins House is an outstanding candidate for National Register listing.

The Watkins House is locally significant in the area of architecture as a landmark in the late nineteenth-early twentieth century residential heritage of Webster Parish. Its distinction within this context rests principally upon its status as an important example of the Colonial Revival influence. The house is also significant within North-Central Louisiana as a rare turreted example of the Queen Anne Revival style.

Colonial Revival

The comprehensive parish-wide Standing Structures Survey has recorded some 432 buildings in Webster Parish which are over 50 years old. The vast majority of these date from the late nineteenth or early twentieth centuries. Most are unstyled. Among the styled buildings the bungalow influence predominates, with mostly low-key examples. Finer or more elaborately styled buildings tend to follow the Queen Anne Revival or Colonial Revival traditions. The parish contains a total of 23 examples of the Colonial Revival influence. The Watkins House is conspicuous among this group because it is one of only five examples in the parish which feature colossal columns and one of only two to feature a pedimented portico. The house derives additional grandeur and importance from its encircling entablature with modillion cornice and additional pedimented gables featuring raking cornices and oculi.

Queen Anne Revival

The parishes of Lincoln, Union, Claiborne, Webster, Bienville, Jackson and Ouachita comprise the region known as North-Central Louisiana. This distinctive area, sometimes known as the "Hill Parishes," was mainly characterized by the Upland South culture. During the late nineteenth and early twentieth centuries the Queen Anne Revival was a decidedly urban influence in the region. But the 200-300 examples found there today are fairly humble. Most are cottages with a two or three bay gallery across half the front and perhaps a single projecting polygonal bay under a gable.

The Watkins House is important within this group because of its impressively textured surfaces and, more importantly, because it is one of only about six residences in the region to feature a turret. Generally speaking, it is the use of a turret which distinguishes the grand Queen Anne houses from the lesser examples. A turret contributes much to the elaborateness of a house's massing, something which is very much a part of the Queen Anne Revival aesthetic. Secondly, because a turret contributes very little extra floor space at considerable extra cost, it is certainly a huxury item.
