#### Describe the present and original (if known) physical appearance

Built in 1901 the Lohr House is a large, rectangular-shaped structure, which has the floor plan of a modified, side-passage house. The two-and-one-half story, frame house rested on a stone foundation; the present owners rebuilt the basement with cement block and will reface the exterior wall with the original, rough, field stone.

The plan of the house is a basic, double-pile or two room deep design, with a large parlor and dining room on the west side. On the narrower, east side is the front stairhall and small parlor behind it. To the rear in a subordinate unit is the kitchen, while a shed addition containing a bath and rear hall were added to the west and rear facades. As with turn-of-the-century houses the cubic volume is broken and enlivened by recessed areas and projecting bays. The entrance bay on the front of the two-bay house, is recessed and has a porch which projects slightly from the main wall; the three-bay window of the dining room, projects in a semi-octagonal bay on the west. And, while the east wall is flush, the west has an irregular facade.

The roofline is enlivened by the cross gable covering the semi-octagonal bay, and the small dormer windows. One lights a small bedroom on the west side, while the other, over the entrance door, was removed by the previous owner and will be replaced in the coming twoyear, restoration project.

Stylistic details of the house include the tall proportions and long, rectangular shape associated with the Queen Anne style. Other details of this style include the two, heavy brackets on the west gable, and the decorative, octagonal shingles in the dormers. These shingles could also allude to the Shingle Style or English Vernacular Revival styles, as several windows have lattice work, which appears in the upper light on the main facade. Colonial Revival details appear in the egg and dart moding found in oone room on the second floor, in the swags over the front windows and in the semi-circular arch with keystone on the second floor.

While the house is structurally sound, it has been neglected. The present owners are rewiring, stripping paint, patching leaks and plaster, refinishing floors and recovering the roof. As mentioned above, the basement had to be rebuilt due to extensive water damage. The archtectural integrity of the house is being preserved and in many cases, restored.

#### Statement of Significance (in one paragraph)

The Lohr House is significant in the areas of architecture and early settlement. The residential landmark of Estelline, the dwelling was built in 1901 for Charles and Mary Lohr, pioneer settlers in Hamlin County. As one of the oldest residences of Estelline, the house is a turn-of-the-century blend of Queen Anne, vernacular revival and Colonial Revival styles. No one style predominates, instead the casual mixture and simple use of detail creates a pleasing combination of standard, pattern book parts. Virtually all of the interior furnishings, including gas lights, brass hardware, wood and copper toilet, watertanks, and elegant metal cast heat vents, are intact and will be restored.

Soon after their marriage in 1882, the Lohrs migrated from Osage, Iowa to Hamlin County. They had followed Charles' father lead and settled on the banks of the Big Sioux River. While Peter Lohr returned to Iowa, his sons stayed on in South Dakota. They entered into business together. The town of Estelline was platted in 1882 and the first buildings erected in 1887; several commercial structures were built with bricks invented and manufactured by the Lohr brothers. Another enterprise was the Lohr and Lohr Drugstore.

Later owners of the house include E. M. Converse, a farmer, city accessor and manager of the Estelline Livestock Shipping Association. Another owner, Leo Westra, owned the house with his sister, Veronica. After years of neglect, the present owners are undertaking a major restoration of the dwelling to return to its original appearance.
