7. DESCRIPTION

Located within the incorporation limits of Hazlehurst, just west of the Hazlehurst Cemetery and at the end of Dale Drive, is the Marchetti Farm, a 67.5-acre truck farm that retains a full complement of historic outbuildings. The house was built about 1895, and a circa 1918 remodelling gave it its present vernacular Queen Anne, gable-front-and-wing form. The front yard of the house is bordered by a decorative iron fence, and a wire fence separates the side yard from an adjacent field where gardens were historically planted. Large camellia bushes and numerous pecan trees grace the yard. Directly behind the house is a brick molasses house/storage building and a corrugated metal shop building. Further to the north is a brick and frame building that served as a flower house, potato house To the northwest, and separated from the yard by a and smokehouse. wire fence, are a cow barn with corn crib, a bath house, and a horse South of the house, across Dale Drive, is a garage and a barn. fertilizer and implement storage building. Only the two parcels that contain the house and outbuildings are being nominated; these two parcels contain 37.4 acres of fields, wooded areas, and a small pond.

Facing south, the Marchetti House is a one-story, frame, gabled house resting on brick foundation piers. As originally built about 1895, the house was a three-bay wide structure with undercut gallery and Circa 1918 a cutaway gabled bay was added to the west end rear ell. of the facade, giving the house its vernacular Queen Anne, gablefront-and-wing form, and in 1925 a back porch was added to the house. An interior brick chimney with corbelled cap pierces the roof of the rear ell, and an exterior end chimney on the east elevation has been partially removed. The main (south) facade features a central single-leaf entrance topped by a single-light transom, flanked by the cutaway bay on the west end with three four-over-four, double-hung windows and a six-over-six, double-hung window on the east end. The walls within the "L" of the facade are clad in flushboard, and the two-bay porch has wrought iron posts and concrete deck.

The interior of the house originally was a center hall plan with two rooms to each side of the hall, and a rear ell. The front room added circa 1918 can be accessed directly from a door opening onto the porch or from what was originally the front southwest room. The house retains its original four-panel doors, plain trim, and mantels composed of pilasters supporting a denticulated frieze and molded mantel shelf.

The molasses house/storage building directly behind the house was constructed circa 1895 and is an "L"-shaped brick building with corrugated metal roof. The bricks used for construction of buildings on the property were fired on site. Also built circa 1895 is the combination smokehouse/potato house/flower house. The north third of the building is the smokehouse, constructed of vertical boards and accessed through paired wooden doors. The central portion of the building is the sweet potato house, constructed of six-course common bond brick and accessed through a door of vertical planks topped by a wire mesh transom. A corrugated metal shed roof crowns the northern two-thirds of the building. The southernmost third of the building was the flower house, and it has a concrete foundation and brick walls laid in stretcher bond. The roof is now clad in corrugated metal but originally was covered with glass sashes. Also in the rear yard is a circa 1960 corrugated metal shop building, which is a noncontributing element.

In the farmyard northwest of the house are two barns and a bath house. The northernmost barn is a gambrel-roofed, vertical board structure built circa 1915 to stable horses. The southern cow barn with corn crib was built circa 1895 and is a gabled building constructed of vertical boards. The roofs of both barns are clad with corrugated metal. The bath house is a small, two-bay wide, gabled structure with vertical board siding. Built circa 1895, the bath house served an adjacent pond, which is now dry.

South of the house, across Dale Drive, is the circa 1920 board-and batten garage and the circa 1925 fertilizer and farm implement building, which is constructed of vertical board and crowned by gable and shed roofs.

The owners of the property plan to plant the farm in pine trees and operate the property as a tree farm. Only the two parcels (37.4 acres) that contain the house and farm buildings are being nominated. This acreage includes the farm yard, former fields, wooded areas, and a small pond southwest of the house.

8. STATEMENT OF SIGNIFICANCE

The Marchetti Farm is significant in the area of agriculture (Criterion A), being an intact example of a Copiah County truck farm of the period 1895 to 1940. The farm retains a full complement of historic buildings, and these retain a high degree of integrity. The associated historic context developed in the MPS cover document entitled "Historic and Architectural Resources of Copiah County, Mississippi" and represented by this property is "Copiah County's Development from the Post-Bellum Period to the End of World War II, 1866-1945." As discussed in the MPS cover document, truck farming was of vital importance to the economy of the county from the late nineteenth century until the end of World War II (see pages 16-26 of the MPS cover document), and the Marchetti Farm is a significant local example of a truck farm. (Although registration requirements for agricultural properties have not yet been developed in the MPS cover document, it is clear that a truck farm that retains all of its historic farm buildings is eligible under Criterion A in the area of agriculture if these buildings retain integrity.)

Frank Marchetti was born on June 7, 1841, in Faenza, Italy, and came to Copiah County about 1861. He married a Copiah County native, Martha Ann Tanner (1851-1928), and in 1895 built the Marchetti House and some of the outbuildings (molasses house, flower house/potato house/smokehouse, cow barn, and bath house). Mr. Marchetti was a truck farmer, raising asparagus, carrots, tomatoes, beans, peas, cabbage, pears, apples, and plums. These early crops were followed by later crops of sweet potatoes. In addition to farming this property, the Marchetti family farmed 300 acres west of town; approximately 100 acres of this was devoted to truck farming while the remainder of the land was in cotton and corn. Frank and his sons also operated a grocery business in Hazlehurst, which was established about 1900 (Robert G. Marchetti; <u>Hazlehurst: A View of the Past</u>: 15).

Upon Frank Marchetti's death in 1908, his oldest son, John W., took over operation of the truck farm, raising beans, peas, cabbage, and corn, as well as cattle. He remodelled the house in 1918 and also constructed the horse barn in 1915, the garage circa 1920, and the fertilizer and implement storage building in 1925. When John died about 1936, his brother Robert Emmett took control of the farm. The property was operated as a truck farm until about 1940, at which time it became primarily a cattle farm. The property is still owned

by the Marchetti family, who plan to plant the farm in pine trees and operate the property as a tree farm (Robert G. Marchetti).

- 10. GEOGRAPHICAL DATA

<u>Verbal Boundary Description</u>: The property being nominated includes Parcel No. 120 as shown on Map 107L and Parcel No. 24 as shown on Map 107P in the Copiah County Tax Assessor's Office (see accompanying scale maps). These parcels are located in Section 9, Township 10 North, Range 2 West.

Boundary Justification: The area being nominated consists of two parcels that contain the house and farm buildings and is 37.4 acres of the 67.5 acres historically associated with the farm and still owned by the Marchetti family. Additional acreage was omitted because some was discontiguous with these two parcels, while other acreage will be planted in pine trees. The 37.4 acres being nominated is located immediately adjacent to the developed area of the town of Hazlehurst, and this acreage constitutes the rural setting of the house and farmyard. This is particularly important because the property is being nominated for agricultural significance. In addition to the house and farm buildings, these parcels contain open fields, wooded areas, and a small pond southwest of the house.


