The Rock Hill Cotton Factory [Boundary Increase] consists of a typical one-story, linear brick and wood-frame cotton warehouse building in the city of Rock Hill, South Carolina. Located immediately northwest of the Rock Hill Cotton Factory [listed in the National Register of Historic Places on 21 April 1992, as part of the Historic Resources of Rock Hill, South Carolina, multiple property submission], the building, known as the Fewell Cotton Warehouse, is divided into three parts with substantial brick walls with stepped parapets on either end and two corresponding interior brick firewalls. Within each section along the White Street range the walls are wood-clad but have been altered to varying degrees. Along the interior or opposite elevation are relatively intact weatherboard-clad walls with sliding plank warehouse cargo doors. The low-pitched roofs are asphalt/composition with exposed rafter tails.

Running approximately half the length of the south end of the warehouse building and adjacent to the mill building is a small, one-part commercial block that faces White Street and consists of a central, single-leaf entrance with flanking double-hung, one-over-one sash windows. A simple corbel is the only adornment to the facade's parapet. Along the side [south] elevation are single, double and triple windows with sash of a similar character as those on the White Street elevation [facade]. A stepped parapet on the south or side elevation indicates the gentle, sloping character of the commercial-type built-up roof that shelters the building. A single central entrance is the rear elevation's only fenestration.

The Fewell Cotton Warehouse is significant as an important remnant of the early textile history of Rock Hill. It is located adjacent to the Rock Hill Cotton Factory (1881), the city's first textile mill. The warehouse was built before 1894 as part of the Cotton Factory complex. In 1903, the warehouse was purchased at auction by Edward Fewell from the Crescent Cotton Mill for \$3,000. Fewell, a native of the Ebenezer community near Rock Hill, had a strong background in the cotton business. From 1882 to 1885, he was employed by J. M. Ivy & Co., one of the leading cotton merchants in the upstate. He served as local representative for William Black & Co. of the New York Cotton Exchange from 1885-1887. In 1887 he and his brother R. T. Fewell began a large cotton brokerage business with offices across the upstate and in Charleston, where they exported about 25,000 bales of cotton each year to Europe. In 1893, R. T. Fewell withdrew to organize and build the Arcade Cotton Mill in Rock Hill, of which Edward was an investor and director. Edward continued the cotton business and in 1903 purchased the warehouse from the Crescent Cotton Mill, continuing operations there until the 1940s. In recent years, the building has been rented to a variety of service and retail businesses.

The property is significant for its association with the development of the textile industry in Rock Hill. Although its date of construction is unknown, it is shown on the 1894 Sanborn Insurance Map, indicating that it was built in the early years of the operation of the Rock Hill Cotton Factory. It is located directly to the rear of the Rock Hill Cotton Factory building and was oriented to take advantage of a rail spur serving the mill.

The Rock Hill Cotton Factory was listed in the National Register of Historic Places on 21 April 1992, as part of the multiple property submission "Historic Resources of Rock Hill, S.C." The Fewell Cotton Warehouse was not included in the boundary for the Rock Hill Cotton Factory at the time.

The proximity of the Fewell Cotton Warehouse to the Rock Hill Cotton Factory—it was historically separated from the factory by nothing more than a rail spur, which served both the mill and the warehouse—and its close association with the early history of the factory justifies the expansion of the boundary for the Rock Hill Cotton Factory to include the Fewell Cotton Warehouse.

The Fewell Cotton Warehouse meets the registration requirements of the property type "Textile Mill Buildings and Related Buildings" of the multiple property submission "Historic Resources of Rock Hill, S.C."

Verbal Boundary Description

The boundary of the nominated property adds the portion of York County Tax Parcel # 6272001004 (as shown on the accompanying York County GIS Map) to the adjacent existing National Register property listed in 1992 as the Rock Hill Cotton Factory.

Boundary Justification

The Fewell Cotton Warehouse was constructed shortly after the Rock Hill Cotton Factory and was associated with the operation of the factory for most of its operation as a textile mill. Because it is adjacent to and was historically associated with the Rock Hill Cotton Factory during its period of significance, and never separated physically except by a rail spur (now removed), the addition of this tax parcel with the warehouse is justified.


