1. Name: Mimbres School, survey number 67

2. Location: 200' east of Highway 61 and 150' south of junction of 61 with Forest Route 73.

4. <u>Owner</u>: Dan Antonio and Mariano Grijalva et al, San Lorenzo, N.M. 88057

7. <u>Description</u>: Photo 35; map 7; foundation unknown; stuccoed adobe; corrugated metal gabled roofs, wood shingles in gables; 6/1,6/6 double hung windows singly and in tandem; double doors with transom. New French double doors in original opening, adobe room added to north rear in 1985. Enclosed in an ornamental fence of wire, pipe and cast iron, likely erected near the construction of the school in the 1890s. Two small wood frame sheds sided with corrugated metal stand behind the school and within the fence.

8. <u>Significance</u>: This is one of four unaltered historic buildings remaining in Mimbres. (See Sibole Store, # 71, above for discussion of history of Mimbres.) Built in the 1890s, this along with the San Juan school, is one of the first two schools built in the valley and therefore meets Criterion A as a good reminder of the early settlement of Grant County. It uses typical materials of the local New Mexico Vernacular--adobe and corrugated roofing--but adapted to a new purpose, and a scale just slightly larger than the normal residence. It meets Register Criterion C as a good, well-preserved example of the New Mexico Vernacular type.

10. <u>Geographical</u> <u>Data</u>: Approximate Acreage: less than one. Quadrangle Name: San Lorenzo, N.M. Scale: 1: 62,500 UTM References: 13 221000 3638950 Verbal boundary: A rectangle, roughly 120' by 190', as shown on map 7, formed by lines parallel to and ten feet from the ornamental fence enclosing the building. Since this is an unplatted area, this boundary has been created to include only the school, two small sheds and the historic fence.
