The Cahow Barber Shop is located in Chapman, Merrick County, Nebraska. The false front commercial building, built in 1889, is of frame construction with a gable roof and linteled door and window hoods. The barber shop is presently owned by the Lone Tree Literary Society whose future plans call for restoration of the building for the purpose of preserving the childhood impressions of Central City native and author Wright Morris.

The Cahow Barber Shop, situated on the south-west end of main street in Chapman, Nebraska is a simple, rectangular, one-story, wood-frame structure with a false-front and gable roof. It rests on a foundation of limestone runners and the original clapboard siding is still intact. The ninety-four year old building, which was constructed in May-December of 1889, stands on its original site. The interior has been altered from two rooms to one. The north three-fourths or front of the interior has had the original wainscot and plaster removed and replaced with dry wall while the south one-half or back retains the original wainscot and plaster. The interior wall, dividing the two rooms, has been removed. The existing three windows and three doors are original to the building. The windows are double hung.

The original contents of the building (barber chair, mirror and backboard, clock, and benches) have been kept and are housed in the Merrick County Museum in Central City. The original barber sink is also in safe-keeping by the Museum.

This building, to be restored and housed again with the original barber shop furniture and fixtures, has been added to the properties of the Lone Tree Literary Society whose purpose is to preserve the childhood impressions of author-photographer Wright Morris who was born on the plains of Nebraska on January 6, 1910 at Central City. The Literary Society also owns the Patterson Law Office and the Wright Morris Boyhood home, both located in Central City and both listed in the National Register of Historic Places.

Statement of Significance (in one paragraph)

The Cahow Barber Shop is significant in the field of literature as it relates to the writings of Central City's noted author, Wright Morris. Appearing in Mr. Morris's literary works, both in writing and photographs. the barber shop stands as a reminder of the childhood impressions of the author's life. Architecturally significant, the barber shop stands as the only remaining nineteenth century frame commercial building in the downtown business district of Chapman.

The Cahow Barber Shop in Chapman, Nebraska is the place where Will Morris (the father of Wright Morris) "first set eyes" on his future wife. On page five in Will's Boy, Wright Morris writes, "On weekends in Chapman the farmers parked their buggies at the hitch bar in front of Cahow's Barber Shop. . . According to Eddie Cahow, my father first set eyes on my mother, leaping from the chair, the cloth dangling from his collar, to help her down from the buggy. That is the story and who am I to change it?"

Wright Morris was born January 6, 1910 in Central City, Nebraska to William H. and Ethel Grace (Osborn) Morris. His mother, died six days after his birth and is buried in the Chapman Cemetery nearby. In 1919, Morris moved with his father to the urban environment of Omaha, and six years later to Chicago.

Wright Morris is regarded as one of this country's most gifted writers. He received the national book award in 1956 for his novel, The Field of Vision. He has published extensively and has received three Guggenheim fellowships. From 1962-1975 he was professor of Creative Writing at San Francisco State University. Repeatedly, in the course of Wright Morris's work, there is a return to the territory of his birth, with many of his books being set in Nebraska.



Luther Cahow (referred to as "Eddie" Cahow in Morris' literary works) purchased the Barber Shop in 1902 where he barbered for 47 years. He sold the building in 1949. Mr. Cahow was born in Stuart, Iowa in December of 1872, coming to Chapman, Nebraska in 1881 residing on a farm outside of town. Several years later, he moved to town and lived with family relatives. In 1894, Mr. Cahow left Chapman and traveled through Wyoming, Colorado, Montana, and South Dakota, returning to Chapman in 1896. The Cahows were natives of England and earlier generations had lived in the state of Maryland. Mr. Cahow was married to Laura Mae Fishburn, on April 10, 1901, having one son, Gerald Vaughn, who was born in March of 1904. He died in November 1950 at the age of 77 years. The following paragraph is taken from one of Morris' books which talks about the barber shop.

"In the mirror where the things of this world were reflected, my father and mother exchanged their first glances, an Eden full of the ringing chirp of Cahow's shears." ---God's Country and My People by Wright Morris, 1968

Photographs of the interior of the Cahow Barber Shop appear in several of Morris' books; <u>The Inhabitants</u>, <u>God's Country</u> and <u>My People</u>, The Home Place, and Wright Morris - Photographs and Words.

Architecturally significant, the Cahow Barber Shop represents a rare local example of a frame false-front commercial building, typical of many modest structures put up by local businessman in small towns throughout Nebraska in the late nineteenth century. In Chapman, the structure stands as the only remaining frame commercial building in the downtown business district. The town hotel (c. 1880's), a significant two story frame structure located on the corner east of the barber shop, was torn down last spring to make way for a new masonic lodge. The remaining business properties are constructed of brick or concrete block, with several modern intrusions consisting of pre-fab metal buildings. WASO Form - 177 ("R" June 1984)
