Describe present and historic physical appearance:

The Gann Row Historic District in Benton, Saline County is a square city block of thirteen structures surrounding a central green space. Construction dates range from 1880 to 1924. The buildings, all residential, are located three blocks south of Benton's downtown area. Eight of the buildings are small Craftsman bungalows, one is a two-story garage that was converted into apartments and moved from a location one block away on Smith Street, and one is a small Folk Victorian with a wrap-around porch. Three of the buildings facing Main Street are 1880 Folk Victorians with Craftsman porches applied to the front facades. The district is bounded on the north by West Maple Street, on the east by South Main Street, on the south by West Pine Street and on the west by South Market Street. All structures are considered contributing.

Architectural Survey

The Gann Row Historic District, is a block of unassuming residences, the bulk of which were rental properties from the time of construction. This collection of structures represents modest housing stock for the working class people of Benton, covering a construction span of 1880 to 1924. Three of the earliest buildings dating from the 1880s, 411, 415 and 417 S. Main Street, were altered with the application of horizontal weatherboard siding over the original board and batten and the addition of full front porches at an unknown date.

Craftsman

Craftsman is the predominant style of this small district. Eight of the eleven houses are constructed in the rectangular bungalow style. 402, 406 and 410 (SA0077, SA0078 and SA0079) S. Market Street all present similar facades and were built in 1924 by the same local workman, whose name is unknown. All

are rectangular weatherboard structures with full front gabled porches. A span of stick work fills the pediment of each porch above a single double-hung window, single-leaf front door and a ribbon of three double-hung windows. The porch posts are the only variation in style on these three buildings. 418 S. Market (SA0081), also constructed by the same workman, has a smaller front porch with stick work span, covering only half of the front facade and the main roof has a small hip on gable. Fenestration consists of two single double-hung windows on the front elevation.

- 414 S. Market Street, (SA0080) differs from the surrounding homes on its street with a different porch and window configuration. A ribbon of three double-hung windows dominates the front facade while a small side porch leads to the single-leaf front door. An unusual architrave of bead board and half-timbering surrounds the porch overhang.
- 424 S. Market Street (SA0082) has a gabled front porch covering half of the front elevation. While similar to the first three houses to the north of this street, it is slightly larger and has an enclosed pediment on its front porch. The window arrangement consists of a pair of double-hung windows on a gable front-facing wing and two single windows on either side of the front door under the porch.
- 421 S. Main Street (SA0083) was moved to its current lot in 1998 from 804 Military Road in Benton. This house echoes the bungalows with stick work porches on S. Market Street. It shares window arrangements and bracketing with the Market Street homes as well and was probably executed by the same builder in 1924.
- 112 W. Maple Street (SA0088) is another example of the Craftsman style that seems to share the same builder. Trademark decorative stick work is seen again in the full front porch of this rectangular building clad in stucco. Its simple front facade is fenestrated with two single windows beside a front door and window at the west corner.
- 106 W. Maple (SA0089) was also moved in 1998. This two-story building was relocated from 112 Smith Street in Benton. Constructed in 1920 as a garage for the never completed home of C.D. "Bullet" Hyten, it was turned into apartments in the 1930s. The current owner plans to continue its rental residential use.

Folk Victorian

These homes are the oldest in the district, dating from 1880 to 1890. 417, 415 and 411 S. Main Street (SA0084, SA0085 and SA0086) were altered in the 1920s with the addition of full gabled front porches and horizontal siding over the original board and batten cladding, remnants of which can be seen on the rear of 415 S. Main Street. The windows were probably changed at this time also. These three homes have rectangular floor plans with front facing gable roofs. The front gables of each above the porches are covered in wooden shingles. 417 and 415 have fish scale shingles and are embellished with decorative circular designs containing a cross pattern. 411 has diamond shingles and no decorative design. Porch foundations are composed of small uncoursed rubble stone. Supports and balustrades are square two-by-fours.

104 West Maple Street (SA0087) is a slightly larger, more complicated example of the Folk Victorian style than the three on S. Main. This home features a wraparound porch and a hipped roof with side gabled wing. The gable end on the east is decorated with triangular strips of wood above a louver. Another small side porch extends past the gable to the rear of the home.

State significance of property, and justify criteria, criteria considerations, and areas and period of significance noted above:

The Gann Row Historic District is historically significant to the city of Benton as an early example of a middle class rental residential enclave established by Dr. Dewell Gann, Sr., organizer of the first Saline County Medical Society. The district consists of modest homes assembled for the middle and working classes of Benton. The bulk of the Craftsman residences in the district are simple rectangular floor plans with minimal embellishments. The four earliest homes on S. Main Street and West Maple display such Folk Victorian elements as shingled gable ends and wraparound porches. The Gann Row Historic District is being nominated to the National Register of Historic Places under Criterion C with local significance for its portrayal of the Folk Victorian and Craftsman architectural styles of the 1880s and 1920s.

Historical Background

The first settler within the present day Saline County boundaries was William Lockhart, who traveled from North Carolina in 1815. Lockhart had traversed the Missouri Trail, (later called Military Road) past Little Rock toward Texas. He established his home at the point where the Trail crossed the Saline River. The county of Saline was known in 1835 as Saline Township in part of Pulaski County. In that year the township was divided into four townships- Saline (encompassing the area of Benton), Fourche, Davis and Brazil. The county of Saline was created in 1836 and Benton was selected as county seat, being nearer to the center of the county. It was also situated on prominent routes such as Saline Crossing and the main highway to Washington in Hempstead County from Little Rock.

Commerce in Saline County took an upturn in 1825 with the establishment of a watermill about ten miles northwest of Benton by Samuel Williams. This eased life for the early settlers somewhat as they did not have to travel to Little Rock twenty-five miles away in order to obtain ground corn. Another of the county's earliest industries was pottery plants. By 1873 there were seven pottery factories exporting their goods and the railroad arrived in 1871. Salt mines and planing mills began to develop in the area as well. The William Farrell Lumber Company, one of many established in the county, was incorporated by 1882.

The town of Benton in Saline County is thought to have evolved around 1834 with the establishment of a store in the residence of Joshua Smith. An order of incorporation for Benton was granted in 1839 and eighty acres were laid off for the town. Before the Civil War twenty acres were added to the north in an area called North Benton. In 1853 twenty acres were added to the south and in 1870, 160 acres were added to the west. By 1889 the population in Benton numbered 900.

1889 was the year Dr. Dewell Gann, Sr., moved to Arkansas. By 1890 he had settled in Benton and opened an office. It was in that year that he bought the first lot in Block 36 of the Original Town of Benton from a Tinnie Carter. Dr. Gann was a charter member of the Woodmen of the World. In 1903 he organized the Saline County Medical Society and served as secretary. He encouraged the completion of the Lott Railroad to Hot Springs and was made chief surgeon of that road. The Doctor was also surgeon for C.R.I. & P. Railroad at Bauxite and the Missouri Pacific Railroad. Manufacturing industries such as Norton & Wheeler Stave Company, Parker Stave Company and Gaiser Lumber Company also retained his services as surgeon.

By 1929 Dr. Gann owned all of Block 36 and had built all of the houses on Market Street. The town of Benton was growing and several businesses and industries had been established around the courthouse, a few blocks north of the Gann Row Historic District. These Craftsman residences constructed by Dr. Gann, and the existing Folk Victorian cottages, served as home to the growing middle classes employed at Niloak and Eagle Pottery, and Owosso Manufacturing, as well as at the local lumber mills, furniture factories and the State Hospital for Nervous Diseases at Benton. This area of Benton can still be considered home to the middle class. The district is surrounded by moderate housing to the south, east and west and is bounded on the north by Benton's historic downtown. The majority of the houses on Block 36 are owned by the same person who has plans to continue their historic use as rental residential properties.

Architectural Significance

The Gann Row Historic District consists of modest residences constructed for the working class of Benton. Dr. Dewell Gann, Sr., purchased the lots in Block 36 beginning in 1890. At that time there were four Folk Victorian houses constructed between 1880 and 1890 extant. These homes underwent Craftsman renovations by Dr. Gann in the 1920s, when he built the remainder of the houses on Market and Maple Streets. All thirteen structures are considered contributing to the district. The Gann Row Historic District is being nominated to the National Register of Historic Places under Criterion C with local significance as a microcosm of intact late nineteenth and early twentieth century rental residential stock for middle class workers of Benton. This district's character is important in the face of Benton's rapid transformation to a bedroom community for Little Rock, and the changing architectural styles being introduced into growing subdivisions and strip malls.




