DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

The castle gatehouse was originally built between 1899-1901 using face brick as its exterior surface. In order to give it an authentic look of a typical ancient castle, the brick surface was covered with Portland cement plaster blocked off to represent stonework. In 1958 the old stucco was removed and a new coat of gray stucco was applied to the brick surface and similarly blocked off.

By Acts of Congress in 1850 and 1852, the U.S. Army Corps of Engineers was given the responsibility for providing a water supply to Washington, D. C. For approximately 40 years, the city was furnished untreated, unfiltered, often muddy water, first from Little Falls Branch and then from the Potomac River.

During the latter eighteen hundreds and early ninteen hundreds, extensive additions and changes were made to the system. In 1905 the fist filtered water was sent to the city from the newly completed McMillan Filter Plant.

The Castle Gatehouse was constructed as part of these improvements. Situtated at the mouth of the Georgetown Reservoir, water passes through the Castle on the way through the 4 mile long city tunnel to the McMillan Reservoir and Treatment Plant.

This structure was constructed to resemble the insigna of the Corps of Engineers. This insigna had been adopted as a regulation device for the Corps of Engineers uniform from the 1839 West Point Cadet uniform which carried a turretted castle on the cap plate, hat, coat collar, belt plate, and buttons.

The Georgetown Castle is a well known local landmark. It is worthy of recognition as symbol of the Corps of Engineers responsibility held for over one hundred years. It is a symbol of the beginning of the actual treatment of the water furnished to the city, a major factor in reducing diseases and providing a high quality, palatible supply.
