The Norfolk Carnegie Library is located at the West End of the downtown business district of Norfolk, Nebraska. The front of the building faces north and overlooks Norfolk's main thoroughfare, Norfolk Avenue. The library, completed in 1910, is one of 68 Carnegie Libraries constructed in Nebraska during the last phase of the Carnegie Library "wholesale" period and conforms to the building plan prototype established by Carnegie. The library is rectangular shaped, one story with a raised basement and is designed for efficiency. The original exterior configuration and detailing of the building remains in tact.

The Norfolk Carnegie Library, constructed in 1910, is a one-story brick structure with a raised basement and a hipped roof. The brick is a reddish fired brick with iron spots. The trimmings are cream sandstone. Measurements of the rectangular shaped building are 60 feet by 44 feet. The building is of the Classical Revival style. The windows are placed symmetrically and are double hung. The words "Public Library" are inscribed in a stone header above the entrance. The entrance features double doors with sidelights and a transom.

The interior of the library's main floor originally included a foyer, central book delivery, stock room, librarian's office, study room and two reading rooms. In 1997, seven foot high, glass partition walls were constructed to provide office space in the east and west reading rooms. The interior retains its original 13 foot high ceilings, oak ceiling molding, baseboard, paneled doors, window and door surrounds as well as the three-quarter inch ceramic floor tile of the foyer. The wood lath and sand plaster walls are sound and undamaged. The original wood floors have been covered at different points in time with battleship linoleum, asphalt tile and carpet.

An interior stairway to the right of the foyer leads to the raised basement where a lecture room with a stage, classroom, coal bin, boiler room, kitchen and restrooms are located. In 1953, the coal-fired boiler was replaced with a gas-fired boiler and the coal bin was converted to a storage room. In 1997, the gas fired boiler as well as the steam piping and radiators were removed and a forced air heating and air conditioning system was installed. At this same time, the stage was removed from the lecture room and the exterior basement walls were insulated and covered with drywall. The existing windows and doors as well as the wood molding surrounds were retained in place. The interior wood lath and sand plaster walls were retained.

The building currently functions as an office for a planning and engineering firm. This conversion has been sensitively completed and the building retains a high degree of historic integrity representing this building type and style well.

The Norfolk Carnegie Library meets the registration requirements of the National Register of Historic Places Multiple Property Documentation Form, "Carnegie Libraries in Nebraska, 1899 to 1922", and is significantly associated with the historic context "Educational Enrichment: Carnegie Libraries". The property is locally significant in the area of public education (Criterion A) as an important example of the property type "Carnegie Libraries in Nebraska" as well as the distinctive characteristics of the Classical Revival style of architecture (Criterion C). The period of significance is derived from the year of its construction and operation as a library which began in 1910 and extends to the established fifty year cut-off year of 1948. This period is justified because the building was a functioning library throughout the period.

The Norfolk Public Library first opened its doors on July 7, 1906 with a collection of 400 books. The Norfolk Women's Club had been working for a public library almost from the beginning of the club's founding ten years earlier. In 1908, the operation was transferred from the Women's Club to the City of Norfolk and became a free public library. In 1908, a movement was begun to secure building funds from Andrew Carnegie. Construction of the building, which is located on the southwest corner of 8th Street and Norfolk Avenue was begun in 1909 and completed in September of 1910. Carnegie made a grant of \$10,000 with the stipulation that the city must provide 10% of the amount annually to maintain the facility.

The building served as a public library until 1978 when it was adopted to another use, that being a public art gallery. The Norfolk Art Center occupied the building until June of 1997 when it was sold to the engineering/architectural firm of Johnson-Erickson-O'Brien and Associates, Inc.

The building stands today as a major landmark in Norfolk and is a testament to the Classical Revival style of architecture of the early 20th Century. The example of the academic genre marks this building with exceptional significance.
