SUMMARY

The Arlington Hotel, currently the Echo Tavern, is a two-and one-half story, commercial building. The Vernacular style building, with simple classical details, was constructed as the Arlington Hotel in ca. 1882. The building is one of the oldest buildings in Echo and represents the primary period of the town's development. Although the building has undergone some modifications, the building retains its simple rectangular plan, gable roof, shiplap siding, and original windows (although boarded over). The building was originally used for a hotel and a saloon; currently the first floor is used as a tavern/restaurant and the upper floors are vacant. The building is in fair-good condition with minor-moderate exterior alterations.

SETTING

The Arlington Hotel is located on Lot 4 and part of Lot 3 of Block 1 of the Koontz Addition to Echo. The building is situated on a flat lot in downtown Echo on the corner of Dupont Street (to the east) and Main Street (to the south). A vacant lot is located directly west of the building. An alley and residential dwellings are north of the building.

PLAN

The two-story building, measuring 28 ft. x 66 ft., is rectangular in plan and has a basement and an attic. An historic addition, measuring 20 ft. x 25 ft. (east-west), has been added to the north side of the building. Two additions have been added on the west elevation; one historic shed addition and one non-historic addition housing the restaurant. The building has a corner entrance.

The interior of the building was historically used as a hotel room on the upper floor and a saloon on the lower floor. Staircases to the second floor were located on the exterior of the north elevation (staircase removed) and on the west elevation (removed). The second floor is divided into nine rooms and a bathroom. The tavern on the first floor is divided into the kitchen, tavern, restrooms, and restaurant. The building has a partial basement and a full attic.

EXTERIOR

The two-story building has a gable roof covered with asphalt shingles which is capped with a brick chimney near the gable peak. A newer wood clad chimney is on the east side of the gable. A wide friezeboard extends around the perimeter of the building. The soffit is covered with tongue and groove boarding. Cornerboards with simple classical capitals finish the corners of the shiplap siding. The majority of the four over four double-hung and one over one double-hung windows are currently boarded-up. Projecting cornices cap the windows and simple wood trim surround the windows. The foundation is brick.

The building has a recessed corner entrance. The entrance is flanked by sidelights (boarded up) and a transom. A new entrance door has been added to the south elevation along with an aluminum glass sliding window. Vertical board and batten siding covers a majority of the first story of the south elevation. A non-historic wide vertical board band extends across the south elevation above the first floor windows. This band extends across the south elevation of the one story addition located west of the original hotel building. Original windows of the storefront are intact beneath new covering.

A one-story addition and a smaller shed addition are located on the north elevation. The larger addition has a gable roof covered with wood shingles, boxed eaves, a wide friezeboard, and a shed extension on the west side. Modifications to the addition include window replacements with aluminum frames, addition of utility boxes, boarded over windows, and a new door on the north elevation. A small shed addition is located on the southwest of the gable addition. Early Sanborn Fire Insurance maps indicate the rear additions to the building. An exterior staircase once (removed) lead to the door on the second story of the north elevation.

Other additions are located on the west elevation. A historic shed addition with an open shed porch area extends along the northern side of the west elevation. A newer, large shed addition is also attached to the west elevation. The newer addition has a shed roof with rolled shingle sheathing topped with air conditioning units. The exterior wall on the addition are a combination of vertical board siding, shiplap siding, and plywood. An exterior door is located on the north side of the addition. This addition replaced an enclosed exterior staircase.

INTERIOR

Due to restricted access, the interior of the building will not be discussed in length.

First Floor and Basement

The first floor is divided into a restaurant area, restrooms, tavern, and kitchen. The tavern and kitchen (north portion of first floor) are located in the original section of the building (east one-half). The tavern walls are covered with newer wood boards. The original ceiling heights and fir floors are intact. Stairs in the center of the kitchen area lead to the basement. The basement has a dirt floor and brick walls.

The restaurant addition extends to the west and has horizontal cedar boards covering the east, north, and west walls of the room. Wood shingles cover some of the south interior wall.

Second Floor and Attic

The second floor is currently only accessible by ladder from the north elevation (exterior). The second floor is divided into nine hotel rooms and a bathroom. The rooms flank a central hall. A door is on the north end of the hall. The original ceiling heights are original and the walls retain the original plaster work. The floors are fir. Stairs to the attic are in the northwest corner of the second floor. The attic extends across the entire length of the building. The attic was once used for the storage of coffins.

ALTERATIONS

Majority of windows have been boarded-up; new door and window on the south elevation added; addition of vertical boards on the south elevation; chimney addition on the east side of the gable; addition of a vertical board banding above the first story windows on the south elevation. One story porch removed on the south elevation and original staircase removed accessing the upstairs hotel rooms on the west and north elevations. Addition on the west side of the building. Historic additions on the north side of the building.

STATEMENT OF SIGNIFICANCE FOR THE ARLINGTON HOTEL

The Arlington Hotel, now known as the Echo Tavern is significant under Criterion A for its association with the development of transportation and agriculture in the Echo and Meadows area. This development followed the completion of the Union Pacific railroad line through Echo in 1884 and allowed for the movement of cattle, sheep, grain, and other agricultural products to markets in many parts of the United States. Rail transportation continued to be a major source of business and income in Echo through the 1940s when new highway construction and improvements in barge traffic on the Columbia River signaled major changes in transportation patterns and the eclipse of the railroad.

The Echo Tavern was built by J.H. Koontz between the years 1882 and 1886. It is one of the few remaining large, wood-frame commercial building still standing in Umatilla County. In its early days it was known as The Louvre Saloon. When it was constructed it featured "sample rooms" for traveling salesmen to display their products in, a regular feature of many hotels of the time. The top floor was used by an undertaker who stored coffins there; they were discovered many decades after the undertaker left.

James H. Koontz, Echo's founder, was born in 1830 in Belmont County, Ohio and learned the trades of cabinet making and carpentering there. As a young man he moved to Iowa and later came to Oregon by wagon train. He remained in Portland for a short time, then in 1863 settled in Umatilla Landing, at that time a busy transfer point for goods shipped up the Columbia River on their way inland. Koontz was postmaster in Umatilla Landing for 17 years and also had a general store handling much of the freight that went in and out of the port. Forseeing the decline of river trade and the rise in railroad transportation that had become available to communities across the nation, Koontz moved to the Echo area in 1880. Koontz and W.D. Brassfield filed the first plat on the east side of the Umatilla River for the City of Echo in that year. Within four years, Echo had 15 businesses. As the town of Echo grew, Koontz constructed the Henrietta Flour Mills in 1886, a hotel called the Arlington House, now the Echo Tavern, the Koontz Building which housed his general merchandise store and a feed store, a spacious home for his family, several small cottages, and donated land for the Methodist Episcopal Church. Mrs. Koontz was the former Cynthia Ann Hyatt. The couple had seven children, only three of whom survived infancy.




BOUNDARY JUSTIFICATION

This lot defines the current property boundary This includes the historic hotel and the west side additions.




