

Summary Paragraph

The Baptist Church of Christ at Sardis, commonly known as Sardis Baptist Church, is a small wood frame vernacular country church located approximately fifteen miles east of Louisville, Mississippi in Winston County. The Church was established in 18831 and the current structure was erected in 1917 replacing an earlier frame church constructed in 1902-1903 on the same site. The church is a single room with beaded board walls and ceiling, and still has its original pews. The church is located in a rural part of Winston County on Sardis Road and situated among dense tree growth. There is a cemetery to the rear of the church where church members are buried. In addition two modern out buildings, a pavilion and small bathroom building, have been constructed more recently on the site.

Narrative Description

Site

The church is located on a one acre site off of Sardis Road in rural Winston County. A gravel drive from Sardis Road leads to the church and wraps around the church building forming a loop (Photo # 1). On the site is the church building (photo # 2), a cemetery (Photo #8), pavilion (Photo #9), and a small bathroom building (Photo #10). The buildings and cemetery are in a clearing surrounded by dense tree growth. There are a couple of large mature trees close to the church, one in the front and one in the back, between the church and cemetery. The site rises slightly from the road and the church sits on the highest point on the site giving it prominence. Grass covers the portion of the site not covered by trees.

Church Exterior

The church is a small wood frame vernacular building typical of rural churches in Mississippi. It is rectangular in shape, approximately 30' by 40', and has a high pitched front facing gable roof. The front façade features two symmetrically placed entry doors (Photo #2). According to Mississippi architectural historian Richard Cawthon it is a typical form for rural churches with examples in Mississippi that date back to the 1850s.

The church sits on a foundation of local rocks moved to the site for the foundation. The foundation rocks were used for an earlier church on the site constructed 1902-1903. The current church was completed in 1917, after the first church was destroyed, and was built in the same location on the same foundation rocks. According to church members, the current church is a replica of the first church. The foundation rocks are located approximately 10' apart.

The church is sided in wood clapboard that is 41/2" deep and there are 4" wide corner boards where the clapboard terminates. The roof is sheathed in V-crimp metal panels, a replacement of the original roof which was most likely wood shakes. The church is approximately 14' high off of the ground to the eave and 28' high to the peak of the roof. The church sits approximately 1' off of the ground. The roof has a gable return on the front and rear (south and north elevations) with eaves that extend about 1' on the sides (east and west elevations) of the church with fascia boards of approximately 4" and a frieze below of approximately 10".

The front, or south elevation, has a pair of symmetrically placed wood doors each with four recessed panels set in simple framed openings. The doors are not original as a historic photograph of the church shows that the doors were originally

wood with five vertical panels each. Pre-formed concrete steps, with three steps, lead to each door and have a simple metal rail to the right of each set of steps. Between the doors is a light bulb socket with a metal cover over it attached to the siding.

Both the sides, or the east and west elevations, are the same, with four wood double hung sash windows each with four panes over four panes (Photo #4). The windows have simple wood frames and sills. The windows are 78" tall and 38" wide with their frames.

The rear, or north elevation, has a door and window which are asymmetrically placed. The door is wood with six recessed panels and the window matches those on the side elevations. A wood ramp has been constructed recently over the steps for easier access to the church. There is also a light bulb socket with a metal cover over it attached to the siding in the same fashion as the one on the front elevation.

Church Interior

The church is accessed from the front by a pair of doors or from the rear by a single door. Architectural historian Richard Cawthon believes that the twin doors on the front became a customary element of traditional church building which derived from the practice of having separate entrances in some churches for men and women.³

The interior is one large room with no partitions. At the north end of the interior and centered in the wall is a pulpit raised 1' off of the ground with three lecterns (Photo #6). The pulpit is 8'4" wide and 6'9" deep. Just behind the pulpit at the left corner is the rear window. A closet was added to the northwest corner of the church to store the piano. It does not go all the way to the ceiling. When entering the church there is a small space before the rows of pews start. There are three sets of pews, six rows each that are parallel to the front of the church (Photo #7). In front of those pews there is a rectangular open space in front of the pulpit and to either side of that space are four rows of pews that are perpendicular to the other pews. All of the pews are movable, 15" deep, and were handmade for the church. They were built in three lengths, 10'3", 8'4", and 6'5". The 10'3" pews are those that are closest to the pulpit. The 6'5" pews are the center pews of the three sets of pews and the 8'4" pews are the ones on the outside against each side wall.

The cross section of the interior of the church features an approximate 30 degree slope of the ceiling at about 10' off the floor up to a flat ceiling that spans the interior. The walls and ceilings are covered in tongue-and-groove double beaded pine board panels that are stained. The floor is covered in 5 ½" pine boards with a simple flat baseboard. The doors have simple plain board trim that is stained and the windows have trim made out of the same beaded board used on the walls and ceilings.

Besides the addition of the closet, the only alteration to the interior was the addition of few simple light bulb sockets for lighting. They were actually added in the 1980s. There has been no heating or air conditioning added to the building. In fact there is no evidence that the building was ever heated with a wood stove as there are no cuts in the walls or ceilings for a flue.

Cemetery

Behind the church building is a small cemetery where church members are buried. The cemetery is surrounded by a modern decorative iron fence and the gravesites are laid out in traditional rows (Photo #8). There is no landscaping or pathways to delineate the rows and the ground is covered in grass. According to an inventory of the cemetery, the earliest burials occurred in 1915 with three buried that year. There are approximately 160 people buried in the cemetery. Markers in the cemetery vary in shape, size and material. There are markers of marble, granite, wood and native rocks.

There are two recent accessory structures added to the church property, an open-air pavilion, and a bathroom building. Both are non-contributing structures.

The open-air pavilion was constructed in 2002 and is 80' long by 25' wide. Metal box columns support I beams that form the roof structure (Photo #9). The roof is covered in metal panels. Under the pavilion are fixed tables supported by metal columns with plywood tops. The pavilion has a concrete floor.

The bathroom building was constructed in 2007 and is an 8' by 16' metal building. The building has a rear sloping shed roof with an overhang over the front elevation which has two doors for the bathrooms (Photo #10). The building and roof are both sided in metal panels. The doors are metal clad wood with six projecting panels.

Statement of Significance Summary Paragraph (Provide a summary paragraph that includes level of significance and applicable criteria.)

The Baptist Church of Christ at Sardis, completed in 1917, is located in rural Winston County approximately fifteen miles from the town of Louisville. It was built for and is still owned by the same congregation. The church is an outstanding example of vernacular church architecture, which over the span of its life has received only minor changes. The church is a single room and retains original features such as wood double hung windows, wood clapboard exterior walls, beaded board interior walls, original pine floor, and pews built specifically for the building. The Baptist Church of Christ at Sardis has maintained a high degree of historic integrity making it eligible for listing in the National Register of Historic Places under Criterion C - Architecture.

Narrative Statement of Significance (Provide at least one paragraph for each area of significance.)

Winston County was established on December 23, 1833 from territory that was acquired from the Choctaw Indians through the treaty of Dancing Rabbit in 1830.¹ It was named in honor of Colonel Louis Winston a surveyor and military commander in territorial Mississippi.² Louisville, the closest town to the church is located about 15 miles away and was laid off in blocks and lots in 1834.³ It was also named in honor of Louis Winston. Louisville was incorporated in 1836.⁴ It became the junction for several stage lines and was on the great mail route from Nashville to New Orleans.⁵ The railroad came to Louisville and Winston County in 1905.⁶ The first settlers of Winston County principally came from the Carolinas by way of Georgia and Tennessee.⁷ Baptists entered the county first and in 1834 a Baptist Church was established in Louisville.⁸

The congregation of the Baptist Church of Christ at Sardis was established the First Sabbath in July of 1883 when the Abstract of Faith, the Church Covenant, and the Rules of Decorum were adopted. At the first meeting of the congregation there were four females and three males. They also adopted the name "Sardis" for the church as well. 9

There is no reference in the church minutes as to the original location of the church. The church membership continued to grow over the years and by 1898 there were forty-seven male members and fifty-nine female members. In 1899 at the August meeting of the church it resolved itself into a committee to raise funds for the construction of a church and a building committee was appointed.¹⁰

On January 6, 1902 a deed was filed with Winston County for the sale of land from W.N. Haggard to Sardis Baptist Church. The plot of land was one acre and the legal description as follows: beginning at a point 70 yards south of the N.W. Corner of the N.W. ¼ of sec. 22, T14, R14, and running thence south 140 yards to the New Macon Road thence east along said road 35 yards thence North 140 yards thence West 35 yards to place of beginning containing one acre in N.W. ¼ of said sec. 22 T14, R14.

The next mention of the new church appears in the Saturday before the third Sunday in October 1902 minutes. It states that the collecting committee was to collect what money they could for the purposes of completing the new church, suggesting that the church was under construction by then. In the minutes on the Saturday before the third Sunday in January, 1903 the collecting committee was discharged suggesting that the church was complete by then. There is no reference in the minutes to the church congregation moving into the new church. The church minutes after May of 1904 have been lost.

According to church members the church that was built in 1902-1903 was destroyed by fire or storm and the present church erected in 1917 on the foundation rocks of the original church and was a replica of the earlier church.¹¹

The church built in 1917 is similar to other rural churches in Mississippi with its rectangular shape, high pitched front facing gable roof, and two symmetrically placed front entry doors. According to Mississippi architectural historian Richard Cawthon, it is a typical form for rural churches with examples in Mississippi that date back to the 1850s. Surviving examples include the circa 1855 Bethany Presbyterian Church near Centreville in Amite County (NR, 2003), and the 1854 Lebanon Presbyterian Church near Learned in Hinds County (NR, 1999). The 1905 Toxish Baptist Church (III) near Pontotoc in Pontotoc County was another example of the style; however, it has been demolished. Historic photos of that church show a very similar exterior and interior to the Sardis Baptist Church. It is difficult to determine how many churches of this rural vernacular style are left in Mississippi since they were built in rural areas and there is no centralized record of construction, the style used, or whether they remain today.

According to church members the church was built by carpenter and builder William Thaddeus Puckett who was also a church member. The pews and pulpit are original to the church and were possibly made by the builder of the church as well. The lumber used in the construction of the churches and pews came from logs grown in the community and milled at a local portable saw mill owned by J.W. Haggard, also a member of the church.¹⁴

The church is no longer being used regularly for church services. Members from the congregation still meet there for a Memorial Day service every year on the fifth Sunday in May or the first Sunday in June. Weddings, funerals, and family reunions still take place at the church.

The Baptist Church of Christ at Sardis is an outstanding and very intact example of rural churches that were built across Mississippi from the 1850s to the early 1900s. The wood frame, one-room church retains original siding, windows, interior finishes, pews, and pulpit. It has received only minor changes with the roof material, wood doors, and lighting. It remains in a very rural location, and there has been no development around the church so the rural quality of the site has not been diminished. The church is accessed from a long rural road and the church property itself is surrounded by dense tree growth, again giving it that rural quality.

The cemetery on the church grounds is also significant and tied directly to the church as members of the congregation are buried in the cemetery. The cemetery is to the rear of the church and is outlined by a decorative iron fence. The earliest burials in the cemetery date back to 1915 and burials are still occurring. There are approximately 160 grave sites in the






