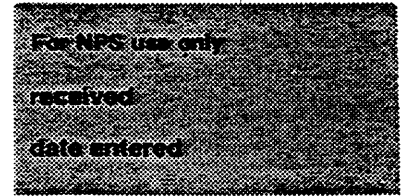

1. Name: Tom Eby Storage Building, survey number 21
2. Location: approximately 50' west of Highway 61 and 200' north of the Eby Ranch Road
4. Owner: Mrs. Leedro Eby, Route 15, Box 1017, Faywood, N.M. 88034
7. Description: Photo 64; rectangular; foundation unknown; stuccoed adobe; corrugated metal hipped roof with gablets (original flat earthen roofs remain in some sections); original windows closed in; 4 single doors.
8. Significance: This building began as a house for Simeon Eby who received the patent for his homestead in 1888. The building is a good example of New Mexico Vernacular construction in the valley and as such meets Criterion C. Its single file plan with a door to each room, adobe construction and hipped roof with gablets are all typical of this predominant historic type. The rooms are deeper than normal, however. After a new house was built nearby by Tom Eby, the building was used as a farm kitchen. In 1972, the windows were bricked in and the building devoted to storage.

Verbal boundary: A rectangle, roughly 40' by 60', formed by lines parallel to and ten feet from the exterior walls of the building. Since this is an unplatted area, this boundary has been created to include only the building.
