STATEMENT OF SIGNIFICANCE			VITTIN

THE PLAN AND DESIGN OF THE 2ND ST. JOSEPH COUNTY COURTHEOUSE WAS SUP-PLIED IN 1853 BY JOHN M. VAN OSDEL, CHICAGO'S FIRST ARCHITECT. IT IS IN MANY RESPECTS SIMILAR TO THE SECOND COOK COUNTY, ILL. COURTHOUSE DESIGNED BY HIM IN 1851.

THE COURTHOUSE IS IN THE GREEK REVIVAL STYLE. THE CENTRAL MASS OF THE BUILDING IS STRAIGHTFORWARD AND CLASSICAL IN ITS PROPORTIONS. CONSID-ERABLE LATITUDE OF DESIGN IS EXPRESSED IN THE DETAILS AND TRIM, AND IN THE PORTICO COLUMNS AND ENTABLATURE, WHICH ARE THINNER AND LIGHTER IN CHARACTER, MORE IN THE CLASSICAL ROMAN TRADITION. THE SIX FLUTED TWO STORY COLUMNS ARE PAIRED AND CENTERED; THE CAPITALS ARE OF A MODIFIED CORINTHIAN ORDER, THE LEAVES OF WHICH ARE LIKENED LOCALLY TO LEAVES OF CORN. THE COLUMNS ARE BRICK, FINISHED WITH CEMENT. THE WOODEN CUPOLA IS WELL PROPORTIONED, WITH AN AGREEABLE ARRANGEMENT OF FRIEZES, CORNICES AND VOLUTES (OGEE CURVES). THE PLAN, THOUGH NOW ALTERED, WAS TYPICAL OF THIS TYPE OF COURTHOUSE. CONSTRUCTION OF BRICK BEARING WALLS, FACED WITH "ATHENIAN MARBLE" (LEMONT LIMESTONE), WITH TIMBER FLOORS, INTERIOR WALLS, AND TRIM, WAS TYPICAL OF THE IMPORTANT STRUCTURES BUILT BOTH IN SOUTH BEND AND CHICAGO BEFORE THE FIRE.

THE OLD COURTHOUSE IS PROBABLY THE OLDEST BUILDING IN THE DOWNTOWN AREA OF SOUTH BEND, AND IS CERTAINLY ONE OF THE CITY'S FEW REMAINING GREEK REVIVAL BUILDINGS. IT IS ONE OF SIX CLASSICAL COURTHOUSES REMAIN-ING IN INDIANA. IT REPRESENTS AN INDIVIDUALISTIC APPROACH TO THE CLAS-SICAL REVIVAL STYLE, AND IS AN IMPRESSIVE AND STATELY BUILDING. THE FACT THAT IT WAS MOVED OVER AND TURNED AROUND ON ITS OWN BLOCK DOES NOT DETRACT FROM ITS SIGNIFICANCE AS A LANDMARK PIECE OF ARCHITECTURE IN THE DEVELOPMENT OF SOUTH BEND.

IT WAS BUILT WITH PRIDE AND GREAT EXPECTATIONS, WHICH IN FACT EXCEEDED ITS CAPACITY, AND WAS FROM THE TIME IT WAS BUILT UNTIL IT WAS MOVED IN 1896, THE CENTER OF INTENSE POLITICAL ACTIVITY. IT WAS A COMMUNITY GATHERING PLACE AND A POLITICAL PLATFORM, ESPECIALLY DURING THE CIVIL WAR AND THE ASCENDING CAREER OF SCHUYLER COLFAX, THE SOUTH BEND NEWS-PAPER EDITOR WHO BECAME VICE PRESIDENT UNDER U. S. GRANT. IN ITS ASSO-CIATION WITH THE PRE-CIVIL WAR AND CIVIL WAR PERIODS AND ALL THAT CAME TO PASS WITHIN THEM, IT BECAME A SYMBOL OF HISTORY TO THE PEOPLE OF THE AREA. THIS SYMBOLISM WAS REINFORMED BY LATER USE OF THE BUILDING AS G. A. R. HEADQUARTERS AND HISTORICAL MUSEUM, AND WAS TESTED SEVERAL TIMES WHEN PLANS WERE AFOOT TO CHANGE, MOVE OR DESTROY THE BLDG. NOW THAT THE DOWNTOWN AREA IS BEING MODERNIZED & ENLARGED, THE BLDG. REMAINS A UNIQUE LINK, A REAL & VISIBLE ONE, WITH SOUTH BEND'S EARLY HISTORY.
