The Fruge Store (c.1900) is a two story building sheathed in decorative pressed metal. Originally housing a general mercantile business, it is located on Main Street (now busy U. S. Hwy. 190) in the small community of Elton. Modifications to the store have been minimal.

As was typical of the period, the Fruge Store is a false fronted building. The parapet features a wooden cornice with small, simple brackets. The entire building is sheathed in sheets of pressed metal with a rusticated design in the manner of cut stone. A hipped canopy hangs from wires attached to the facade. Remarkably, the store retains its original wooden shopfront with cast-iron columns. The design features a display window with a recessed door on each side. The rectangular building's roof is ornamented with decorative ventilators.

The largely unaltered interior consists of a single large space with a balcony at the rear. At the extreme rear of the store on the ground level are three small rooms -- one used for storage, one for an office, and one used historically by customers to try on shoes. Builtin shelving along the sides features a heavy cornice and shelves supported by diminutive turned members in the Eastlake manner. (The same shelving can be found in the previously mentioned storage room.) The shelves stand atop counters which retain some of what appear to be historic storage bins below. Of great interest is a historic "rolling" ladder on the west side of the building. Attached to a track on the ceiling and with wheels at the bottom, it provided access to the higher shelves and allowed one to move easily from one end of the shelving to the other. The balcony, which provided additional retail space, is reached via a prominent flight of stairs at the center. The stairs and the balcony balustrade are original, featuring simple newel posts and turned balusters. The interior is sheathed in narrow gauge beaded board, and the wooden floors have not been covered, although they may have been patched and/or replaced over the years. Other interior features worthy of note are simple wooden interior support posts and one Grand Rapids showcase. The office features an opening with a ledge in the manner of a bank or depot ticket window.

Alterations since construction:

(1) Makeshift partitions have been placed in one front corner to create a smaller retail space. (The historic shelving in this area remains unharmed.)

(2) Historically the Fruge Store shared its awning with an adjacent building. (Although joined at the front, the two buildings were about three feet apart.) When the adjacent building was demolished in the 1970s, the Fruge Store awning was finished off at the corner in an appropriate manner.

(3) There is a small shed roof addition on the east side of the store toward the rear.

(4) Small horizontal windows on the western elevation have been covered with sheets of metal.

Assessment of Integrity:

The Fruge Store is a remarkably well preserved general mercantile store from the turn-of-the-century, complete with its original shopfront, shelving, "rolling" ladder, etc. While the partitions are unsightly, at least they have done no harm, and they could be quite easily removed.

The Fruge Store is locally significant in the area of commerce because it is one of very few buildings left to represent the commercial history of Elton. The current condition of downtown Elton belies the fact that during the historic period it was the commercial hub for northern Jeff Davis Parish. (The fifty year cutoff is being used to end the period of significance because Elton remained a commercial hub into the post-WWII era, and the store remained in business as a general mercantile establishment.)

Settlement of what would become Elton began in earnest in the late nineteenth century, paralleling the history of the parish as a whole. Like other towns in southwestern Louisiana such as nearby Jennings, most of the newcomers in the 1880s and '90s were from the Midwest. The economy was based largely on rice growing and milling. The small village received a great boost in 1906 with the coming of the railroad. In 1911, Elton was incorporated as a village. In 1921, its status was changed to that of a town, meaning that the community now had a population in excess of 1,000.

During the historic period, Elton was a commercial center for not only its residents but the surrounding agricultural area. The nearest other trade centers were Jennings (17 miles away), Kinder (12), and Oberlin (15). The only available Sanborn map, for 1920, shows a four block downtown with some 20-25 commercial establishments along Main Street, now U. S. Highway 190. Early twentieth century photographs depict a bustling small town downtown whose Main Street was lined by one and two story frame false-front buildings. There were several general stores, a bakery, drugstore, hotel, bank, etc.

Sadly, there is not much of old downtown Elton remaining. Some of the buildings shown in old photos were lost long ago to fire while others were undoubtedly torn down within more recent times. Today's downtown is on the decline, with the majority of buildings being vacant. There are only four or five historic commercial buildings remaining, most of which, if not all, are vacant. As one of these survivors, the Fruge Store is of great importance to represent the commercial history of the town. In addition to being a general mercantile store, it served as the small town's bank during the Depression and into the postwar years. Elton's bank closed in 1933, and a bank did not reopen in the community until the early 1950s. During this period Ix Fruge, the proprietor, cashed paychecks from the previously mentioned office window.

Historical Note:

The exact date of construction for the store is not documented. The earliest record is a 1912 photo of downtown Elton showing the building. The store was purchased in 1926 by Osborn Ix Fruge, who formed a partnership with his father-in-law, Henry Savoie, and operated a general mercantile store under the name of Savoie and Fruge. In 1945, the present owner, Leo H. Fruge, the only son of Ix Fruge, joined the business and named it Fruge and Son. Ix Fruge died in 1976, and his son operated the store until his retirement in April 1994. Today the building is vacant.
