Description:

The south-facing Eastman-Lord House is a two-and-a-half-story, side-gable, I-house initially constructed as a cape c1818 and added to in c1849 to result in its current configuration. Extending from the northeast corner of the main block is a two-story gable-front ell. The buildings rest on granite foundations, are sheathed in clapboards, and terminate with a metal-clad gable roofs.

The main block is five bays across and one bay deep, the center entry is recessed slightly and framed by paneled reveals. The wood paneled door is flanked by half-length sidelights. A late-19th century Queen Anne entry porch shelters the doorway; it has a hip roof supported by turned posts with decorative brackets, the balustrade has turned members and a low railing. Windows are mostly two-over-one double-hung sash; the attic is lighted by mid-19th century six-over-six sashes. All are flanked by louvered blinds. (Historic views show the use of nine-over-six windows even after the entry porch was constructed.)

Along the rear of the main block is a one-and-a-half- story, full-width shed-roofed element supported by rubble and sheathed in clapboards. Its roof continues the line of the main block's rear slope. Fenestration consists of a wooden door (not accessed by any steps) on the western-most bay, and four windows including nine-over-six, two-over-two, and one-over one sashes.

The two-story ell to the northeast of the main block is gable-front in orientation. It is the product of two building campaigns. The rear section was previously a free-standing building which housed a the general store Eastman operated during the 1830s. During the mid-19th century, the front section was constructed, connecting the rear building to the main block. There is an entry door on the west (left) bay of the façade, and a three-sided bay projection with hip roof on the east bay. The two second-story windows are two-over-one sash; the single gable window is six-over-six. Windows elsewhere on the ell are two-over-one, six-over-six, and nine-over-six, with a late 20th century three-part window on the rear (north). On the east (side) elevation, there is a door sheltered by a simple one-bay gabled porch. A mid-20th century single cell addition on concrete foundation extends eastward from the rear of the ell.

The balance of the lot is grassed and includes mature trees, lilacs, and evergreen shrubbery.

Significance

The William K. Eastman House at 100 Main Street in Conway, New Hampshire is eligible for the National Register of Historic Places under Criterion B for its associations with William K. Eastman (1794-1887), a prominent citizen and businessman of Conway. Its period of significance is 1818, the date of construction, to 1879, the years of Eastman's occupancy. Eastman built this house just after his marriage and resided there throughout a 65-year career in business and community service. It is the only structure surviving with associations to his active career, his first tannery and later mills having been lost to demolition and fire. (Eastman's original tan yard was operated by Christopher W. Wilder from 1850 to 1875, who did harness-making and carriage-trimming there. By the early 1880s it had become quite weatherbeaten and was demolished. The straw board mill burned, probably around 1890. The site of his store does survive, as the rear section of the side ell of the house.) The house retains integrity of location, design, setting, materials, workmanship, feeling, and association for Eastman's occupancy. The only significant changes have been the introduction of a one-story, one-bay Stick Style entry porch, likely added in the 1880s and a single cell addition at the rear of the side ell, which do not effect the house's ability to convey its associations with Eastman.

William K. Eastman was born in Loudon, New Hampshire in 1794, the fourth child of David and Ruth (Whittemore) Eastman. He attended Loudon schools and later high school in Concord, during several winters. After a one-year apprenticeship at a Concord bakery, he left for Limerick, Maine where he learned the trade of tanner and currier.

Eastman came to Conway in 1814 where he settled and would live for the next 65 years. In 1816 he married Rhoda Messer of Loudon. They moved into a small house near the tannery and began the construction of a permanent home, the William K. Eastman House, at 100 Main Street, across the road from the tannery. The house was completed c1820.

Eastman initially established himself as a tanner on Pequawket Pond. He continued at the site until c 1834, adding shoe-making and harness-making to the business in 1827. He operated a general store at his home during the 1830s. It was located in a building to the east of the house that was later connected to the house by an addition constructed in the mid-19th century.

About 1845 he built a mill on the lower Pequawket Power Privilege to produce straw board, a rough board used to make boxes and book covers. (That mill burned shortly after, as did the factory that replaced it.) At the new location, sons Hasket D. and William W. Eastman were in partnership with their father as William K. Eastman and Sons.

In 1853 William K. Eastman and Sons purchased the Jonathan Chase wool-carding and cloth-dressing mills on the east side of the Pequawket stream. They were enlarged and operated by the Eastman company until 1865 when they were reorganized as Eastman (Hasket) and Pendexter (Daniel E.).

Eastman's wealth and prominence grew over the years. He was a respected businessman known as William K. Eastman, Esq.. Not only did he have many business interests, he held local and state offices including deputy sheriff, selectman, juryman, coroner, state representative for two terms; was a lieutenant in the militia, delegate to Democratic state conventions, and part of a delegation meeting General LaFayette in 1825. During the Civil War, was a founder of the Conway Methodist Society and also a founder of the South Conway Seminary, a school of excellent reputation serving students in the grades beyond those available in the municipal system. In 1840 he was one of fifteen men in Conway wealthy enough to own a four-wheel chaise. Eastman owned a 300 acre farm that was valued at \$2000, according to the 1860 agricultural census. Other 1860 inventories indicate he owned a house, barn, shop, and store on eight acres as well as two cows, a horse, small farm, house and lot occupied by C.W. Wilder, interest in Eastman and Pendexter and stock in trade – all valued at close to \$5,000.

After his wife's death in 1870, Eastman lived on in the house with his daughter Caroline Eastman Barnes and her family for nine years. In 1879 he sold everything and moved to Minneapolis where a number of his family had successfully established themselves in the preceding years. He remained there the rest of his life, residing with his son Hasket. William D. Eastman passed away October 18, 1887. He was buried in Conway next to his wife.

Civil War veteran George Heath of Conway purchased the house in 1879, residing there until his death in 1900. The Kennett Family owned the house very briefly,

then selling it to Mary Daniels Lord (wife of Eben Lord, at one time a box maker) who ran a millinery shop there. The house next passed to the Lords' son, Robert

Raymond Lord, a night watchman for the Conway Fire Department. Lord gifted the house to the Conway Historical Society in 1962. He retained life tenancy and occupied a small apartment partitioned off from the rest of the interior. After Lord's passing, in the late 1980s, the house became a very active museum and cultural center. It has continued to grow increasingly more vibrant with important collections and publications to its credit.


