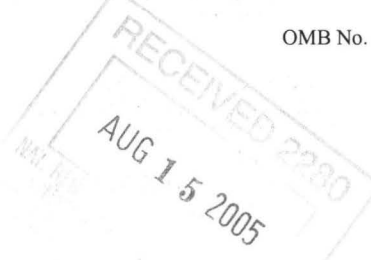

SUMMARY

The Melvin Chrisco House constructed in Damascus in 1947 is an example of the Minimal Traditional–influenced Mixed Masonry style executed by Silas Owens, Sr. The Mixed Masonry one-story structure is characteristic of Owens' herringbone pattern created from cut sandstone complemented by extensive cream brick detailing surrounding doors and windows and exhibits Craftsman architectural details in keeping with the era in which it was constructed.

ELABORATION

The front, eastern façade of the Melvin Crisco House is dominated by a double-arched, gabled porch at the northeast corner, with both arches lined with cream brick. Beneath the apex of the front-facing gable, a square louver is surrounded on three sides with Owens' three-three pattern of cream bricks resting on a brick ledge forming the fourth side of the square. Under the porch, a pair of double-hung two-over-two aluminum replacement windows is located to the north of the structure. Proceeding south, the main entrance to the house is via a single wood front door with a diamond-shaped window protected by a three-part aluminum storm door. Beyond the front door is an additional wood door. The front porch features vernacular folk art in the marbles set in concrete around the name of the original owner, Melvin Chrisco. On the southeast corner of the front façade is another pair of double-hung two-over-two aluminum replacement windows, again outlined in cream brick with the lower edge forming a brick window ledge. The gabled front porch joins the house at a larger front-facing gable covering the southern window pair.

The southern elevation is fenestrated east to west by two pairs of double-hung, two-over-two windows replicating the eastern façade, followed by a smaller single two-over-two, double-hung window. A rear room was added after the initial construction which features a matching double-hung, two-over-two window set in the vertical board-sided addition. The roofline features a cross-cut gable protruding from the hipped roof over the second pair of windows in the original structure. Above this pair of windows is a rectangular louver surrounded by cream brick detailing near the peak of the gable. Owens' trademark herringbone pattern created in the intricately cut and laid rock is visible on the southern wall to the west of the second pair of windows.

The rear, western elevation consists of a vertical board-sided rear room on a concrete block foundation. Two single-hung, two-over-two aluminum replacement windows flank the rear elevation which is capped by the hipped roof of the house.

From west to east, the northern elevation of the house is partially shielded by a free-standing carport and storage shed addition to the property. The carport/shed structure is considered non-contributing due to its dropped ceiling, gabled end, and vertical board siding. A secondary single-leaf entrance to the house is located at the western corner of the northern wall, followed by a single-hung, two-over-two window surrounded by cream brick. A cross gable intersects the hipped roof at mid-point on the northern elevation under which two pairs of two-over-two, double-hung aluminum replacement windows exist. A rectangular louver, identical to that on the south elevation, is in the apex of the cross gable on the northern wall. The front porch wraps around from the front façade to the northern elevation featuring a cream-brick-lined arch that provides access to the front porch and main entrance to the house. Most notable about the northern elevation is the distinct herringbone pattern created from sandstone rocks that is a trademark of the masonry of Silas Owens, Sr.

Integrity

The Melvin Chrisco House in Damascus is a good example of Silas Owens, Sr.'s, trademark herringbone pattern created on his Mixed Masonry structures. Additionally, the Chrisco House retains its integrity due to the lack of alteration or visible additions. Original fenestration design remains, as well as the characteristic arched arcade utilized frequently by Owens in his construction.

Criterion C: Architecture, Local Significance

SUMMARY

The Melvin Chrisco House is being nominated to the National Register of Historic Places under Criterion C with local significance as a fine example of a Mixed Masonry residential structure built in the Minimal Traditional style by Silas Owens, Sr., an African-American mason in rural Van Buren County. The house, located in Damascus, was built in 1947 and exhibits several distinctive characteristics of the craftsmanship of Silas Owens, Sr. Cut sandstone interspersed with cream-colored brick trim surrounding doors, windows, and on chimneys are hallmarks of Owens' work, as well as arched arcades and a rough herringbone pattern within the laid stone. The Melvin Chrisco House is being nominated to the National Register of Historic Places under the multiple property listing, "A Storm Couldn't Tear Them Down: The Mixed Masonry Buildings of Silas Owens, Sr., 1938-1955."

ELABORATION

Melvin Chrisco commissioned the construction of a Mixed Masonry house in rural Van Buren County in 1947. Silas Owens, Sr., was hired to build the residence in the Minimal Traditional style with Craftsman architectural detailing. When the cast concrete front porch was poured, Chrisco etched his name into the wet concrete with the date August 29, 1947.

Melvin Chrisco sold the house to Joe Brown of Damascus before moving from Arkansas to California. Joe Brown sold it to his brother, Doyce Brown. Mr. Brown and his family have occupied the house since the late 1940s. Upon moving in, according to Doyce Brown, the house had no running water. Plumbing and an interior bathroom were the first additions made to house after the Brown's acquired it from Chrisco. The rear room addition was built to house the bathroom and provide space for Brown's growing family.

In the 1970s, Doyce Brown replaced the original windows with aluminum-framed windows, but did not alter the fenestration patterns constructed by Silas Owens, Sr. Mr. Brown reports that the carport was extant when he purchased the house from Melvin Chrisco. He has since added a shed roof storage room onto the rear of the carport.

Doyce Brown was a dairy farmer until he retired. Brown's Dairy in Damascus is still a family-run business, operated by Mr. Brown's son, Robert Brown. The house is set to pass onto Robert when he retires from the dairy. The Brown's hope to keep the Melvin Chrisco House in their family into the future.

Statement of Significance

The Melvin Chrisco House is being nominated to the National Register of Historic Places under **Criterion C** with **local significance** as a good example of Mixed Masonry constructed by Central Arkansas craftsman Silas Owens, Sr., in Van Buren County. The rural location of the structure on an auxiliary road in Damascus contributes to the overall significance of the structure which has not been affected by sprawl or shifting patterns of land use. The superb craftsmanship demonstrated in the stone coursing and arched arcade is complemented by the folk art detailing of glass marbled set in the front façade's mortar. The Melvin Chrisco House is being nominated under the multiple property context, "A Storm Couldn't Tear Them Down: The Mixed Masonry Buildings of Silas Owens, Sr., 1938-1955."

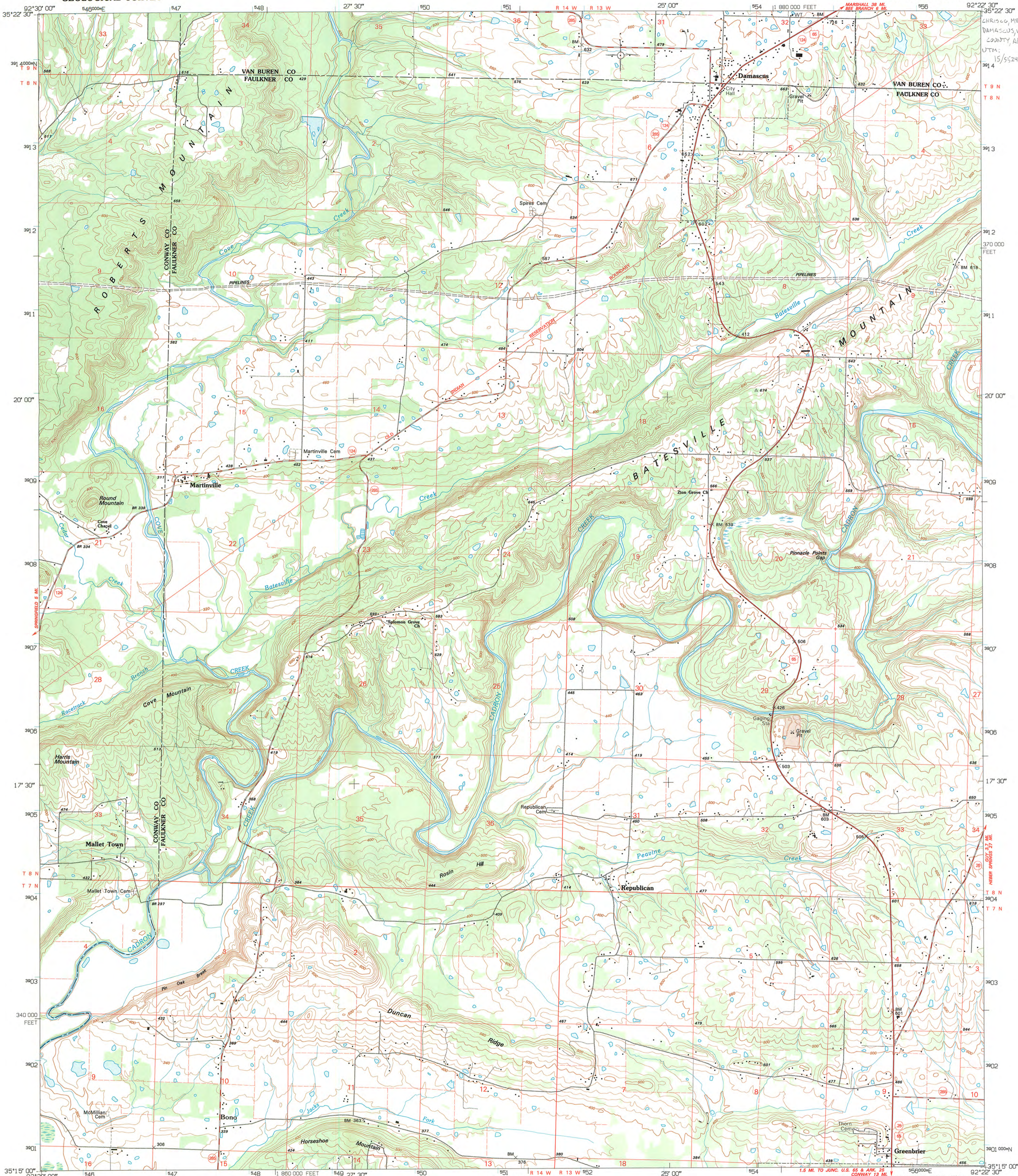

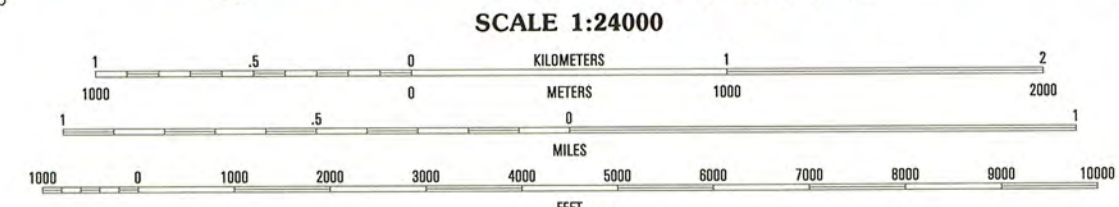
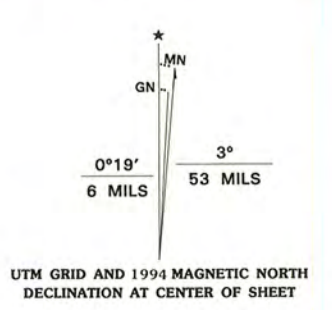
