Hastings, "Queen City of the Plains" (2000 Pop. 24,064), is located in the heart of south central Nebraska. It lies 100 miles west of the state capital, Lincoln. Hastings is an urban oasis among vast agricultural areas, livestock lots and rolling hills covered with prairie grass swaying gently in the seemingly constant wind. Fifteen miles of divided highway connects north Hastings to Interstate 80. This divided highway becomes a four lane main artery through Hastings. This tree-lined thoroughfare, Burlington Avenue, makes a captivating first impression of the Central Hastings Historic District, providing a sample of treasures to be found to the east or west of this avenue.

Uniformly set back behind tree-lined, terraced Avenues stand 319 diverse properties uniting to create the Central Hastings Historic District. These historic properties provide a cohesive physical document of community development that occurred from 1880 until 1950. The District is comprised of approximately 30 city blocks, and the street patterns of the District are decidedly linear, which generally creates a uniform visual rhythm within the district. Garages and backyard sheds were not evaluated and are not included in resource counts or property descriptions.

The Central Hastings Historic District is located between Colorado Avenue, west to Bellevue Avenue and 7<sup>th</sup> Street, north to 12<sup>th</sup> Street with the 600-800 blocks of St. Joseph, Kansas and Colorado Avenues being excluded due to the presence of Mary Lanning Memorial Hospital. Highland Park, which is the setting for the spectacular Rainbow Fisher Fountain, completes the boundary to the north with Lincoln, Hastings, and Denver Avenues terminating at the park. Alexander Square, a city park, is located at 7<sup>th</sup> and Lincoln Avenue.

The Avenues canopied by mature trees include sidewalks that are set back from the road by deep terraces that give the pedestrian an inviting view of the well maintained residences and properties of the neighborhood.

The architecture within the Central Hastings Historic District represents all economic and social levels from each period of growth that began in the 1880's with the Victorian Era. Modest one-story houses with Queen Anne features resided on the same block with more elaborate two-story Italianates. The same is true with all the styles of architecture that followed. The Arts and Crafts Period of the early 1900's through the 1920's integrated modest catalogue ordered bungalows with high-style architect designed Craftsman houses, resulting in a uniquely blended neighborhood. This eclectic and intact collection of historic properties creates a significant and cohesive historic district.

Following are examples of some of the houses that represent the span of community development occurring within the Central Hastings Historic District.

The elaborate residence at 1000 W. 9<sup>th</sup> was built in 1886. Constructed as a two-story clapboard house with a one-story warp around porch, it uniquely exhibits and blends Victorian elements to create an elegant piece of art.

The stately two-story clapboard residence at 722 N. Hastings was constructed in 1885 with elements characteristic of the Italianate style such as a low-pitched hipped roof, bracketed eaves, wrap around one-story porch and projecting side bay.

The asymmetrical Victorian two-story house at 749 N. Lincoln Ave. was built in 1888. Typical of the Queen Anne style, it has many intersection roof lines, bands of differing materials, projecting bays, wooden wall cladding and an Eastlake inspired wrap around porch.

The Victorian Era 2 ½ story masonry residence at 1119 N. Denver was built in 1888. Its many interesting roof lines, projecting front gabled bay, partial porch and tall, narrow windows combine to create a solid and impressive result.

The prominent two-story masonry residence at 1018 N. Burlington was built in 1928. Its use of Colonial Revival elements such as symmetry, accentuated entry, portico with classical detailing and side gabled roof create an orderly visual effect.

850 N. Burlington was constructed as a two-story brick residence in 1922. The combination of Colonial Revival elements gives this house a dignified presence on Burlington Avenue.

The Masonry residence at 907 N. Burlington was built in 1908 to reflect the Craftsman style of the Arts and Crafts Period. The simplistic Bungalow elements are combined to create a sturdy, natural and cozy appearance.

This small-scale masonry Bungalow at 806 N. Lincoln combines Craftsman style features such as an open full width porch supported by massive tapered columns and a cross gabled effect with braces under the eaves to create a stable and harmonizing result.

The solid two-story masonry residence in the 800 block of N. Lexington with its enclosed one-story porch, two broad front gables and braces under the eaves showcases the artistic simplicity of the Craftsman Style which dictates the architecture of this sturdy house.

The two-story masonry residence at 916 W. 9<sup>th</sup> Street was built in 1930. It utilizes the refined simplistic elements of the Prairie Style to exude a quiet and dignified presence.

The foursquare masonry residence at 1128 N. St. Joseph blends elements of the Prairie style to create a strong and cohesive visual effect.

Constructed in 1909, the elaborate foursquare residence at 815 N. Lincoln adapts detailing from the Colonial Revival style to portray classical balance, order and strength.

The small-scale masonry house at 1105 N. Hastings with its steep gables was built in 1940. It is a vernacular transitional house utilizing elements from the Tudor style, resulting in the warmth and charm of an English cottage.

The masonry house at 1124 N. Lincoln was built in 1929 drawing upon the French style to create an elegant visual statement.

The one-story residence at 901 N. Lincoln built in 1949 is a Modern Ranch house that utilizes a sense of small-scale, low hipped roof, overhanging eaves and angled plan to create a grounding harmonious effect with much visual interest.

842 N. Lincoln is a vernacular masonry residence that features modified stylistic elements to create a solid and stately effect.

The one story residence at 910 West 10<sup>th</sup> Street is a simple vernacular house. It displays Queen Anne elements through the use of differing wall materials, corniced windows and varied rooflines to create a quaint and subtle appearance.

There are three apartment buildings within the neighborhood. Madgett Flats provides a grand presence at 827-831 N. Hastings. It is a 2 ½ story masonry structure with a projecting front bay that utilizes elements of the Victorian Era. Maryland Apartment's well-ordered appearance results from the use of classical elements when constructed in 1928. The masonry urban row houses at 801 N. Hastings offer a unique flare within the neighborhood.

One contributing site, Alexander Square, is located on the northwest corner of 7<sup>th</sup> and Lincoln Avenue. This park was deeded to the city in 1937 as a memorial to the pioneer Samuel Alexander family. A WPA era shelter and an associated shed constructed in 1938 are contributing structures. Each structure is constructed of limestone and is rustic in nature. The shelter, with a steep hipped roof with exposed rafters and diagonal timber supports, was placed on a diagonal axis near the rear of the lot and has built in concrete benches.

The Central Hastings Historic District is locally significant under Criterion A: Community Planning and Development. This District represents and documents the development of Hastings from 1880-1950. The structures found throughout the district represent a significant pattern of development that mirrors the growth of the City of Hastings during the period of significance.

The earliest residences in what would eventually become Hastings, a dug out and a sod house, were constructed just prior to the city's platting in 1872. That fall the St. Joseph and Denver City Railroad crossed the Burlington line and Hastings was soon transformed into the commercial hub of central Nebraska with a population of 2,847 in 1880.

North Street, now Seventh Street, was Hastings' original northern boundary. The Central Hastings Historic District extends from Seventh Street north to Twelfth Street, and from Bellevue Avenue on the west to Colorado Avenue on the east. In 1872 Samuel Alexander homesteaded the quarter section extending north from Seventh Street. He built the second frame house and the first store building as well as served as the first Hastings postmaster.<sup>1</sup> In January 1878 Alexander's First Addition to Hastings was platted from a portion of his homestead.<sup>2</sup> By 1880 15 homes had been built in the proposed historic district. Hastings had passed through its frontier period and settled down to a decade of growth, which has never since been equaled.

During the decade of the 1880s Hastings grew from a raw prairie town into a city. The Kerr Opera House was built in 1884, the Bostwick Hotel opened in 1885, Parkview Cemetery and the city water works were established in 1886. Large brick blocks, including the 1886 Masonic Temple block, were constructed downtown. Hastings, like much of Nebraska, owed its existence to railroads and railroad fever was raging. By 1887 five railroads served Hastings and there were rumors of several more to come.

Influenced by the demand for housing lots, adjacent landowners quickly surveyed their land for inclusion in the town's boundary. Between 1878 and 1887 all of what is now called the Central Hastings Historic District was platted and annexed. Houses were constructed at a rapid rate with an estimated 700 homes built in Hastings between 1884 and 1887. It was during this period that large frame houses, conspicuous in size and design, were erected in the historic district. These houses were constructed primarily for land speculators and moneylenders. The residential blocks were not as densely occupied as they are today. The average per block density at that time was three houses per block. Often large residences were placed at a distance from their neighbor in order to entice others to build homes on nearby grounds usually owned by the same developer.<sup>3</sup> The large frame Victorian house at 1000 West Ninth Street was built at this time.

The demand for building materials for the many rural and urban buildings being constructed in the area resulted in the establishment of two sash, door and blind factories in Hastings during the 1880s.<sup>4</sup>

In 1887 Hastings experienced a huge real estate boom fueled by speculation of railroad construction. From January to March, transfers of land ranged from \$50,000 to \$100,000 a day. Lots that sold in February for \$300 to \$500 increased to \$1,200 to \$1,800 each in June. Hastings was filled with speculators from the East. In July the boom ended. Prices declined by as much as 75 percent; and a number of Hastings businessmen left town to try to recover their fortunes elsewhere.<sup>5</sup>

In an attempt to stimulate investment, the Queen City Land Company published a 95-page booklet in 1891 extolling the benefits of investing in the Hastings area. Woodcuts of many large Hastings homes, including fourteen still standing in the Central Hastings Historic District, illustrated the booklet.

During the mid 1890s Hastings along with much of the country suffered a depression. A number of businesses and industries closed, and the farm population as well as that of Hastings declined. Mortgages on many of the large homes constructed during the boom of the 1880s were foreclosed and some houses stood empty. Several vacant houses were moved outside the city.

The two Hastings architects who had the greatest influence on the historic district were C. C. Rittenhouse and C. W. Way. C.C. Rittenhouse, Adams County's first practicing architect, influenced the appearance of Hastings before 1900. He designed many buildings and houses in the city between 1877 and 1895, when he moved to the West Coast. Three of his buildings are on the National Register of Historic Places: the Farrell Block, and the Nebraska Loan and Trust building, both downtown, and McCormick Hall at Hastings College.

Michigan native, C.W. Way arrived in Hastings at age thirty-six in 1906. He established an architectural practice that led to contracts for most of the prominent buildings in the city in the next generation. His versatility as an architect is evidenced by the range of his designs: he directed construction of everything from the towering Clarke Hotel to gas stations to private homes in Hastings. Two of his buildings, the Clarke Hotel and Dutton-Lainson's Victory Building are on the National Register of Historic Places.

By 1900 the depression was over and building resumed. Judge Burton credits Mayor C. J. Miles who was elected in 1902 with helping turn Hastings' fortunes around. Beginning with the Miles administration the businessmen, reinvigorated by new blood and assisted materially by good crops and advancing prices for farm products, worked to make use of the possibilities that confronted the city and ushered in a period of substantial growth.<sup>6</sup> Hastings population increased steadily during the first three decades of the twentieth century. The city's population reached 9,339 in 1910, 11,647 in 1920 and 15,490 by 1930.

In 1902 the new B & M Railroad depot opened to the public on First Street. Designed by Thomas Rogers Kimball in the Spanish Colonial Revival Style, one of its features is a tile roof. The building was much admired by Hastings citizens, some of whom had tile roofs installed on their 1880s era frame houses.

The dominant house style during the first decade of the Twentieth Century was the American Foursquare, a basic box configuration that was a response to the extravagance of the Victoria Era. John Kipp owner of the Kipp Cigar Company built his home at 815 North Lincoln Avenue in 1909. It is an elaborate foursquare with Colonial Revival style detailing

The December 31, 1911 *Hastings Tribune* proudly pointed out the following statistics for the city: more bricks and cigars manufactured in Hastings than elsewhere in Nebraska; the biggest harness and collar manufacturing plant in Nebraska, lowa or Kansas; the second-biggest brewing and artificial ice plant in the state; the third largest foundry business, building supplies company and candy manufacturing plants in the state.<sup>7</sup>

The Great War broke out in Europe in 1914 resulting in increased demand for food products and higher prices for grain, horses and mules. The booming agricultural economy of the years up to 1920 enriched many Hastings merchants

resulting in the construction of large expensive homes in the area between ninth and twelfth streets. Many of these homes were constructed of brick from the four Hastings brickyards. A. R. Thompson, a banker, built his large impressive Arts and Crafts style home at 1136 North Saint Joseph Avenue in 1915.

Another factor in Hastings economic growth during the 1920s was the development of a large wholesale industry. Railroad lines radiated out of Hastings like spokes in a wheel enabling Hastings to serve a larger territory in a shorter time. Hastings location on the east-west DLD Highway, later Highway 6, and on Highway 281 running north and south, was another important factor. In 1929 the manager of the Paxton and Gallagher Company reported that he had seen business volume increase five hundred percent in seventeen years in Hastings. He attributed that increase to improved roads and the use of trucks. To promote better housing development, Hastings passed its first zoning ordinance in 1928.

The two-story brick Colonial Revival house at 850 North Burlington was built in 1922 by G. R. Dutton of the Dutton-Lainson Company. It is typical of the fine homes built during the 1920s in Hastings by businessmen involved in wholesale distribution and manufacturing.

Hastings population decreased and housing construction slowed dramatically during the depression of the 1930s. No new homes were built in the historic district in 1934 and 1935 and during 1936 and 1937 only two were built each year.

A new Union Pacific Railroad overpass was constructed for Highway 281 at 16<sup>th</sup> Street and Kansas Avenue in 1936, and the highway was rerouted down Burlington Avenue from its old Hastings Avenue location. The location of a busy fourlane highway in a residential area would disrupt the residential character of the historic district in later decades.

Alexander Square, the small park at Seventh Street and Lincoln Avenue, was deeded to the city in 1937 as a memorial to the pioneer Samuel Alexander family whose home had stood on the site. The Works Progress Administration erected a rustic shelter that still stands in the park.

By 1939 Hastings was coming out of the depression and 48 new residences were constructed that year, ten of them in the historic district. In 1940 Hastings had a population of 15,145, down 345 from 1930. English Cottage style homes, like the one at 1105 North Hastings Avenue, were built as infill in the historic district at this time.

The year 1942 brought to Hastings the most startling changes it had known since its boom years of the 1880s. On June 10<sup>th</sup> the United States Navy announced that it would built a \$45 million ammunition plant southeast of Hastings. By the end of the year the town was strained to house thousands of newcomers flocking in to work at the Naval Ammunition Depot being built east of town. This caused a shift in location of new construction within Hastings. In February 1942 a Chamber of Commerce survey located 268 vacant houses and apartments in Hastings; in June the city began planning how to house thousands of new residents and the city council established regulations for trailer parks.<sup>8</sup>

By 1943 Hastings' population had increased to an estimated 22,252, a 47% increase in less than a year. Rents skyrocketed from \$35 a month to \$70 a month.<sup>9</sup> The Office of Price Administration imposed rent controls in 1943. During the war years many of the large 1880s era houses were converted into apartment buildings. After the end of World War II, depot employment declined dramatically and the demand for housing in Hastings also decreased. During the 1950s and 1960s several of the stately old Victorians, which had been over used and poorly maintained, were demolished to make way for modern construction.

H. L. Haberman built the one-story Modern Ranch style house at 901 North Lincoln Avenue in 1949. It is the most recent contributing structure in the Central Hastings Historic District.

Settlement within the Central Hastings Historic District began in the prosperous 1880's when Hastings original northern boundary, 7<sup>th</sup> Street (then called North Street), was crossed to create the city's first suburb. With this expansion, new land was plentiful and lots were large with typically three houses to a block. After the depression of 1890's, recovery began with new construction in the District around 1905. The large lots of the Victorian Era were subdivided to accommodate new the growth that occurred until the end of the 1920's. Following the Depression of the 1930's and the arrival of the nearby Naval Ammunition Depot in the 1940's, times were prosperous once again with economic growth and increased population. Transitional period homes were squeezed in between the Victorian and the Arts and Crafts homes within the District to accommodate this new development. The patterns of development blend well with consistent setbacks and unity among different periods of growth to relate a rich and complete story about the history of growth in Hastings.

The Central Hastings Historic District is locally significant due to the unique story that it conveys about the growth patterns in Hastings. This District would fall under Criterion A: Community Planning and Development. The District represents and documents the development of Hastings from 1880-1950. The diverse architecture results mainly from two significant periods. The Victorian Era of the 1880's and the Arts and Crafts Era from 1900 through the 1920's. This architecture is well blended creating visual harmony. This unity results from the visually rhythmic streetscapes composed of sidewalks separating mature tree lined terraces and uniformly set back houses. The District is intact with all economic levels of each significant period represented, creating an accurate and integrated story. This District displays integrity through the ability of the diverse architecture to unite and convey a harmonious and intact physical document of this community's development.

The Central Hastings Historic District has excellent integrity of location, setting, feeling and association. The District's integrity of design, materials and workmanship is very high. Non-contributing properties within the boundaries of the district detract somewhat from the overall integrity of design, materials and workmanship. However the vast majority of non-contributing properties are not intrusive to the district's historic character in that they retain their massing, siting, setback and, in most cases, materials. Most are considered non-contributing due to inappropriate additions that do not intrude upon the overall streetscape, large-scale and inappropriate fenestration changes or high levels of historic materials removal. Very few non-contributing buildings were constructed outside the district's period of significance, and none could be considered intrusive in nature. Overall, the District retains excellent historic integrity.
