STATEMENT

The Linden is one of a number of large apartment blocks built in Davenport at the turn of the century (see thematic discussion). Like many of these, the Linden displays a modified Federal style facade of clean lines, rectilinear forms, and lightly-detailed cornice and frieze. The entrances feature round-arched doorways with fanlights set within trabeated frames of pilasters supporting full entablatures. The two-story oriels are similar to those found on a number of turnof-the-Century buildings on nearby West 3rd Street (see W. 3rd St. District), and are a departure from the full-height polygonal window bays featured on many other examples of this building type in the survey area.
