## **Summary Paragraph**

Located west of the community of Pickens, the James Martin Baggs Log Barn is located near the intersection of N4480 and Baggs Trail on the southwest corner. It faces east onto N4480 and is surrounded by open fields to the south and west. The log transverse crib barn rests on a stone pier foundation. Located in the center of the barn, aligned with the ridge axis, is an aisle with cribs on either side. Shed roof loafing sheds extend from the north, west and south elevations. Due to its excellent condition, the barn maintains its historic integrity.

### **Narrative Description**

The east gable-end elevation of the barn faces onto N4480 Road. This elevation serves as the façade of the barn. It contains a rectangular opening, centered on the gable axis. Located on either side of the aisle are the cribs constructed of logs with a modified half dove tail. The gable end has shiplap wood siding. The only other opening on this elevation is on the east wall of the south crib. It is a small rectangular opening that has the appearance of a window but is really a loading portal for the cribs.

The north and south elevations are identical. Each elevation is concealed by a shed roof loafing shed. The crib walls are constructed of logs with a modified half dove tail. The roof structure is supported by vertical logs.

The west elevation contains a rectangular opening, centered on the gable axis. Located on either side of the aisle are the cribs constructed of logs with a modified half dove tail. The gable end has shiplap wood siding. The west elevation has a shed roof loafing shed that connects to both the south and north elevations. The west elevation of the loafing shed has horizontal wood boards that serve to contain animals in this area.

The interior of the barn is composed of two round log cribs. The ridge axis aisle is 10 feet 6 inches wide. The cribs are all un-chinked and thus were used for cob corn and peanut storage. The south cribs each have a batten door providing access to each individual crib. The cribs measure 15 feet long by 8 feet wide by 8 feet in height. The cribs store approximately 770 bushels. The north crib has three batten access doors providing access to stalls. The stalls measure 9  $\frac{1}{2}$  feet long by 9 feet wide by 8 feet in height. The barn also has a partial haymow.

No significant modifications have been made to the visual appearance of the barn other than the application of corrugated galvanized steel sheeting to the roof. The final dimensions of the barn are 28 feet from north to south and 32 feet from east to west. The loafing sheds add 9 feet to the north, south and west elevations.

**Statement of Significance Summary Paragraph** (Provide a summary paragraph that includes level of significance, applicable criteria, justification for the period of significance, and any applicable criteria considerations.)

The James Martin Baggs Log Barn is significant at the local level under Criteria C for its architectural style. The period of significance is 1909 when the barn was constructed. The property is an exceptional log Transverse crib barn that remains in excellent condition. The Transverse crib barn replaced the four-crib barn plan to become the ubiquitous folk barn type of the Upland South however, in the survey of the State of Oklahoma, only two log examples were identified state-wide; the other is the Jerry Baggs log barn located in the Cloudy Vicinity. Prior to the comprehensive barn survey of Oklahoma, it was believed that this barn type did not exist in Oklahoma.

Narrative Statement of Significance (Provide at least one paragraph for each area of significance.)

The James Martin Baggs Log Barn is an exceptional example of a Log Transverse Crib Barn representing early twentieth century farming and ranching in southeastern Oklahoma. After 1950 agriculture in Oklahoma had become largely mechanized and began to intensify and specialize enough that general-purpose barns, especially log barns, became increasingly obsolete. Unlike frame constructed barns, log barns could not be easily electrified or plumbed, and they were essentially useless for storing machinery. The James Martin Baggs Log Barn was never modernized, but it has remained in use for storage through modern times.

The transverse crib barn has been well-documented as an American barn type that originated around 1815 in southwestern Virginia and upper east Tennessee. A transverse crib barn has 1) gables facing front and rear, 2) a central runway beneath the roof ridge having wagon access at both ends, 3) four to ten cribs (typically six) on either side of the runway, 4) a loft positioned above the cribs, and 5) multipurpose functions (granaries, stalls, hay storage). The James Martin Baggs Log Barn exhibits all of these features.

After 1890, most transverse crib barns were built with sawn lumber rather than logs. The James Martin Baggs Log Barn is the exception to this as it was constructed in 1909 and was constructed of logs. However, it does exhibit one of the most common alterations to the traditional Transverse Crib Barn, the addition of flanking sheds to the eave sides.

The Baggs family came to the area in the early 1900s from Rocky, Arkansas. They purchased 240 acres from the Choctaw Nation. The barn functioned as part of the family farming operation where they grew seed crops such as peanuts, corn and sorghum for the livestock. They initially grew cotton, as many farmers did at that time, but that did not last long on this operation. As such, the barn was utilized for grain storage on the south side and livestock stalls on the north side. The stalls served as the interior area for horses. While the Baggs maintained a small herd of cattle and hogs, this barn was not utilized for them.




