

#### DESCRIPTION

Loucks Grove Church is located about eleven and one-half miles northeast of Greenfield, Adair County, Iowa. It faces the west toward the sloping hill of Loucks Grove Cemetery which lies one-quarter mile away. The church can easily be seen from the rocked county road which is 43 feet from the front entrance. The one acre tract on which the church is located still has trees on three sides. Although land cultivation has edged to church property boundaries, a trace of timber remains.

The rectangular structure measures 42 feet 4 inches long by 32 feet 3 inches wide and 31 feet  $4\frac{1}{2}$  inches high and sits on a native limestone foundation. The stones are laid together to provide a support which is 22 inches wide and 33 inches tall at the highest point. The cornerstone at the southeast corner bears the date 1895 and a name which is no longer legible. The only entrance is through a vestibule on the west side. The vestibule is 16 feet 3 inches long by 6 feet 6 inches wide and 31 feet  $4\frac{1}{2}$  inches high. The 24 foot steep roof of the main structure and the vestibule fall from the 31 foot  $4\frac{1}{2}$  inch high peak to the 16 foot sidewalls. Over the original wooden shingles, two layers of composition shingles have been applied. Currently a re-roofing project is underway to remove all the shingles. New wooden shingles are being laid, entirely by hand, to the specifications of the original shingles. The exterior walls are sided with 4 inch lap siding which has been painted white. A re-painting project is now in progress. There are three Gothic style windows on both the north and south sides of the church. Over the double doors in the vestibule is an ogee arch window with ten panes. It is presently being repaired.

The interior of the church is reached through the vestibule which opens to single doors on both the north and south sides of the sanctuary. The ceiling and upper part of the interior walls of the church and vestibule are covered with the original lath and horsehair plaster. Over the plaster is a thin layer of painted finishing plaster. The 16 foot ceiling of the one-room church is rounded to meet the sidewalls and is also

rounded at the corners. Three Gothic style windows are spaced evenly in the south wall as well as three of the same in the north wall. The measurements of the windows are  $40\frac{1}{2}$  inches wide by 111 inches long. The pointed arch of each window accounts for 31 inches of the total 111 inch length. Yellow pine is the material used for the door and window frames. Bullseye corner blocks decorate the frames at the upper corners of the doors. The wood surrounding the doors and windows has been stained and varnished. The hardware on all doors is decorated with an intricate design. The lower portions of the walls are lined with 5 inch wide wainscoting which has been stained and varnished. The height of the wainscoting in the vestibule is 59 inches and drops to  $45\frac{1}{4}$  inches in the main part of the building. An exception to the  $45\frac{1}{4}$  inch height is when it rises to 52 inches directly behind the altar area.

The floors of the choir and altar area are 3 inch wide, dark, unidentified wood; the vestibule floor is  $3\frac{1}{4}$  inch unidentified wood. They are all original. The floor in the main part of the sanctuary is made of  $3\frac{1}{4}$  inch wide yellow pine. There was a fire in the church in 1960 that damaged the floor of the main part of the sanctuary; the area was replaced at that time. The vestibule floor has been painted, but the rest of the floors of the church are varnished.

In the northeast part of the church is the altar and choir section. The total area is 21 feet 6 inches long by 8 feet 6 inches wide. The choir area accounts for 10 feet 6 inches of the length on the north side. It is reached from the main floor by a  $7\frac{1}{2}$  inch riser. The other 11 feet is the altar area which is in the middle of the east wall. The altar area is reached by a  $7\frac{1}{2}$  inch riser from the choir section or by two  $7\frac{1}{2}$  inch risers from the main part of the church. The remaining 9 feet 10 inches in the overall area is on the south end. There are no interior walls other than the one which divides the sanctuary and the vestibule.

The pews (which are believed to be original) are made of pine and have been stained and varnished. There are 12 center pews which measure 8 feet 10 inches long. The 20 remaining pews are 7 feet 7 inches long and are attached to the side walls. The sidewall pews have only one end; the sides that are attached to the walls have no ends. Both sets of pews have cutout shields attached to each end on the outside. The width of all the pews is 1 foot 4 inches and have a rolled area at the top of the backrest. The armrests on the ends of the pews gently curve downward.

The building is currently in structurally good shape. The foundation needs minor mortar work. The roof is now being replaced. There is moderate water damage to the ceiling in the southeast corner but will not require extensive repair. Raccoon hunters knocked out four holes in the plastered walls, but those too will not require extensive repair.

The only outbuilding on the Loucks Grove Church property is a wooden frame three-hole out house. It is located approximately 20 feet from the northeast corner of the church. The date of construction is not known.

A hitching rail once stood at the east side of the churchyard. It was removed long ago, but plans to replace it are being considered.

Paint, varnish, a ceiling fan and various minor repairs have been made through the years. Electricity was installed August 25, 1957; a propane fueled space heater was added in January, 1961; and the vestibule ceiling has been lowered. There have been no structural changes and the church remains very much as it was on the day of completion in 1895.

STATEMENT OF SIGNIFICANCE

Loucks Grove Church is a locally significant example of a Gothic style influenced rural community frame church. It is significant for its being representative of a once common class of rural religious buildings. It is further significant within its county as the sole surviving and unchanged example of its building type.

The churches of 1895 that bore the influence of Gothic style architecture did so in varying ways and degrees. Some had gingerbread detailing under the eaves, gables, and over the front entrance, or patterns cut in the siding. Others decorated the inside doorways with carved designs in the upper door facing. Many of the churches chose a window with an ogee arch which was placed above the front entrance; often the windows were multi-paned. Some rounded the angle where the sidewalls and ceiling met, while others chose door hardware that boasted intricate designs. One or more of the preceding features were some of the usual Gothic influences; however, the most common and obvious feature was pointed arch windows. Loucks Grove incorporated carved door facings, an ogee arch ten pane window, rounded ceiling, decorative hardware, and six windows with pointed arches.

At the close of the year 1895, twenty-nine churches had been erected in Adair County, a rural county in southwest Iowa, during the preceding twenty-four years. Of those twenty-nine, nineteen were of Gothic influence. Today there are only seven of that era and style that have survived. They are: Adair Methodist (town of Adair), Highland Methodist (Prussia Township), Congregational at Hebron (Grand River Township), Greenfield Presbyterian (town of Greenfield), Bridgewater Christian (town of Bridgewater), Zion (Union Township), and Loucks Grove (Jefferson Township). Loucks Grove is the only one that has remained structurally unaltered and its physical integrity intact. The other six have been either moved or considerably altered or both. The additions of wings, entryways, and

basements were common alterations.

Early church records of Loucks Grove were destroyed by vandals in the late 1960s, and the only source of information for early years is the newspaper accounts in the <u>Stuart Locomotive</u>. In the September 27, 1895 edition an article appeared that told of interested farmers hauling lumber for the Wahtawah Church (later called Loucks Grove). The building material, both exterior and interior, was most likely ordered through a Stuart, Iowa lumberyard from a universal millwork catalog. That was an ordinary method of obtaining building material during the late 19th century. The foundation is definitely native limestone and was probably quarried from Howe, Iowa which is approximately three miles southeast of the church.

It is not entirely clear if the congregation built the church or if some professional labor was hired. The <u>Stuart Locomotive</u> reported in the January 17, 1896 edition that "the new Wahtawah Church is completed and the carpenters gone home." However, the January 31, 1896 issue of the same newspaper reported "nearly all the labor was donated by the friends." Men of the congregation could probably have constructed the building, but skilled labor was certainly needed in some capacity. For example, a trained backplasterer was surely involved with the interior walls and rounded ceiling corners. The walls and corners are still solid (except for roof leakage damage) after one hundred years.

The architect or builder of the church is not known. The cornerstone of the building bears the date 1895 as well as an illegible name above it. Perhaps it is the name of the architect or builder.

Loucks Grove was free of the \$1000.00 construction cost on the day of dedication, January 26, 1896.

Loucks Grove was a Christian Church from 1895 to 1957, and an

Independent Church from 1957 to the present. It has been intermittenly active during the years and is currently active on a yearly basis only.

Loucks Grove Church stands as the lone example of an unchanged Gothic influenced rural religious building of the late 19th century in Adair County, Iowa. Such buildings represented about two-thirds of the county's churches in 1895. It is a simple, white, frame building that has withstood the test of time and has undergone no structural changes in one hundred years. With the exception of electricity and a propane space heater, it is today as it was then in 1895. The vestibule with its decorative hardware on the doors and an ogee arch window, and the sanctuary with its pointed arch windows and rounded ceiling that exhibit the Gothic influence still show the original design and construction. It is the only church in Adair County with such a distinction.


SKETCH MAP




