Narrative Description

The Herrick Barn is located approximately one-half mile west of Gary in Deuel County, South Dakota. It was constructed in 1899 by Captain Henry H. Herrick, an early settler of Deuel County. The barn was constructed into the side of hill with a stone foundation visible on the southwest, northwest, and northeast elevations. The lower level of the barn is timber framed and the roof is a braced rafter frame. It has a stone foundation visible on the southwest, northwest, and northeast elevations. It has a gambrel roof with wood shingles and exposed rafters. The barn sits on a northeast-southwest axis. All of the other buildings that used to exist on the farm are no longer extant.

The southeast elevation features from left to right across the elevation: two fixed four-pane windows, a hinged wood door, a fixed four-pane window, a hinged wood door, a fixed four-pane window, a hinged wood door, two fixed four-pane windows, and another hinged wood door. The elevation also has wood clapboard siding.

The southwest elevation has two fixed four-pane windows in the gambrel peak. There are two large sliding doors below these windows that cover the entrance to the hayloft. The southwest elevation has wood shiplap siding.

The northwest elevation is built into the bank and has a single boarded-up window toward the center. The elevation also has wood clapboard siding.

There are two fixed four-pane windows in the gambrel peak of the northeast elevation. In the center of the elevation on the first level is a single doorway built into the stone foundation. Like the southwest elevation, the northeast elevation has wood shiplap siding. A silo used to stand near the barn off the northeast elevation but now only the foundation of the silo remains.

Narrative Statement of Significance

The Herrick Barn is located less than one-half mile west of Gary, South Dakota in Deuel County. The barn is eligible for the National Register of Historic Places under Criterion C for its distinctive architecture. The Herrick Barn is a significant example of a bank barn in South Dakota.

Bank barns are identified by construction into the side of a hill allowing for access to both floors of the barn. The ridgeline of the barn often runs parallel to the slope with the hill meeting the barn on the long side. These types of barns are often wood frame structures upon stone foundations. Because Northeast South Dakota was heavily glaciated, fieldstones were more abundant in this area and thus used more frequently in construction. The lower level of bank barns generally housed horses or cattle while the loft area of the upper level was used to store hay. While some bank barns have manmade banks built along side them, most South Dakota bank barns are constructed into the side of an existing hill. The bank barns on the Willow Grove Farm and the John Frydrych Farmstead, both listed on the National Register, are wood-frame structures constructed upon stone foundations. Both of these barns are built into the side of a hill and the ridgeline of each barn's roof runs parallel to the bank.

Historical Background

Deuel County was organized in 1878 during the early stages of the First Dakota Boom, the first great wave of migration into South Dakota that lasted roughly from 1878 to 1887. While the settlement and development of most counties in South Dakota was directly related to the construction of the railroad, the settlement of Deuel County was actually delayed slightly after the construction of the railroad. The Winona & St. Peter, an affiliate of the Chicago & North Western Railroad, constructed the first line into Deuel County through Gary in 1872. Several factors, including an economic depression, a drought, and grasshopper plagues, delayed settlement into the area following the construction of the line. By the late 1870s and early 1880s these factors had largely dissipated and settlement into Deuel County and South Dakota boomed.³ For a time, Gary was the only town on the South Dakota side of the South Dakota-Minnesota border to have railroad service so it was often referred to as the "Gate City."

Captain Henry H. Herrick was one of the first white settlers in Deuel County. Herrick was a former Mississippi River steamboat captain until he moved to Deuel County in 1871. When the Winona & St. Peter began constructing their line near Gary in 1872 they established their construction camp in Gary. Herrick took advantage of this by opening a hotel to accommodate the railroad workers. Herrick also owned a livery stable in Gary. In May 1899 Herrick tore down this livery stable and used the materials to construct the nominated barn west of town.⁴

Varying amounts of rainfall resulted in differing types of agriculture developing east of the Missouri River compared to the western part of the state. Large scale sheep and cattle ranches emerged in the dryer western region of South Dakota while smaller farms focused on crops like wheat, corn, and oats as well as dairying developed in eastern South Dakota. The types of resources constructed characterized these different types of agriculture.⁵

During the late nineteenth century and early twentieth century, farmers experimented with new barn forms and features, attempting to enclose the maximum amount of space at the lowest possible cost and attain the highest degree of efficiency. The gambrel roof was one feature commonly turned to by farmers across the Midwest to increase the amount of space in the loft area. The bank feature was another method of construction some farmers used to increase efficiency by allowing them easy access to both levels of the barn.⁶

Identifying features of a bank barn found in the Herrick Barn include construction into the side of a hill along one of the barn's long sides, wood frame construction, a stone foundation, outside access into each level, animal storage on the lower level, and hay storage in the loft on the upper level. The form of this barn is common, including a gambrel roof and a long rectangular plan. While the bank feature on the Herrick Barn is relatively unique to South Dakota, features of the Herrick Barn are similar to that of other National Register-listed bank barns in South Dakota, including its stone foundation, construction into the side of a hill, and roof line parallel to the bank. Although the overall farm site no longer retains its historic integrity, the Barn does retain sufficient integrity from its date of

Verbal Boundary Description

The barn is located in the West Half of the Southeast Quarter of Section Four, Township 115N, Range 47W, Deuel County, South Dakota. The boundary is an imaginary line that forms a rectangle encompassing the barn. It begins three feet northwest of the northwest corner of the barn and runs east to a point three feet northeast of the northeast corner and then runs south to a point three feet southeast of the southwest corner and then runs west to a point three feet to the southwest of the southwest corner and then runs north to the original starting point.

Boundary Justification

The boundary encompasses only the immediate area surrounding and including the barn as the rest of the buildings and structures that existed on the farmstead are no longer extant.
