DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Smithville Apothecary is set on a plot of land within a small townscape. Although the building has been moved from its original site, in Manahawkin New Jersey, the structure itself is essentially unchanged. The one (1) story frame building has a pitched roof, with the gable at the front and rear. The interior consists of two (2) rooms, one behind the other. The old floor boards are exposed, but the other major interior features are replacements. However, they date from the same time as the building. These features include the fixtures and the collection of apothecary equipment.

The exterior is articulated as follows. The clapboard building is surmounted by an Italianate bracketed cornice, with returns on the frontal gable. The gable itself has a pitch of roughly forty-five (45) degrees, and a patterned shingle infill. The pattern consists of broad horizontal stripes.

The front porch is set below the frontal gable, and below the main cornice of the building. The three (3) bay porch has a bracketed cornice of its own. The ground floor is entered through a central door which is flanked bay large three (3) sided bay windows. These are late 19th Century commercial shop front windows, whose upper portions are decorated with small panes of colored glass, in the Queen Anne mode (the windows are original to the building). The upper half of the entrance door is similarly decorated. The rear gable is crisscrossed with diagonal framing members forming a diamond pattern. At the center of this composition is a diamond shaped window.

The following is a description of the original surroundings of the structure now known as the Smithville Apothecary.

Manahawkin is a small strip development town, with a main street scape comprised of mid to late 19th century structures (which have undergone many physical changes) and several backstreets lined by c.1910, Bungalows. This town can in no way be described as being in a state of preservation. The small apothecary building was set among the above mentioned structures, which were residential in nature, larger in scale and not completely in character.

Although it is now in Smithville (an artificial historic community setting), the surrounding restored structures present a setting which is probably closer in feeling to the surroundings at the period of the apothecary's construction than those of its original site.

#### STATEMENT OF SIGNIFICANCE

The Smithville Apothecary is a good surviving example of a small late 19th Century commercial building. At one time, this building type characterized many small towns in South Jersey. However, because of their intown location, many have been destroyed by subsequent development. Those which survive have often been severly modernized. The Smithville Apothecary survives intact complete with the original Queen Anne shop front windows, whose authenticity is confirmed by surviving relatives of the original owners. The apothecary is also indicative of an important aspect of 19th Century life.

The apothecary is unusually well executed for such a small structure. The Queen Anne front gable, the fine stick style rear gable, the Italianate cornice, indicate that the building was designed without a sophisticated knowledge of styling. It therefore can be seen as a fine surviving piece of builder-vernacular architecture of the late 19th Century.

The apothecary is no longer on its original site. However it is a surviving example of a 19th Century type, and is not being nominated to the National Register because of associations with any specific piece of history. Therefore, the fact that the building was moved is of diminished importance.

#### HISTORY

The rememberances of family members indicate, that in the early 1890's the pharmacy was owned by Doctor John Lewis Lane, who had built it some years before. Lane was born in Tuckerton, New Jersey in 1867. He graduated from Jefferson Medical College in 1888. He lived in Tuckerton and conducted the apothecary in Manahawkin. Apparently he operated as both physician and pharmacist to the town. This was not an unusual arrangement for the period.

In 1894 the apothecary was sold to C. H. Crammer. It was then used as the Barnegat Exchange by Bell Telephone Company. Later the United States Post Office occupied the building. The apothecary was being used as the local Girl Scout Headquarters when it was purchased by the Smithville Inn and moved to its present location.
