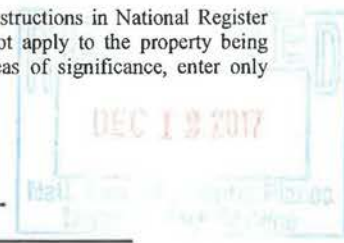



Summary Paragraph

The R.L. Leach Grocery Store is located in Dutch Mills, Arkansas, on the west end of Dutch Mills Road, near Washington County Road 418. The building is situated along what used to be the highway running through Dutch Mills. Serving as both a grocer and a post office, the one story R.L. Leach Grocery Store was the hub of Dutch Mills after the arrival of its original German settlers following the Civil War and into the 1960s. It is a plain-traditional, twentieth-century commercial building with a gable roof made of metal and a rectangular plan. Approximately twenty-five feet long and forty feet wide, the building is adorned with a black and white "R.L. Leach" sign on the parapet, as well as a Coca-Cola "Fresh Fruits & Veg." sign. Featuring barred double-hung windows, the building has novelty siding as well as a front porch with an awning supported by posts. The building is built on a continuous field stone foundation.

Narrative Description

The R.L. Leach Grocery Store is located in Dutch Mills, Arkansas, on the west end of Dutch Mills Road, near Washington County Road 418. The building is situated along what used to be

the highway running through Dutch Mills. Serving as both a grocer and a post office, the one story R.L. Leach Grocery Store was the hub of Dutch Mills after the arrival of its original German settlers following the Civil War and into the 1960s. It is a plain-traditional, twentieth-century commercial building with a gable roof made of metal and a rectangular plan. Approximately twenty-five feet long and forty feet wide, the building is adorned with a black and white "R.L. Leach" sign on the parapet, as well as a Coca-Cola "Fresh Fruits & Veg." sign. Featuring barred double-hung windows, the building has novelty siding as well as a front porch with an awning supported by posts. The building is built on a continuous field stone foundation. The building is comprised of two storefronts due to the Sycamore Filling Station being moved from across the road in 1939 and joined with the original building.

East/Front Elevation

The east side of the building has two symmetrical storefronts, each with a central door that is flanked on each side by a four-over-four barred double-hung window. The door in the southern storefront has decorative panels on the bottom half and a large window in the top half. The door on the northern storefront is a solid wood door. The two storefronts are spanned by a full front porch with a full-width shed roof supported by four wooden posts. A large stone step provides access to the porch in front of the southern storefront. At the north end of the building there is an additional boarded door frame. The parapet above the storefronts features the "R.L. Leach" sign as well as the Coca-Cola sign.

North/Side Elevation

The north side of the building has white novelty siding in fair condition. It also has no fenestration.

West/Rear Elevation

The rear of the building has a smaller one over one double-hung window with bars on it on the north side, as well as a four-over-four double-hung window the same size as the windows on the east facade. Immediately to the north of the four over four window, there is another boarded up entrance with an unpainted wooden barrier covering what used to be a back door.

South/Side Elevation

The south side of the building features another barred four-over-four double-hung window on the western end of the building. There is also an electrical wire fixed on the roof on the south side, which connects the building to the telephone wires to the west of the building.

Interior

The interior is one large space with built-in shelving along part of the west wall. Two wooden posts in the center of the building support the ceiling where the two buildings were joined together. The ceiling and walls of the original Leach building are covered with bead board paneling. In the Sycamore Filling Station part of the building, the walls and ceiling are covered with planks. Plank floors are found throughout the building.

Integrity

Overall, the Leach Store retains good integrity from its period of significance. The largest change to the building was the relocation in 1939 of the Sycamore Filling Station and its integration into the structure. However, this occurred during the period of significance and is a historic change in the building. The building retains much of its original fabric from the time of the Leaches running the store. In addition, the setting of the building still reflects the small-town atmosphere from when it operated as the store and post office. As a result, it is easily able to convey its historic significance.

The R.L. Leach Grocery Store is being nominated to the National Register of Historic Places under **Criterion A** with **local significance**. It is being nominated with a period of significance of circa 1925-1968, when it served as a grocer and post office. The building is being nominated for its role in the commerce of Dutch Mills, and its importance within the community as its post office.

Narrative Statement of Significance (Provide at least **one** paragraph for each area of significance.)

Dutch Mills was originally settled in 1850 by two German brothers, John and Karl Hermann, who established mills and stores within the settlement.¹ They organized a post office in 1853 under the name of Hermannsburg, which the settlement would be known as while the Hermanns remained there.² The Hermanns, as Unionists, were harassed by their neighbors and bushwhackers during the Civil War, until the family decided to flee to St. Louis shortly after the Battle of Prairie Grove in December of 1862.³ There are conflicting stories as to the origin of the community's name following its resettlement after the Civil War, with some stories holding that the loyalty of the Hermanns and their fellow German immigrants to the Union contributed to the renaming of the community, as "Dutch" was used as a pejorative by Southern loyalists towards Germans.⁴ Other sources maintain that the name was a result of the strange dialect of English that the community spoke as a result of their German heritage, and was simply a misnomer by those that settled Dutch Mills following the Hermanns.⁵

After the resettlement of Dutch Mills following the conclusion of the Civil War, the commerce that the Hermanns brought to the settlement with their mills and stores when it was still known as Hermannsburg had to be replaced. This movement started with the replacement of the post office for the town, when it was opened again as the Dutch Mills post office on October 10, 1871.⁶

There were a few merchants in Dutch Mills in the first couple decades of the twentieth century, with community members such as Fred Freeman and Austin Johnson working to maintain

economic activity in Dutch Mills following the emigration of the German settlers that initially bolstered the settlement's commerce.⁷ Johnson ran a general store and a flour mill in town.⁸ His general store burned in 1925, and he built another store, which he sold to Ruth and Raymond Leach before it burned ca. 1931.⁹

Will Sparks operated a grist mill from the late 1920s through the 1930s in Dutch Mills.¹⁰ The Brannons of Dutch Mills ran a store for a few years in the 1930s.¹¹ In addition to the grist mill and various general stores, there were saw mills, flour mills, and blacksmith shops within the community.¹² In the beginning of the 1930s, a canning factory was opened in town, owned and operated by Jim Gregory and Jim Pyette of nearby Cane Hill, Arkansas. In the center of all this commerce, however, was the R.L. Leach Grocery Store. As with many smaller communities, the hub of the town was the post office, and Ruth Leach, as postmistress, took advantage of the traffic to the post office by having a grocer in the same building.¹³

Built circa 1925, the north half of the R.L. Leach Grocery Store is the original building sold to the Leaches by Johnny and Mary Jane Sparks, while the southern half is from the Sycamore Filling Station, which was located across the road from the Leach store, and was owned by Will Sparks.¹⁴ The R.L. Leach Grocery Store reflected the economic strategy employed by many postmasters at the time, further solidifying the importance of the building to the community. Utilizing this economic opportunity was Ruth Leach, who was appointed postmistress in 1928, following in the footsteps of her relatives Camma C. Leach and Thomas Leach in nearby Morrow, Arkansas, in the late 19th century.¹⁵ Without many other stores in the settlement, the grocer was central to the buying of goods for the people of Dutch Mills in the twentieth century, and its service as a post office until 1968 cemented its centrality to the community. Ruth's husband Raymond was a farmer, while she ran the store and the post office, resulting in her having a revered role in the community.^{16, 17}

Ruth Leach maintained her role running the store and her position as postmistress for over three decades, until her health forced her to retire in 1967.¹⁸ She was succeeded in both duties by Ora Matlock, until the post office was closed in 1968, and the store a few years later.¹⁹

With so few centers of activity in Dutch Mills, and with no others remaining, the R. L. Leach Grocery Store's significance is amplified. Being both a primary store for the people of Dutch Mills and serving as its post office ensured that people would be spending time in there, and today it is the only remaining commercial building from Dutch Mills' past. The Leach Store is emblematic of a time and place where the post office was central to the community, as was often the case in close-knit, rural communities of the early twentieth century.

The property is now owned by Historic Cane Hill, a non-profit that has been working on restoring properties in the area. The building was restored in 2013, resulting in the removal of red sheet metal siding and restoration of the novelty siding.

Significance of Property

With so few centers of activity in Dutch Mills, and with no others remaining, the R. L. Leach Grocery Store's significance is amplified. Being both a primary store for the people of Dutch Mills and serving as its post office ensured that people would be spending time in there, and today it is the only remaining commercial building from Dutch Mills' past. The Leach Store is emblematic of a time and place where the post office was central to the community, as was often the case in close-knit, rural communities of the early twentieth century.

The Leach Store incorporating another business' building demonstrates the importance that it had in Dutch Mills' commerce. With the traffic to the store bolstered by the presence of the post office, the store needed more space and was successful enough to acquire that section of the Sycamore Filling Station. Due to its importance in the commercial history of Dutch Mills, the R. L. Leach Grocery Store is being nominated to the National Register of Historic Places under **Criterion A with local significance.**

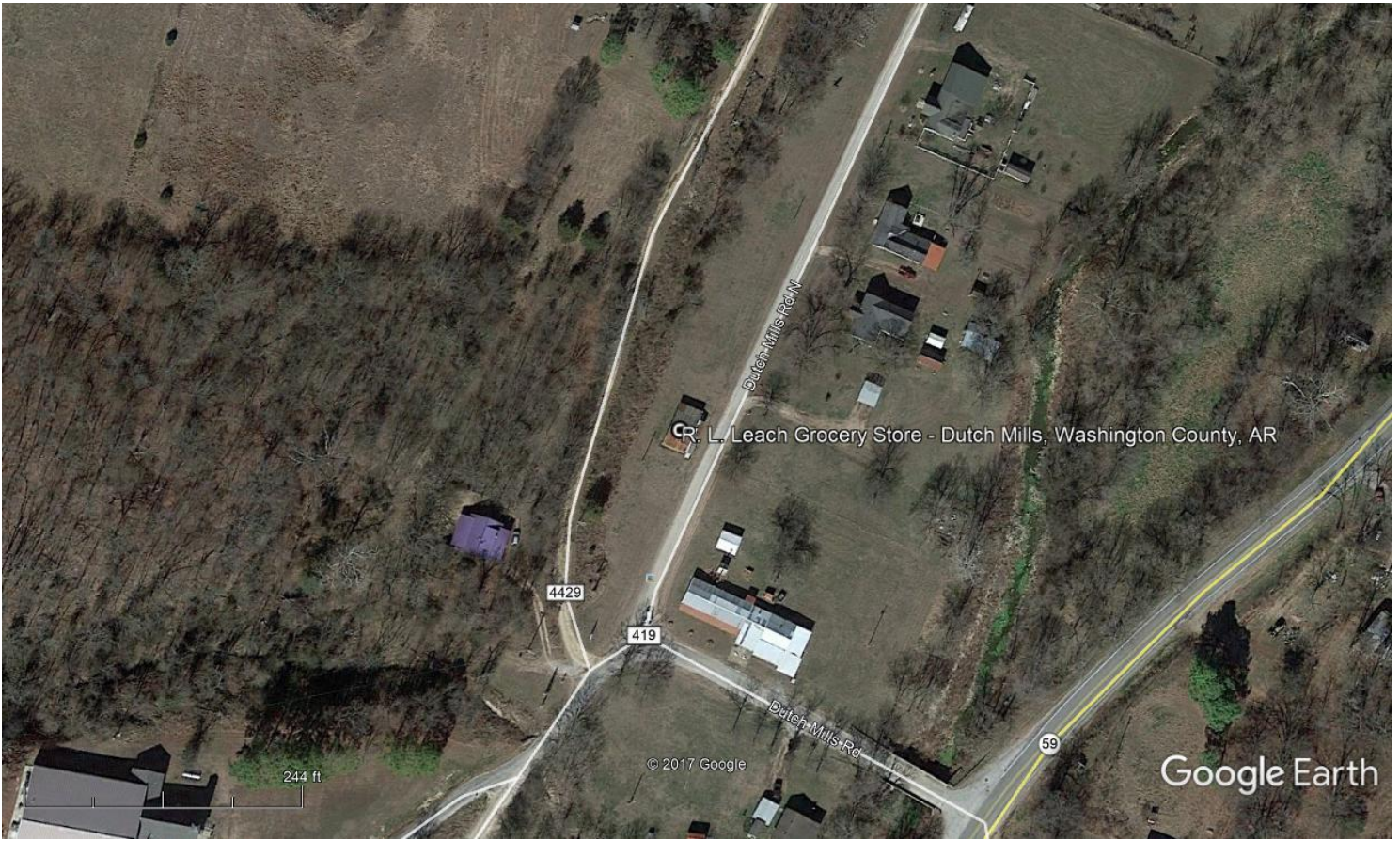

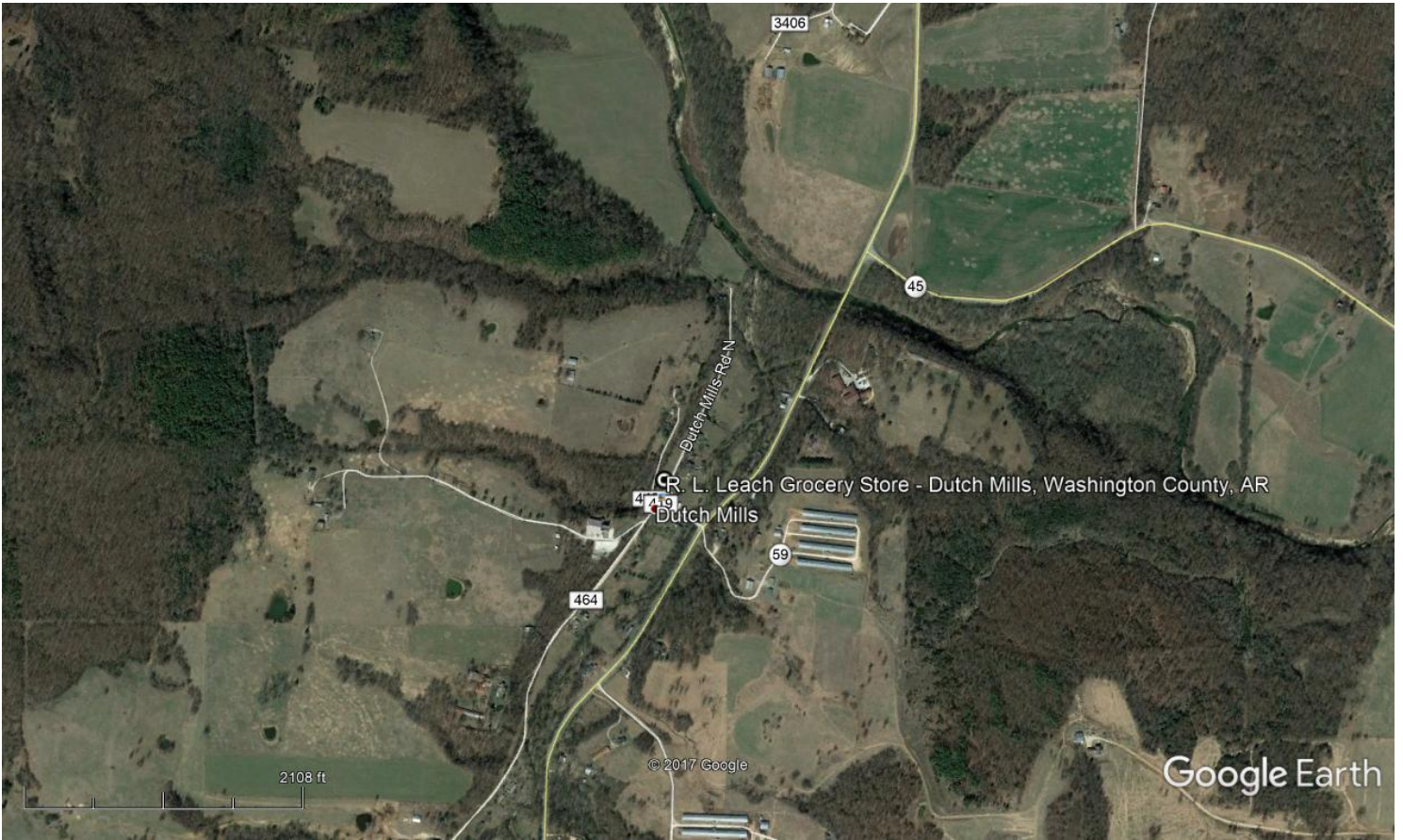

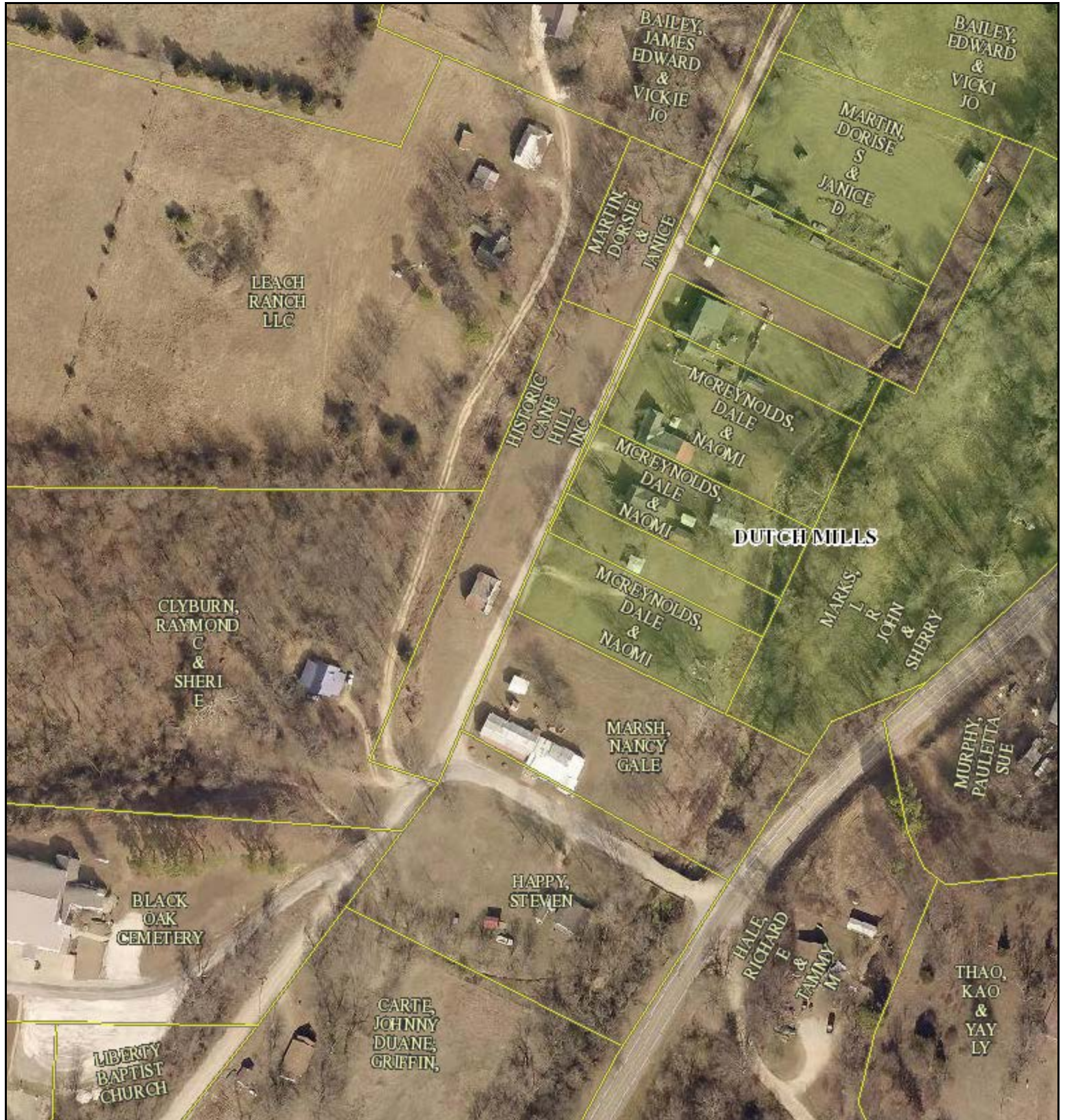
