Summary Paragraph

The Poche House was constructed circa 1875 on Grand Isle by local builders. The house, featuring wood mortise-and-tenon structure and tongue-and-groove floors, served as the community place of worship from 1893 until 1913 when the first church was constructed on the island. The house has survived over one-hundred-forty years of annual tropical storms, hurricanes, and flood events and provides testimony to the strength and appropriateness of the design and construction in its' sub-tropical environment. It retains 6/6 wood windows, French doors, porch details, the majority of its floor plan, four panel interior doors, wood floors, window and door frames, and baseboards. It has been recently rehabilitated and elevated a few feet, but overall, it would be recognizable to former owners and visitors and is eligible for listing on the National Register.

Narrative Description

The Poche House and shed contain historical significance as Louisiana Coastal Vernacular structures on Grand Isle. The house consists of the original creole-style five-room home with additions to the rear that occurred over the years as the house was occupied by various owners. The foundation supports a wood structure with side-facing gables. The house had a brick pier foundation, wood lap siding, and metal roof. The front faced towards the beach on the south with the rear towards Caminada Bay. The plan revealed the original two large front rooms with three smaller rooms across the back in a typical Creole style raised cottage plan. The front gallery (porch) has four doors with shutters spaced symmetrically across the façade. Two doors open into each of the two equal-sized front rooms, both currently bedrooms. The right *cabinet* is the bathroom accessed via a small center hall. The left *cabinet* is a walk-in closet. The center space opens into a large living area and extends to the kitchen addition. Stairs in the living room extend upwards to a sleeping loft. The additions form a U-shape around an entrance deck between the kitchen and walk-in closet. The living room has doors to both the rear porch and the entrance deck on the west side. The kitchen has a door to the rear porch. The rear (north) porch with lean-to roof faces Community Lane in the direction of Caminada Bay. The building is currently used as a guest house.

Prior to 2005, changes to the original plan included kitchen, bathroom, sleeping porch, and storage shed to the rear of the house (this is now the street facing side of the house). Front and rear porches were screened and an exterior metal stair on the east accessed a door in the gable end of the attic. Original wood clapboard siding was

covered with asbestos siding. Shutters were in place on doors and windows of the original house but doors were replaced. The house was naturally ventilated via windows and doors. Front and rear porches have had the screens removed; railings and columns were installed on the rear porch to match the front. Asbestos siding was replaced with cement siding to match the size of the wood siding elsewhere on the house. The exterior stair has been removed and replaced with an interior stair in the living room. Interior floors remain cypress tongue-andgroove boards of varying widths. Walls remain plaster with wood bases and crown moldings. Four panel interior doors vary slightly in design (some have fluting) with porcelain knobs on cast iron locksets and slidebolts. Even with the recent renovation, the house retains many original features.

The property also contains a non-contributing elevated apartment building on the northeast corner near the street. This building appeared to date to mid-twentieth century prior to Hurricane Katrina.

Historic Integrity - Poche House and Shed: The house maintains its historical integrity, on the site, location, and compass orientation. The original spaces remain despite several small additions (some within the period of significance), and structural and cosmetic changes that occurred over time. The current owner extensively renovated and remodeled the house after Hurricane Katrina but retained historical integrity of materials and finishes as possible. To prevent further flood damage but keep the historical character of the setting, the house was elevated to approximately five-and-one-half feet above grade on a new concrete grade beam and pier foundation. The higher floor level necessitated rebuilding stairs to the front porch and the addition of an entrance deck inside the U-shape between the original house and the kitchen addition, with stairs to the parking area. Damaged exterior siding was replaced with painted cement fiber lap siding. The corrugated tin roof was replaced with steel roofing.

Exterior metal stairs on the east side of the house to a door in the gable were replaced with new interior stairs to the sleeping loft. The kitchen and living room additions appear to date to the late nineteenth or early twentieth century. The kitchen was remodeled with new cabinets constructed of salvaged wood. The double-drainboard porcelain sink was cleaned and reinstalled in its earlier location. The bathroom was remodeled but plumbing fixtures (wall-mounted sinks, claw-foot tub, and toilet) were cleaned and reinstalled in their prior locations. The rear sleeping porch was converted into an open porch. Throughout both the exterior and interior of the house, finishes have been remodeled and/or replaced in-kind.

The attic has been carefully renovated into a single large bedroom with original roof structure visible in the ceiling. Central HVAC was installed with window HVAC units in some rooms not accessible for ductwork. Hardware on some exterior doors has been replaced with security deadbolts.

The wood frame storage shed was detached from the house and relocated off the northeast corner of the house next to the apartment building. The brick and wood post foundation supports a wood frame structure with sidefacing (east-west) gables. Exterior walls have clapboard siding and the roof is metal. The storage shed was relocated, cleaned, repaired, and painted after Hurricane Katrina. It retains wood siding, corrugated tin roof, and original doors and shutters, and retains its' historic character.

The apartment building was elevated to meet base flood elevation requirements [fourteen (14) feet above grade] and extensively remodeled after hurricane Katrina. It no longer retains historic value.

Constructed in 1875, the Poche House is significant on the local level under Criterion C: Architecture as a prime example of the Louisiana Coastal Vernacular style. The Poche House has direct associations with the historic context from the Mid-19th Century Development (1812-1880) as defined in the "Louisiana Coastal Vernacular: Grand Isle, 1780-1968" Multiple Property Submission. It meets the registration requirements of the Building Property Type found in Section F of the MPS. The Poche House is eligible under Criterion C as it retains many original design features, materials, and examples of mid-late19th century craftsmanship. The period of significance is 1875, the year it was built.

Narrative Statement of Significance (Provide at least one paragraph for each area of significance.)

The Poche House falls under the building property type as defined in the Louisiana Coastal Vernacular: Grand Isle, 1780-1968 multiple property submission. Built in 1875, this house falls under the discussion of a Creole type house with interconnected rooms and no true hallways. The building also has heavy braced timbers, a large attic space, and a generous gallery. The interior also has several original board and batten doors, floors, and original hardware. On Grand Isle, there are also bungalow style buildings that often also had prominent gable roofs, overhanging eaves, large gabled porches, large windows, beamed ceilings, and casual, hall-less floor plans. The Poche House has all of these features, even including some of the features of the later bungalow style buildings, including the beamed ceilings on the first and second floors.

The registration requirements for the MPS state,

"Buildings of French Creole and Bungalow styles must retain major elements of these styles as described above for eligibility under Criterion C. Status of elevation to meet Base Flood Elevation requirements should not completely disqualify buildings on Grand Isle if they meet a majority of other elements of the specified style, mainly because of the geographic location of these buildings on an island continually battered by flooding and hurricanes and because of the longstanding history of elevating buildings on Grand Isle. Applicants should show documentation of historical background relative to the community for those structures not meeting Criterion C for architecture to achieve Criterion A or B listing under community significance. Buildings should at least retain integrity of design, feeling, association, location, and setting. Materials may have changed some due to repairing storm damage, but overall, the building should retain its overall form, style, and layout."

The Poche House meets the requirements under Criterion C as it retains the major elements that have been mentioned in the building property type description. Furthermore, it retains integrity of design, feeling, association, location, and setting. The Poche House also retains integrity of materials, miraculously even after weathering all of the storms it has seen over the last 130 years. Its overall form, style, and layout it most certainly intact and thus, the building is eligible for listing on the National Register as a prime example of the Louisiana Coastal Vernacular of Grand Isle.


